Garfield County Drug and Alcohol Coalition Meeting November 9, 2016 Minutes

Jane Martin called the meeting to order at 10:10 am. Introductions were completed. Those in attendance were Jane Martin, Matt Lohman, Pamela Bookout, Jeff Tallent, Gail Box, and Meri Spurlock.

Matt Lohman made a motion to approve the minutes of the October 12th meeting as written. Gail Box seconded the motion and the motion was unanimously approved.

Matt Lohman gave a report on the results of the grant funding from the Human Services Alliance. Pam Bookout gave a report for Youth and Family Services. YFS had asked for \$4200.00 and received \$2000.00 for their proposal on the voucher program and background checks for volunteers. It was discussed that, hopefully, next year the turnaround time between receiving information about grant funding availability and the deadline for grant proposals would be much greater.

Pam Bookout, Jane Martin, and Matt Lohman spoke about the struggles of adults and adolescents in recovery. Pam mentioned that YFS now has a Peer Recovery Support Specialist (PRSS) to utilize and they excited about having a PRSS to utilize. There will be an ethics class for PRSS on December. Matt Lohman spoke about SQ781 passing and Hope Outreach is looking forward to, hopefully, receiving funding for their treatment programs.

Gail Box gave a report on Garfield County Prescription Drug update and presented the Prescription Drug Logic Model. She stated that Jaycee Randol and Jay Sharp will be in charge of the Picnic for Progress next year.

Meri Spurlock gave a report on Garfield County Underage Drinking. Required corrections and revisions for the Strategic Plan have been received. ODMHSAS has specifically requested more community input. Coalition members suggested utilizing retired teachers and retired persons from churches to work on the Social Host presentations. It was announced the next RBSS Training will be held Saturday, November 19, noon-3:00 at Callahan's. It also was announced a Target Responsibility for Alcohol Connected Emergencies (TRACE) Training for law enforcement will be held January 25-26, 2017, 8:30-5:00 at Garfield County Sheriff's Office. Letters and flyers have been sent to all law enforcement agencies throughout Garfield County and all of Region 2.

Underage Drinking in Garfield County:

- ❖ A TRACE Investigation Training is scheduled for January 25-26, 2017, 8:30-5:00. Target Responsibility for Alcohol Connected Emergencies is a protocol by which law enforcement, who are investigating an alcohol-related emergency, may trace where the alcohol was acquired, purchased, or served and determine if any crimes were committed at that location. This is presented by the ABLE Commission, is free of charge and is worth 16 CLEET hours. Registration is on the CLEET website and is limited to 100 persons.
