UPDATE ON MEDIAN WORK.

Median work is continuing to progress, mulching is steady progress.

TREE REMOVAL UPDATE.

Removed trees damaged in 2015 ice storms at Phillips Park and Crosslin Park.

STUMP GRINDING UPDATE.

Park crews are working to grind stumps in City parks.

UPDATE ON DOWNTOWN CLEANUP EFFORTS.

Crews are picking up trash, painting and cleaning curbs, and educating business owners on methods to keep downtown clean.

POOL MAINTENANCE UPDATE.

New chlorinators are being added to the pool, these will save money as well as make a safer work environment in the pump room. ADA staircase and lift are in the works for the upcoming pool season. The current lift is not in compliance with ADA requirements. Park staff has sandblasted the paint off the walls and worked to clean the remaining sand out of the pool. The pool is on track for a successful season.
