Garfield County Drug and Alcohol Coalition Meeting March 8, 2017 at 10:00 am

Jane Martin called the meeting to order at 10:11 am. Introductions were completed. Those in attendance were Tim Prince, Terri Presa, Tena Dominquez, Jennifer Hughes, Jane Martin, Pamela Bookout, Howard Morrow, Michael Buchanan, Meri Spurlock and Dena Patterson. Tena Dominquez made a motion to accept the minutes as written Pamela Bookout seconded the motion. Minutes were accepted and approved unanimously.

Introduction were completed Pamela Bookout and Jane Martin reported that the Youth and Family's Services Valentine Gala was a huge success. Pamela Bookout reported that the mentor program was going well and individuals from drug court were utilizing the YMCA passes with their families.

Dena Patterson-Kemp shared the work plan has been approved. Howard Morrow ADA is currently working on the laws surrounding prescription drug abuse and misuse. She will begin the discussion with community members about a Naloxone/Narcan. She will make contact with Tim Starkey with Great Salt Plains first. She also announced that Mayor Shewey has approved the proclamation for Austin Box "12" Prescription Drug Abuse and Misuse Awareness Day.

Meri Spurlock reported that Alcohol Compliance Checks were conducted January 20 with 80% compliance!! A TRACE Investigation Training was held January 25-26, 2017, 8:30-5:00. Target Responsibility for Alcohol Connected Emergencies is a protocol by which law enforcement, who are investigating an alcohol-related emergency, may trace where the alcohol was acquired, purchased, or served and determine if any crimes were committed at that location. This was presented by the ABLE Commission. The next Retail Beverage Services and Sales Training will be Sunday, February 12, 3:30-6:30, Café Garcia 324 S. Grand. She distributed and explained the alcohol survey which is utilized to gather data surrounding consumption and perceptions – including perceptions on underage military use of alcohol and prosecution of Social Host Law. She distributed the results for underage drinking according to the 2016 Oklahoma Prevention Needs Assessment Survey. The 2M2L Training is scheduled for March 15 which will be a practicum on party dispersal. Howard Morrow, ADA reported that there must be a citation at the time of the party and a picture attached to the report otherwise it ends up with fourth amendment issues.

Treatment Report – No new updates

The meeting was adjourned at 10:50 am. Tim Prince made a motion to adjourn the meeting and Tena Dominquez second the motion. Motion passed unanimously.
