**BACKGROUND:**

State law and the City's Charter require the City Manager to prepare and submit the annual budget not less than 30 days before the beginning of the new fiscal year. The budget process began in February has resulted in the Fiscal Year 2017-2018 proposed budget draft presented to the Board of Commissioners on April 21, 2017. Special meetings to further discuss the proposed budget are scheduled for May 2, 4 and 9, 2017. A public hearing, required by State law, will be conducted at a special meeting on May 4, 2017 to formally solicit public input. The public hearing will be advertised five days before the hearing in accordance with State law. Feedback from these meetings will be included in the final revision that will be presented to the Commission at a later date.
