Garfield County Drug and Alcohol Coalition Meeting April 12, 2017 at 10:00 am

Jane Martin called the meeting to order at 10:09 am. Introductions were completed. Those in attendance were Meri Spurlock, Jane Martin, Tim Prince, Gail Box, Terri Presa, Tena Dominquez and Sandy Howard. Gail Box made a motion to accept the minutes as written Tena Dominquez seconded the motion. Minutes were accepted and approved unanimously.

There were no new updates on treatment. Dena Kemp shared that the work plan includes a law and policy assessment that is currently being reviewed. She shared the vision about the Narcan Ride and discussion was held. She also reported that PreventionWorkz would be hiring a part-time staff person to assist with the Rx Grant recently received. This individual would be working part-time for ten hours per week. She encouraged everyone to come to the City Council Meeting on May 16th were Craig and Gail Box will be given a proclamation declaring it "Austin Box "12" Prescription Drug Abuse and Misuse Awareness Day." Sandy Howard with Our Daily Bread offered to donate the 500 hotdogs needed for the Picnic for Progress.

Meri Spurlock emphasized the importance of getting the alcohol surveys completed. Please pass the word on about the surveys so more can be gathered. She reported that a 2M2L Training was completed on March 24, 2017 with 17 in attendance and 10 volunteers for the mock party dispersal. She was excited that the Dean of Students from Northern Oklahoma College attended and brought Campus Security with him including someone from Tonkawa. Meri reported that the Garfield County Underage Drinking work plan has been provisionally approved. She updated everyone on the current bills and reported that the bill allowing children twelve and under into a liquor stored died. The coalition held discussion surrounding the bills.

Jane Martin shared about a new Netflix series called "13 Reasons Why" she said it was very dark and sad. She said that the series showed how bullying really can affect others.

Terri Presa made a motion to adjourn the meeting and Gail Box second the motion. Motion passed unanimously and meeting adjourned at 11:00 am.
