ORDINANCE NO. 2017-\_\_\_\_\_

AN ORDINANCE AMENDING THE ENID MUNICIPAL CODE, 2014, TITLE 1, ENTITLED "ADMINISTRATION," CHAPTER 4, ENTITLED "GENERAL PENALTY," SECTION 1-4-1, ENTITLED "PENALTIES FOR VIOLATIONS," TO INCREASE THE PENALTY FOR REPEAT OFFENSES; PROVIDING FOR REPEALER, SAVINGS CLAUSE, SEVERABILITY AND CODIFICATION.

ORDINANCE

BE IT ORDAINED BY THE MAYOR AND BOARD OF COMMISSIONERS OF THE CITY OF ENID, OKLAHOMA:

Section I: That Title 1, Chapter 4, Section 1-4-1 of the Enid Municipal Code, 2014, is hereby amended to read as follows:

**1-4-1: PENALTIES FOR VIOLATIONS:**

- A. Penalties Imposed: Whenever in this code or in any other ordinance of the ~~city~~City, or in any rule, regulation or order promulgated by any officer or agency of the ~~city~~City under authority duly vested in him, or it, any act is prohibited or is made or declared to be unlawful or an offense or a misdemeanor, or the doing of an act is required, or the failure to do any act is declared to be unlawful, or an offense or a misdemeanor, the violation of any such provisions of this code or any other ordinance of the ~~city~~City or such rule, regulation or order shall be punished as indicated in the applicable code section.
- B. Absence ~~Of~~of Penalty: In the absence of any penalty being specified in an applicable code section, an offense shall be punishable by a fine of two hundred dollars (\$200.00), plus costs.
- C. Increased Penalty for Repeat Offenses: In the absence of a specific provision increasing a penalty for repeat offenses, penalties for repeat offenses shall be as follows:
- Second occurrence: The maximum fine shall be increased by one hundred dollars (\$100.00)
- Third occurrence: The maximum fine shall be increased by two hundred dollars (\$200.00)
- Fourth occurrence: The maximum fine shall be increased by three hundred dollars (\$300.00)
- ~~E~~D. Limitation; Compliance ~~With~~with State Statute: The provisions of subsections A, ~~and~~B and C of this section notwithstanding, no penalty shall be greater than that established by Oklahoma statute for the same offense.

~~DE~~. Separate Offense ~~For~~for Each Day: Except as otherwise provided, every day any violation of this code or any other ordinance of the ~~city~~City or any rule, regulation or order shall continue, shall constitute a separate offense. (Ord. 2015-02, 1-6-2015)

Section II: Repealer. All ordinances or parts thereof, which are inconsistent with this ordinance, are hereby repealed.

Section III: Savings Clause. Nothing in this ordinance hereby adopted shall be construed to affect any suit or proceedings now pending in any court, or any rights acquired or liability incurred, nor any cause or causes of action accrued or existing, under any act or ordinance repealed hereby. Nor shall any right or remedy of any character be lost, impaired or affected by this ordinance.

Section IV: Severability. If any one or more of the sections, sentences, clauses or parts of this ordinance, chapter or section shall, for any reason, be held invalid, the invalidity of such section, clause or part shall not affect or prejudice in any way the applicability and validity of any other provision of this ordinance. It is hereby declared to be the intention of the City Commission of the City of Enid that this section of the Enid Municipal Code would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part not been included.

Section V: Codification. This ordinance shall be codified as Title 1, Chapter 4, Section 1-4-1, of the Enid Municipal Code, 2014.
