## EXTENSION OF CLOSING DATE IN MASTER DEVELOPMENT AGREEMENT

This Agreement between the Enid Economic Development Authority, an Oklahoma Public Trust, ("EEDA") and Enid BWP, LLC, an Oklahoma limited liability company, ("Developer") amends the Master Development Agreement between the parties dated February 23, 2017 (the "Master Development Agreement"). Capitalized terms used but not defined herein shall have the meanings ascribed thereto in the Master Development Agreement.

# **RECITALS**

WHEREAS, the Master Development Agreement provides a closing date of August 31, 2017 at which time the transfer of the Development Property is to occur; and

WHEREAS, the Master Development Agreement provides condition precedents for both the EEDA and the Developer to complete prior to said transfer pursuant to §3.03 and §3.02 respectively; and

WHEREAS, the conditions precedent will not be satisfied prior to August 31, 2017 and the parties desire to extend such date, and

NOW, THEREFORE, in consideration of the mutual promises and agreements herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto agree as follows:

The Closing Date of August 31, 2017, found in the Master Development Agreement in Sections 3.02, 3.03 and 11.02 is hereby extended sixty days to October 30, 2017.

# A RESOLUTION AUTHORIZING THE FILING OF AN APPLICATION WITH THE OKLAHOMA DEPARTMENT OF TRANSPORTATION (ODOT), TRANSIT PROGRAMS DIVISION, FOR PUBLIC TRANSIT REVOLVING FUNDS.

WHEREAS, the Oklahoma Department of Transportation, (hereinafter referred to as the "Department", is providing funds under the ODOT Public Transit Revolving Fund grant; and,

WHEREAS, the Enid Public Transportation Authority, (hereinafter referred to as "EPTA"), seeks to receive financial assistance pursuant to the ODOT Public Transit Revolving Fund; and,

WHEREAS, after the EPTA makes application under the grant, the EPTA will be required to execute a contract to receive the grant funds pursuant to the ODOT Public Transit Revolving Fund; and,

WHEREAS, the contract will impose certain obligations upon EPTA in accordance with the provisions of Chapter of 53 of Title 49 of the United States Code;

NOW, THEREFORE, BE IT RESOLVED BY THE ENID PUBLIC TRANSPORTATION AUTHORITY:

- 1. Mary Beth Williams, General Manager for the Enid Public Transportation Authority, is authorized to:
  - a. Submit a grant application for financial assistance for the purpose of operating a rural transit system in the City of Enid, Oklahoma from the Department along with any and all documentation necessary to include:
    - -the description of the transportation services provided;
    - a proposed budget justification;
    - the EPTA independent audit report;
    - Certification of Vehicle Revenue Miles Claimed;
    - EPTA's Certification of Services to the Elderly and Disabled;
    - EPTA's Certification of Availability to the General Public;
    - EPTA's Worker's Compensation Insurance Certificate; and
    - EPTA's Liability Insurance Certification.
  - b. Furnish such additional information as the Department or the Federal Transit Administration may require in connection with the application.
