The Mayor and Board of Commissioners of the City of Enid, County of Garfield, State of

Mayor Shewey called the meeting to order with the following members present and absent:

Staff present were City Manager Jerald Gilbert, City Attorney Carol Lahman, City Clerk Alissa

Mintz, Planning Assistant Karla Ruther, Director of Marketing and Public Relations Steve Kime, and

Human Resources Director Sonya Key.

Discussion was held on the Fiscal Year 2018-2019 City of Enid Budget.

Opening comments were made by Chief Financial Officer Erin Crawford. She began with an overview of the summary of revenues and expenditures for the year. The totals for the year were \$154, 964,649 in budgeted revenue and budgeted expenses of \$156,460,194. That was an increase in revenues of \$11.4 million for the year, and an increase in expenditures of \$10.3 million for the year, over last year's budget.

The focuses this year were the same focuses as last year. For Infrastructure Improvements, the Capital Improvement Program is in those funds with a \$12.8 million budget for this year, and includes \$4.2 million for street improvements; \$1.5 million is for local street improvements; \$1 million for the Cleveland project to do some pre-work on utilities and right-of-way acquisition to continue the roadway expansion project from the railroad tracks to Willow Road; \$300,000 for the ADM Truck Lane, which was part of the ADM TIF; \$400,000 for an airport entryway road that goes along with the upgrades associated with the new terminal; and \$1 million to do mill and overlay on Broadway and to continue that from Washington to Van Buren.

The \$10.7 million under the Kaw Lake Program included in this budget was all debt related and included \$8.7 million that came from sales tax, and \$2 million that was from utility revenues that were set aside for the project.

For Public Safety Support, this was the highest funding year for transfers to operate for Police and Fire. The amount of funding going to these departments was increased by \$1.57 million from the current year.

Ms. Crawford provided a break-down of the budget without the transfers taken in. This took the \$154 million in revenue down to \$95 million, when all of the transfers were removed. Of the \$156 million in expenses, there were \$97 million in expenditures when all of the transfers were removed. Personnel Services was almost \$33 million, which was 34% of the overall budget. The Operations fund was a little over \$30 million, at approximately 31%. Capital Outlay was approximately 15%, or \$14.6

million. The Debt Services fund was a little over \$19 million, or 20% of the budget. Overall, a budget deficit of almost \$1.5 million was reflected.

She presented all of the funds that did not have a balanced budget for the year, and explained that there were specific reasons that many of them did not present a balanced budget.

The Special Projects Fund, which was the budget to bring in special revenue that had to do with Federal and State seizure monies for the Police Department. This fund was always budgeted to spend more, in case there was a need to purchase equipment for their special projects.

As far as the Health Fund, no changes were being proposed to the health plan, but with the projected increases in trends in health funding everywhere; it would lead to an \$112,000 deficit. It was noted that there was a fund balance to draw down from.

The Airport Fund specifically had a surplus in the fund, due to the Oklahoma Strategic Military Planning Commission (OSMPC) grant dedicated to the terminal construction project.

A deficit of \$1.367 million reflected in the Enid Economic Development Authority (EEDA) fund due to a timing issue. A final disbursement from Garfield County was expected for the Advance Foods TIF in June 2018. This would roll into the fund balance, and a final bond payment would be due out on July 1. The funds would be there prior to the end of year to support the deficit.

The Vance Development Authority (VDA) fund had a small deficit, but it was the same budget that was presented each year. A lot of the surplus was due to the scholarship program not being fully utilized. It was noted that this fund had a balance to draw down.

Stormwater reflected a big surplus budget for the year, as opposed to last year's deficit budget.

Almost a million dollars worth of work had been awarded in the prior week.

The funds in the Capital Project Escrow Fund were the money that had been paid by developers for basins, based on what projects were being done in Stormwater. These funds would go towards those projects.

Police, 911, and Fire continued operating deficits, but significant improvement had been made in those funds. There has been re-organization across the state to determine how 911 centers were funded. Staff would continue to look at that fund to determine a solution as to what it needed to be long-term. Last year, the Police budget deficit was \$1.1 million, but significant improvement had been made, and it was anticipated that Police would finish the year with a budget surplus for Fiscal Year 2019, based on trends of what was actually spent compared to the budget in the last few years. Fire had a large deficit because the purchase of a pumper truck was included in the budget, which accounted for approximately \$700,000. It would not be a continuing issue to see that amount of capital spent for Fire every year, it would only be as needed.

Looking at the numbers for revenues in all of these categories and comparing them to the current year's budget, a variance of \$5.5 million increase in revenues without transfers was reflected. Personnel Services was up \$663,000; Operations was up \$1.8 million; Capital Outlay was down \$52,000; Debt Services was up \$2 million, which was an improvement. Personnel Services decreased 1% compared to last year, Operations stayed the same, Capital Outlay decreased 1%, and Debt Services increased 2%. That trend would continue in preparation of having the level of payments it would take to finance Kaw Lake.

Ms. Crawford presented a revenue comparison and the variables that caused increases in that revenue. \$4.9 million was coming from the Municipal Authority. Water revenue had been increased by \$4.75 million, and was conservatively budgeted at \$13.7 million in this year's budget, but would probably come in closer to \$19 million by year's end. The projections were based on the new rate increases, which went from \$5.82 to \$7.01 per thousand gallons. Next January the rates were set to go up to \$7.55 per thousand gallons, and a 2% increase after that.

In response to Commissioner Ezzell's inquiry regarding water sales to Koch Nitrogen, it was noted that 400,000 gallons per day were budgeted in this year. In the upcoming budget, 1.5 million gallons per day were budgeted.

Other slight increases in EMA included \$50,000 for Stormwater, was matching what had come in the last few years, but had seen a trend up; for trash services, there had been a slight increase of about 5% in dumpster rates; and a slight increase in interest earned.

For EEDA, this was all TIF related. We were receiving the last funds from the Advance Foods TIF this year, but added the TP & L TIF for the first time. That netted to approximately a \$1 million increase. \$2 million was put into TP & L, so that the sufficient appropriations were available at the end of the year for whatever was received.

In the Capital Improvement Fund, the revenue was lower. This was almost all related to the 66th Street project with the Oklahoma Department of Transportation (ODOT). There was a \$1.2 million match from ODOT for that project that we would not receive again in Fiscal Year 2019.

The next line, for Capital Recovery was only \$310,000. This had not previously been budgeted. This was prompted by ordinance and was a pass-through item. If funds were received to pass through for an expense, this allowed that to happen and to show revenue and expense, without having to bring the item back for appropriation.

The remaining funds made up \$500,000, and would be discussed during the budget discussion of each fund.

Under the expense pieces of the budget, personnel costs overall were up \$663,000, or about a 2% increase from what it was in the current year. Staffing levels were projected to have a ten person increase, with only three of those being full-time and the other seven being part-time and seasonal. The three full-time positions that were added included the Assistant City Manager position, a Safety Coordinator position, and an Administrative Assistant position for the Public Utilities Division, which was a position that was previously shared with Public Works. The part-time seasonal included gym attendants, ball field maintenance, and lifeguards for the Parks and Recreation Department; added a part-

time accountant; Enid Television Network (ETN) eliminated a part-time Production Assistant position; and two part-time drivers were added to the Enid Public Transit (EPTA).

Under operations, there was a \$1.8 million increase. EMA had a decrease of almost \$900,000, which was attributable to the school bond sales tax. We did not have to pay out the excess collected to the school districts, so that reduced the expenditure on that line. EEDA had two things that drove the operation costs up and those were payout of the TP & L TIF and the parking lot guarantee with the developer of the downtown hotel, which would have to be paid out upon completion of that project.

The Capital Recovery Expenditures and all other remaining funds made up the operations balance.

Ms. Crawford spoke briefly regarding Capital Outlay. These were all of the capital improvement funds. The funding for each of these was determined by priority. The remaining funds of \$388,853 were driven by two main things – the pumper truck for the Fire Department and some decrease in Public Works equipment that we were able to fund and purchase in the current year for some needed street equipment to utilize this summer.

The last area was Debt Service. There was an increase in EMA of \$2 million, which was the place holder for the Kaw Lake project, as some of the additional revenues needed to be pulled as revenues were increased, in order to set those aside for future Kaw payments.

The increase in EEDA was \$7,300, and was based on interest on the three outstanding notes.

Ms. Crawford presented an illustration of the current fiscal year's General Fund budget in comparison to the next fiscal year's budget. The current budget revenue projections were coming in at only a \$5,000 difference from projections budgeted.

Included in the Fiscal Year 2019 budget was a 1.3% increase in sales tax, which was based on both longer- and shorter-term trends.

There was a slight increase in franchise fees and in the interest under miscellaneous. There was a decrease in grant funding, which was due to the removal of the Joint Land Use Study (JLUS) grant and the receipt of a Library state aid grant. These resulted in a \$300,000 increase in General Fund for the year.

It was noted that there were some grants pending.

Expenses for General Fund included Personnel, Operations, and Capital Outlay. There was an increase of \$299,000 for Personnel, a 3% increase; Operations had a slight decrease of \$23,000, mainly due to the removal of the JLUS grant and an increase that was mostly due to an increase in software fees; Capital Outlay had an increase of \$1.527 million.

Operations and Personnel combined resulted in a \$275,000 variance. General Fund Transfers were up \$1.566 million. Almost all of that was for Police and Fire to ensure that they could have what was needed for operations. Sales Tax Transfers were up \$193,000, which accounted for the 1.33% increase that was budgeted for in revenue. Capital Replacement reflected a decrease of \$233,000, at least one larger piece of equipment that was needed would be brought before commissioners for consideration for purchase in June. A couple of smaller piece of equipment that were budgeted for next year were able to be purchased under the current year and were then able to be removed from expenses in the upcoming budget.

A list of all of the departments in the General Fund was presented, along with corresponding expenses.

Discussion was held regarding local program and public arts funding, flow monitoring for Skeleton Creek, the ETN budget, the benefits of the contract with Curt Roggow, and the Oklahoma Municipal League (OML) membership.

General Fund Transfers included proposed transfers out versus last year's budget, at a variance of \$1.566 million. The majority of that was in Police and Fire, at a \$1.7 million increase. There was also an increase to Golf of \$142,000. There were decreases in the Transit, Juvenile Services (a cost which was rolled into the Police budget), and EEDA – based on contract incentives paid out in the recent fiscal year that would not be paid out in the next fiscal year.

The only change in Sales Tax Transfers was moving the quarter of a cent that was going to the school districts into the Kaw Program in the upcoming year, so there was a complete reduction of sales tax for the school system of \$2 million. This resulted in an overall increase of \$193,000, or 1% increase in revenue.

It was noted that sales tax had come in at a little over 1% of what had been budgeted.

Ms. Crawford spoke regarding equipment, which was budgeted at \$667,000 for Fiscal Year 2019. There were email upgrades, which had been delayed to the replacement of servers, but still needed to be addressed; time clock upgrades needed due to the age of the time clocks and technology updates; storm sirens, which had not been budgeted for in several years; air tanks and line upgrades for the Fleet Department because the ones currently being utilized are approximately 20 years old and have lost functionality; traffic battery backups for intersections, to ensure that they are flashing when an outage occurs; replacement of three trucks that all have over 100,000 miles, for Engineering and Public Works; a 12 foot mower for the Parks Department; a Gradall excavator for the Public Works Division, to provide for better, more efficient mobility when cleaning ditches; the next phase of Wayfinding Signage; and repairs to the retaining wall by the Library. The total for equipment expenses for General Fund was \$667,490.00.

The Health Fund was an internal service fund for the City. All departments with the City paid money into the fund, which collected premiums as revenue to pay claims on the health insurance offered

to employees. The employees' portion paid was also collected as revenue. Fiscal Year 2018 did have a balanced budget. For Fiscal Year 2019, revenue was coming in a little lower, which was based on positions and turnover. The current year had been a high expense year with expenses of \$1.1 million in claims in the last two months, as opposed to a typical two-month expense of around \$600,000-700,000. It was noted that there was a fund balance of over \$1 million to draw down from. The upcoming year was budgeted to keep the same plan, and this would reflect a deficit of approximately \$110,000. The numbers in the budget were based on health trends and what Holmes Murphy, health consultants for the City, were telling staff.

Three funds were presented under Non-Major Fund Budgets.

The first fund Ms. Crawford addressed regarded the Community Development Block Grant (CDBG). She noted that at this point, the amount of HUD funding allocation was unknown, but \$400,000 was estimated for the next year. It was noted that there was only one more HUD loan payment to be paid after the Fiscal Year 2019 budget. There was a payment of \$172,000 due August of 2018, and the final payment of \$182,000 would be made in August 2019.

CDBG Administrator Stephanie Carr noted that unofficially the City would be receiving an increase for a total of \$418,584, which was up from last year.

Discussion was held regarding the Community Development Block Grant fund budget, hearings, and staffing.

The next fund covered was the Sinking Fund, which by ordinance, allowed the City to levy judgments in excess of \$20,000 with Garfield County through an estimate of needs process. When those were approved by the commission, they were filed with the county, the individuals were paid out, a claim filed, and then were added to ad valorem taxes so that the City could recover money through the process. No new levies had recently been passed.

Lastly, Ms. Crawford spoke regarding the Vance Development Authority (VDA) Budget. She noted that for Fiscal Year 2017-2018 and Fiscal Year 2018-2019, the same budget was proposed. Mr. Mike Cooper, Vance Development Consultant, turned in the same request for expenditures. His contract had recently been renewed through June 2022.

The only changes were due to changes in the scholarship program structure, and it was anticipated that the program would be utilized more due to changes.

Brief discussion was held regarding the scholarship program, and the possibility of funding a member of the VDA to attend the annual Chamber of Commerce trip to Washington, D.C.

There being no further comment, discussion on the Vance Development Authority Budget concluded.

A proposed budget was presented for Golf.

In the adjusted budget, there was a slight deficit budget due to the rollover encumbrance for the restrooms that were redone. The budget was coming in lower in revenue and expenses. A balanced budget was proposed for Fiscal Year 2019.

An illustration was provided to show golf revenue and the transfer from General Fund. The numbers were put together based on recommendations from an outside consultant, and changes recommended for implementation in an attempt to improve sales at Meadowlake. At the time of the proposed budget for Fiscal Year 2018, the City had only been operating all areas of the facility for three months, there were now fifteen months worth of data. Based on the reality of what had been experienced since implementing the recommended changes, numbers were determined that were more in line with the 15 months of data and what staff felt could be achieved. Golf had no fund balance to draw down from, so the difference had to be made up by a transfer from General Fund, in order to present a balanced budget, because a deficit budget could not be reflected.

Michael League, Superintendant and Director of Golf Operations, spoke regarding the Golf Budget. For the current year's budget, based on consultant projections, revenue was decreased, as well as cost of goods sold. It was adjusted for the next fiscal year. For the upcoming budget, there was only one piece of capital equipment requested, which was needed to replace a twenty-year-old unit that was no

longer functional; and a significant increase in personnel costs was due to the payout for two anticipated

retirements.

It was noted that there had been an increase in membership.

He provided some examples of changes that were expected to improve operations and revenues at the golf course, in order to hit the numbers and reduce the fund balance transfer needed.

A brief discussion regarding replacement of the maintenance building, possible fundraising efforts for golf, and staffing was held.

It was noted that the transfer moved from \$157,000 up to \$300,000, because Golf had to be fully funded in order to operate. This was an increase of \$142,000 from the City to the golf course to meet budget for the year.

Mayor Shewey recessed the meeting to convene as the Enid Municipal Authority.

CFO Erin Crawford presented a brief overview of the Fiscal Year 2018-2019 Enid Municipal Authority (EMA) Financial Plan. Overall she expected total revenues of almost \$54 million. She

reviewed the large categories of revenues and expenses, the projected corresponding dollar amounts for each category, and percentage of the budget represented as follows:

Capital Outlay	\$1,193,000	2%
Debt Services	\$17,018,859	33%

A balanced budget was reflected for this fund for Fiscal Year 2019.

In the comparison to the current year, she stated that there was an increase in revenues of \$5.1 million, Personnel Services increased \$110,000, Operations increased \$3 million, Capital Outlay decreased \$34,000.00, and Debt Services increased by \$2 million.

She further explained that of the proposed EMA revenues this year, 67% of revenue came from Utility Services for water, stormwater, trash services, sewer, and miscellaneous utilities; 33% came from sales tax. Last year, sales tax accounted for 36% and utilities revenues accounted for 64%.

While presenting the Revenue Comparison, it was noted that increase of \$4.750 million was projected in water sales, an increase of \$50,000 in stormwater, an increase of \$100,000 in trash services due to dumpster rate increases, a \$40,000 increase under miscellaneous due to interest, and sales tax increased by \$193,000. This reflected a total EMA revenue increase of \$5.133 million.

Under EMA Expenses, Personnel costs increased \$110,000, Operations decreased \$897,000, Transfers increased \$3.93 million, Capital Outlay decreased \$34,000, and Debt Payments increased \$2.015 million. This resulted in the same \$5.133 increase reflected as an increase in revenue.

A list of departmental expenses was presented for EMA and included an increase of \$4.997 million for EMA Operations, which was made up of a school bond expense that was removed and accounted for about \$1 million of that, transfers out increased by \$3.9 million, and debt payments increased by \$2 million; other than that, the only large increase in the EMA Departmental Expenses was

for Solid Waste Services for a line added that added \$173,000 to lease three additional trash trucks, which was the best option in order to keep trucks serviced and running, but other areas had been cut, in order to try to offset that expense; and Public Utilities Management increased due to the addition of the Administrative Assistant position.

A list of EMA transfers was then presented. There was an increase in General Fund of \$1.5 million, which flowed through to Police and Fire; Street and Alley increased \$225,000, which was additional funding to provide for asphalt, crack seal, and additional maintenance materials needed by the Streets Department, in order to maintain roads; EEDA decreased \$170,505, due to payouts on incentives and contracts; Capital Improvement, Street Improvement, Sanitary Sewer, Stormwater, and Water Capital Improvement were all based on what projects got funded and were prioritized during the budget process. The Central National Bank Center was the same transfer as the current year. These all made up the \$3.939 million increase in EMA transfers out.

EMA equipment was just under \$1.2 million, with the majority of the requests coming from Landfill and Solid Waste for equipment such as a litter trailer, mule, rear load trash truck, roll-off truck, and the semi-truck, that were needed for that department. There were three trucks in the budget for Utility Maintenance and Water Production, for the replacement of older, heavily used trucks. A mower was needed to mow rights-of-ways. Additionally, there was an excavator listed in the budget to replace an excavator that was more than ten years old, and used on a daily basis. The roll-off truck and semi-truck were repeat items from the current budget that had been delayed in order to purchase a vac truck, which was a bigger priority at the time.

The final area of EMA was Debt Payments. The 1998A OWRB note would pay off in August 2018, which was why there was a decrease of \$48,133 reflected; the other slight increases in 2000A and 2002A OWRB notes were due to interest; and the 2003 School Note would pay off in June 2018. The payments stayed the same for the AMI System and Water Treatment Plant. The 2012 Line of Credit was for the Event Center, and these payments were set up to be escalating principal payments set up to

increase over time. That note would pay off in July 2020. The 2016 note had been taken out in December 2016 for Phase II of the Kaw Project. The reserve was found under Future Kaw Payments, and contained the Kaw Sales Tax, as well as the \$2 million set aside in utility revenue specifically for the Kaw Project.

Discussion was held regarding the contract with Stover Group to operate the Wastewater Treatment Facility and what the contract paid for, such as operations and minor maintenance.

Having no further comment, discussion regarding EMA concluded.

Chairman Shewey adjourned the meeting to convene as the Enid Public Transportation Authority.

CFO Erin Crawford spoke regarding the Fiscal Year 2018-2019 Enid Public Transportation Authority Financial Plan, which showed a deficit under the adjusted budget for this year, which was due to the match part of some buses that had been encumbered in the previous year and had rolled over. Revenues were projected to come in \$53,000 under where they were currently at in the budget. This had to do with timing and when grant funds were expended versus when payment was reimbursed. The grant funding would be received, but it might not be in the current fiscal year, which was why the number appeared to be so low.

In the projection, expenses were expected to come in almost \$70,000 under where they were budgeted for the year.

EPTA had added two new driver positions because they had been so busy, and they had had a lot of record days for ridership.

The actual budget proposed for next year reflected a decrease in both revenue and expense, but a balanced budget was presented for the Transit.

It was noted that the current year budgeted for \$55,000 in passenger fare, but based on the current trends, would likely come in at \$71,000 in passenger fare for the year. A \$10,000 increase in passenger fare was predicted for the next fiscal year.

Although projections for the budget appeared to be coming in low, a slight increase in grant revenue was expected to come in for the next fiscal year. The transfer from the General Fund was expected to decrease for the next fiscal year.

An overview of expenses was presented and discussed.

EPTA General Manager Mary Williams addressed commissioners explaining that in the current fiscal year, the EPTA had received a \$10,000 grant from the Long Term Care Authority for the Older Americans Act, to provide free rides for individuals age 60 and older. Two months prior, EPTA was asked if they could utilize \$5,000 for those who were 60 and over, and use that funding by June 30th, and they agreed that they could. That allowed all residents 60 years of age and over to ride the Transit for free. This provided for an increased number of riders. In order to increase revenue and number of riders, Ms. Williams provided examples of additional services provided, such as offering transportation for wedding parties, hotel patrons, and event center patrons.

Brief discussion was held regarding the potential sourcing of CNG, and grant funding received from ODOT.

There being no further comment, discussion on the Enid Public Transportation Authority fund concluded.

Chairman Shewey adjourned the meeting to reconvene as the Enid City Commission.

Mayor Shewey called the meeting to order with the following members present and absent:

PRESENT: Commissioners Norwood, Ezzell, Waddell, Pankonin and Mayor Shewey.

ABSENT: Commissioners Janzen and Wilson.

Staff present were City Manager Jerald Gilbert, City Attorney Carol Lahman, City Clerk Alissa

Lack, Chief Financial Officer Erin Crawford, City Engineer Robert Hitt, Public Works Director Everett

Glenn, Planning Administrator Chris Bauer, Police Captain Bryan Skaggs, Fire Chief Joe Jackson,

Director of Marketing and Public Relations Steve Kime, Human Resources Director Sonya Key, and Ex-

Officio Member Colonel Darrell Judy.

Hindu Statesman Rajan Zed, President of the Universal Society of Hinduism, gave the Invocation, and Captain Bryan Skaggs led the Flag Salute.

Motion was made by Commissioner Ezzell and seconded by Commissioner Pankonin to approve the minutes of the regular Commission meeting of April 3, 2018, and the vote was as follows:

AYE: Commissioners Norwood, Ezzell, Waddell, Pankonin and Mayor Shewey.

NAY: None.

Animal Control Officer David Handley presented "Hollis", a 6-week-old female Lab mix available for adoption at the Enid Animal Shelter.

A Proclamation was read and presented proclaiming the month of May 2018 as "Better Hearing and Speech Awareness Month".

Girl Scout Troop 727 was recognized for their efforts in writing the "Smash Hit" to promote awareness of safety concerns regarding trucks and the East Maine Bridge.

A quarterly update was provided by Mr. Mike Cooper, Vance Development Consultant.

He explained that he generally appeared before the commission to provide updates on the Vance efforts and protect and enhance efforts, but he had also been asked to assist with finding dollars to help fund the Kaw Lake project. He described some issues going on in Washington, D.C. and working through different programs that could allow access to some low-interest money.

The President's Infrastructure Bill was expected to be presented, but not in this year. However, Mr. Cooper expected to see a big infrastructure bill in the near future. Dollars would still be spent on infrastructure, but not on the level of what had been done.

Mr. Cooper had worked with the House and Senate Armed Services Committees to come up with ways for communities and states to access dollars for assistance on projects such as water resiliency, alternative energy, schools, road access, and other issues that helped with readiness for the military. They had come up with language to include in the National Defense Authorization Act (NDAA) to put toward that bill, so that entities that have these particular issues have access to funding. An Authority would have to be established, which would likely be the Department of Economic Development because they are the link between the Department of Defense and the states and communities, and the entities would go through that Authority to apply for grants to assist with different projects. This would create a partnership to promote the completion of big infrastructure projects, such as the Kaw Lake project.

Earlier in the day, Mr. Cooper had attended a briefing on the Joint Land Use Study (JLUS), which the City had received funding from the Office of Economic Adjustment to help complete. The JLUS was not only dealing with encroachment, airspace protection issues and other similar issues, but also a wide variety of things that are important to present short-term and long-term projects for protection and enhancement projects.

At the state level, the budget had just been signed by the governor the previous day (April 30, 2018). What that meant was that the Oklahoma Strategic Military Planning Commission (OSMPC) went back to full funding of approximately \$1 million. Those were the dollars that the community could access to fund a variety of protection and enhancement efforts. The City had received \$158,000.00 in the current year, and would probably receive approximately that much more in the next fiscal year, to help fund the terminal at Enid Woodring Regional Airport.

For the past two years, efforts had been made to complete an air turbine legislation bill that would protect airspace, which was our most important asset. That legislation, under Senate Bill 1576, was officially passed and would be signed by the governor. This was a two-year effort that included the Department of Defense, the military, the Department of Defense Clearinghouse, a wide variety of senators and representatives, wind industry, the Regional Wind Coalition, and the American Wind

Association, in order to bring them all together at the federal level to determine where to build turbines for wind energy, not to say no, but to protect necessary airspace and weather radar utilized in training and readiness. The Federal Aviation Association (FAA) had determined seven levels of criteria of "no hazard", but weather radar was not one of them. Weather radar would be added at the federal level, in order to prevent construction in a particular location that might render radar useless.

It was noted that the Defense Department and the Department of Defense Clearinghouse had already directed the states of Ohio, Arizona, Florida, and North Carolina - areas that were having major issues with towers and structures - to look at this legislation.

While in Washington, D.C., both the Secretary of Defense [James Mattis] and the Principal Deputy of Air Force Installation, Environment, and Energy Lucien Niemeyer had been briefed regarding the wind turbine legislation. He stated that they were very thankful that it had been passed.

Mr. Cooper noted that Deputy Niemeyer was also briefed regarding the activity at Woodring Airport, and agreed that airport improvements couldn't have been done at a better time, especially given the pilot shortage.

In closing, Mr. Cooper spoke briefly regarding the pilot shortage, and how it related to the assets and infrastructure made here and how that could be utilized in the efforts to increase the mission.

Chief Financial Officer Erin Crawford addressed commissioners, explaining that a Request for Proposals (RFP) for audit services had been sent out. It had been five years since this had been done. The RFP was sent out to twelve qualified firms, and two proposals were received. A committee had reviewed the proposals and rated them. Based on the two proposals that were received and rated, RSM US LLP was ranked as the most qualified firm to perform the services for the City.

It was noted that the amount of the fee for services was smaller than the previous year's fee, reflecting an 8% decrease from the last year.

Motion was made by Commissioner Janzen and seconded by Commissioner Pankonin for approval of contract award for professional services to RSM US LLC, ranked the most qualified firm, to complete financial statement preparation; the Independent Auditor's Report on the financial statements of the City of Enid, Oklahoma and its related authorities; complete the Single-Audit Compliance Audit; and the State Auditor and Inspector Form 2643, in the amount of \$86,600.00, and the vote was as follows:

AYE: Commissioners Janzen, Norwood, Ezzell, Waddell, Pankonin and Mayor Shewey.

NAY: None.

City Engineer Robert Hitt provided a brief presentation regarding a request for variance to City of Enid Ordinance 10-6-1, "Sidewalks Required", for property located at 310 East Harvard Avenue. He explained that there was an existing building on the property that was approximately 5000 square feet in size, and the property owner was adding an additional structure that was approximately 5000 square feet in size.

It was noted that the ordinance required the inclusion of sidewalks that parallel abutting street, and also noted that there were exceptions for development along unimproved roads.

Mr. Hitt explained the street conditions for East Harvard Avenue. Although the street appeared to be unimproved and had use to it, he stated that the street had been slurry sealed at one time, so would not meet the definition of unimproved streets. The property owner had requested a variance based on lack of need for a sidewalk in the area and a street that appeared to comply with the definition of an unimproved street.

Motion was made by Commissioner Ezzell to approve said variance.

Motion was seconded by Commissioner Waddell, and the vote was as follows:

AYE: Commissioners Janzen, Norwood, Ezzell, Waddell, Pankonin and Mayor Shewey.

NAY: None.

Motion was made by Commissioner Ezzell and seconded by Commissioner Janzen for approval of contract award for Project No. F-1803C1, Chestnut West Detention Facility – Phase I, to the lowest responsible bidder, Beverages Construction LLC, Crescent, Oklahoma, in the amount of \$499,777.50, and authorize the mayor to execute all contract documents.

Following brief discussion, the vote was as follows:

AYE: Commissioners Janzen, Norwood, Ezzell, Waddell, Pankonin and Mayor Shewey.

NAY: None.

It was noted that there was an additional item under consent for a change order that would add additional dirt work to this project to bring the project up to the total funding available to do work in this area.

Commissioners conducted a review of a sign request for property located at 5230 West Owen K. Garriott Road to determine if an existing billboard may be relocated and converted to a digital billboard under Section 11-13-9(D) of the Enid Municipals Code, "Specific Economic Development Opportunities".

Planning Administrator Chris Bauer provided an illustration of the location of the property, which would be the site of the new Jiffy Trip, located at the northeast corner of Garriott Road and Garland Road. The reason for the proposed relocation of the billboard was to get the existing sign out of the traffic flow and increase safety on the property. The variance request was for changeable copy, which the current sign ordinance allowed on free-standing signs, but did not allow on a billboard. The applicant was seeking relief on that issue. If the variance was granted, it would allow the applicant to have changeable copy on the billboard.

Commissioner Ezzell noted that the ordinance explicitly prohibited electronic billboards. He further noted that there were not electronic billboards in town, and he expressed concern regarding the precedent that might be set in granting this request and the effect on future requests for similar variances.

Commissioner Ezzell made a motion to allow the movement of the billboard, without the change of the type.

Motion died for lack of a second.

Mr. Gilbert explained that the economic development perspective of this was a multi-million dollar improvement at the corner of Garriott and Garland. By observation, it appeared that larger communities, such as Tulsa and Oklahoma City, the trend was away from the old-style billboards, which many times were not maintained.

Mayor Shewey suggested that, in order to be business friendly, they needed to work on this ordinance.

Commissioner Ezzell explained that the billboard ordinance was passed based on an aesthetic decision for the city of Enid, and that if the ordinance was to change, it should be changed for everybody.

Mr. Don Rose of Williams Broadcasting, the company that owns the billboard, addressed commissioners regarding movement of the billboard. He explained the owner of the Jiffy Trip approached them regarding how to move the sign out of the development. In the effort to move the billboard, Williams Broadcasting had agreed to move the sign, while upgrading it at the same time. The upgrade of the sign would enhance the project.

Commissioner Janzen made a motion to approve the request.

Motion died from lack of a second.

A brief discussion was held regarding the potential content displayed on said billboard, the possibility of changing the City's billboard ordinance, and the current standards of digital signage in Enid.

It was noted that the intent of Williams Broadcasting was to comply with the standards currently established under the City's sign ordinance.

Motion was made by Commissioner Waddell to grant movement of sign and change of type with the condition to apply the automatic changeable copy sign regulations found in the sign ordinance.

Motion was seconded by Commissioner Pankonin

CONSIDER AN ORDINANCE AMENDING THE ENID MUNICIPAL CODE, 2014, TITLE 5, "PUBLIC SAFETY," CHAPTER 6, "MINORS," ARTICLE A, TO RENAME THE ARTICLE "TOBACCO AND VAPOR PRODUCTS"; TO AMEND SECTION 5-6A-1 "DEFINITIONS" TO ADD VAPOR PRODUCTS AND REMOVE TOBACCO VENDING MACHINES; TO REPEAL SECTIONS 5-6A-2 "TOBACCO VENDING MACHINES" AND CREATE SECTION 5-6A-2 "PURCHASE OR POSSESSION BY MINORS OF TOBACCO OR VAPOR PRODUCTS" TO PROVIDE PENALTY FOR POSSESSION, PURCHASE OR USE OF FRAUDULENT IDENTIFICATION; TO AMEND SECTION 5-6A-3 "FURNISHING TOBACCO OR VAPOR PRODUCTS TO MINORS" TO INCLUDE VAPOR PRODUCTS; TO REPEAL SECTIONS 5-6A-4 "PURCHASE, RECEIPT OR POSSESSION BY MINORS; 5-6A-5 "DISPLAY OF TOBACCO AGE RESTRICTION SIGNAGE"; 5-6A-6 " PUBLIC ACCESS TO TOBACCO PRODUCTS"; 5-6A-7 "TOBACCO PARAPHERNALIA" DUE TO STATE GOVERNMENT'S PREEMPTION; PROVIDING FOR REPEALER, SAVINGS CLAUSE, SEVERABILITY, CODIFICATION AND DECLARING AN EMERGENCY.

BACKGROUND:

The Police Department has requested expedited passage of this ordinance to allow for the prosecution of minors who possess or attempt to purchase vapor products. The Ordinance defines a vapor product and also repeals sections of the Code that have cities no longer have authority to enforce due to state preemption. The ABLE Commission now has exclusive enforcement responsibility for the location of tobacco vending machines, the signs that must be posted in retail establishments, and transfer of paraphernalia. An emergency clause has been added to the ordinance to provide immediate repeal of the preempted offenses and to provide quicker enforcement of vapor product offenses in Municipal Court. The emergency clause requires a separate vote and it must have six affirmative votes to be effective. If the emergency passes the ordinance will go into effect upon publication, otherwise it will go into effect in 30 days.

ORDINANCE NO. 2018-

AN ORDINANCE AMENDING THE ENID MUNICIPAL CODE, 2014, TITLE 5, "PUBLIC SAFETY," CHAPTER 6, "MINORS," ARTICLE A, TO RENAME THE ARTICLE "TOBACCO AND VAPOR PRODUCTS"; TO AMEND SECTION 5-6A-1 "DEFINITIONS" TO ADD VAPOR PRODUCTS AND REMOVE TOBACCO VENDING MACHINES; TO REPEAL SECTIONS 5-6A-2 "TOBACCO VENDING MACHINES" AND CREATE SECTION 5-6A-2 "PURCHASE OR POSSESSION BY MINORS OF TOBACCO OR VAPOR PRODUCTS" TO PROVIDE PENALTY FOR POSSESSION, PURCHASE OR USE OF FRAUDULENT IDENTIFICATION; TO AMEND SECTION 5-6A-3 "FURNISHING TOBACCO OR VAPOR PRODUCTS TO MINORS" TO INCLUDE VAPOR PRODUCTS: TO REPEAL SECTIONS 5-6A-4 "PURCHASE, RECEIPT OR POSSESSION BY MINORS; 5-6A-5 "DISPLAY OF TOBACCO AGE RESTRICTION SIGNAGE"; 5-6A-6 " PUBLIC ACCESS TO TOBACCO PRODUCTS"; "TOBACCO PARAPHERNALIA" DUE TO STATE GOVERNMENT'S PREEMPTION: PROVIDING FOR REPEALER, SAVINGS CLAUSE, SEVERABILITY, CODIFICATION AND DECLARING AN EMERGENCY.

EMERGENCY ORDINANCE

BE IT ORDAINED BY THE MAYOR AND BOARD OF COMMISSIONERS OF THE CITY OF ENID, OKLAHOMA:

<u>Section I.</u> That Title 5, Chapter 6, Article A, is renamed: TOBACCO <u>AND VAPOR PRODUCTS</u>.

Section II: That Title 5, Chapter 6, Sections 5-6A-1 is hereby amended to read:

5-6A-1: DEFINITIONS¹:

As used in this article, the following terms shall have the meanings ascribed to them in this section:

TOBACCO PRODUCT: Any product that contains tobacco and is intended for human consumption.

Footnote 1: State law reference - 37 OS § 600.1.

¹Footnotes - Click any footnote link to go back to its reference.

TOBACCO VENDING MACHINE: Includes any machine or device designated for use or used for the vending of cigarettes, cigars, tobacco or tobacco products upon the insertion of coins, trade checks or slugs. (1994 Code §§ 18–80, 18–81)

VAPOR PRODUCT: Any noncombustible products, that may or may not contain nicotine, that employ a mechanical heating element, battery, electronic circuit, or other mechanism, regardless of shape or size, that can be used to produce a vapor in a solution or other form. It shall include any vapor cartridge or other container with or without nicotine or other form that is intended to be used with an electronic cigarette, electronic cigar, electronic cigarillo, electronic pipe, or similar product or device and any vapor cartridge or other container of a solution, that may or may not contain nicotine, that is intended to be used with or in an electronic cigarette, electronic cigar, electronic cigarillo, electronic pipe, or electronic device. It does not include any products regulated by the United States Food and Drug Administration under Chapter V of the Food, Drug, and Cosmetic Act.

<u>Section III</u>: That Title 5, Chapter 6, Sections 5-6A-2 "Tobacco Vending Machines" :is hereby repealed:

5-6A-2: TOBACCO VENDING MACHINES:

- A. Conditions For Operation Of Vending Machines: It shall be unlawful for the owner or manager of any building or business, and any other person in lawful possession or control of the space, upon which a tobacco vending machine sits, to permit or allow to be operated a tobacco vending machine unless:
 - 1. The machine is located in an area not accessible to persons under eighteen (18) years of age; or
 - 2. The machine is located in a workplace where the general public is not usually admitted and where such machines are for the use of the employees therein. In such cases, it shall be the responsibility of the owner or manager of any building or business and any other person in lawful possession of said machine to bar access to the machine by persons under eighteen (18) years of age.
- B. Penalty: The violation of this section shall be punishable by a fine of up to five hundred dollars (\$500.00) plus costs. (Ord. 2013-59, 12-17-2013)

Section IV: That Title 5, Chapter 6, Section 5-6A-2 is hereby created:

<u>5-6A-2: PURCHASE OR POSSESSION BY MINORS OF TOBACCO OR VAPOR PRODUCTS:</u>

A. Minor Persons: It shall be unlawful for a person who is under eighteen (18) years of age to purchase, receive, or have in their possession a tobacco product.

- B. False Identification: It shall be unlawful for a person who is under eighteen (18) years of age to make use of fraudulent identification for the purpose of purchasing of tobacco products or vapor products.
- C. Minor Employees: It shall be lawful for an employee under eighteen (18) years of age to handle tobacco products when required in the performance of the employee's duties.
- D. Penalty: When a person violates subsection A or B of this section, The City shall impose a fine of One Hundred Dollars (\$100.00) for a first offense; and Two Hundred Dollars (\$200.00) for a second or subsequent offense within a one-year period following the first offense.

Section V: That Title 5, Chapter 6, Sections 5-6A-3 is hereby amended to read:

5-6A-3: FURNISHING TOBACCO OR VAPOR PRODUCTS TO MINORS:

- A. It is unlawful for any person to sell or furnish in any manner any tobacco or vapor products product to any person under the age of eighteen (18), or to purchase in any manner a tobacco product on behalf of any such person. It shall not be unlawful for an employee under eighteen (18) years of age to handle tobacco products when required in the performance of the employee's duties.
- B. Demanding Proof Of Age: A person engaged in the sale or distribution of tobacco products shall demand proof of age from a prospective purchaser or recipient if an ordinary person would conclude on the basis of appearance that the prospective purchaser may be under eighteen (18) years of age.
 - It is a defense to this offense if the person, who sold tobacco or vapor products to a person under eighteen years of age, demanded, and was shown, and reasonably relied upon proof of age in the form of a driver's license or other government issued photo identification purporting to establish that the purchaser was eighteen (18) years of age or older and the defendant confirmed the validity of the driver's license or other government issued photo identification presented by the purchaser by performing a transaction scan by means of a transaction device. Provided, however, that this defense is not available if the seller failed to exercise reasonable diligence to determine whether the physical description and picture appearing on the license or identification used was that of the person who presented it.
- C. Defense: Proof that the defendant demanded, was shown, and reasonably relied upon proof of age shall be a defense. Provided, however, that this defense is not available if said defendant failed to exercise reasonable diligence to determine whether the physical description and picture appearing on the license or identification used was that of the person who presented it.

Penalty: The violation of this section shall be punishable by a fine of up to one hundred dollars (\$100.00) plus costs, unless the person charged has been convicted previously within a two (2) year period, and then a violation of this section shall be punishable by a fine of up to two hundred dollars (\$200.00) plus costs, unless the person charged has been convicted twice previously within a two (2) year period, and then a violation of this section shall be punishable by a fine of up to three hundred dollars (\$300.00) plus costs.

D. Identification: Proof of age includes a driver's license or other government issued photo identification purporting to establish that the purchaser was eighteen (18) years of age or older and the defendant confirmed the validity of the driver's license or other government issued photo identification presented by the purchaser by performing a transaction scan by means of a transaction device.

Section VI: That Title 5, Chapter 6, Sections 5-6A-4 through 5-6A-7 are hereby repealed:

5-6A-4: PURCHASE, RECEIPT OR POSSESSION BY MINORS:

A. Minor Persons: It shall be unlawful for a person who is under eighteen (18) years of age to purchase, receive, or have in their possession a tobacco product.

B. Minor Employees: It shall not be unlawful for an employee under eighteen (18) years of age to handle tobacco products when required in the performance of the employee's duties.

C. Penalty: The violation of this section shall be punishable by a fine of up to one hundred dollars (\$100.00) plus costs, unless the person charged has been previously convicted within a two (2) year period, and then a violation of this section shall have a maximum fine of two hundred dollars (\$200.00) plus costs, unless the person charged has been convicted twice previously within a two (2) year period, and then a violation of this section shall be punishable by a fine of up to three hundred dollars (\$300.00) plus costs. (Ord. 2013-59, 12-17-2013)

5-6A-5: DISPLAY OF TOBACCO AGE RESTRICTION SIGNAGE:

- A. Any person who sells or displays tobacco products at retail must post conspicuously at the place of business a sign stating the following:
 IT'S THE LAW. WE DO NOT SELL TOBACCO PRODUCTS TO PERSONS UNDER 18 YEARS OF AGE.
 The sign shall also provide a toll free telephone number for the purpose of reporting violations of the prevention of youth access to tobacco act.
- B. The violation of this section shall be punishable by a fine of up to fifty dollars (\$50.00) for each day a violation occurs plus costs. (Ord. 2013-59, 12-17-2013)

5-6A-6: PUBLIC ACCESS TO TOBACCO PRODUCTS:

- A. It is unlawful for any person to display or offer for sale tobacco products in any manner that allows public access to the tobacco product without assistance from the person displaying the tobacco product or an employee or owner of the store.
- B. If the business does not admit into the store persons under eighteen (18) years of age, this section does not apply.
- C. The violation of this section shall be punishable by a fine of up to two hundred dollars (\$200.00) plus costs. (Ord. 2013-59, 12-17-2013)

5-6A-7: TOBACCO PARAPHERNALIA:

- A. Prohibited: It is unlawful for any person to sell, give, or furnish in any manner to a person under the age of eighteen (18) years of age any material or device used in the smoking, chewing, or other method of consumption of tobacco, including eigarette papers, pipes, holders of smoking materials of all types, and other items designed primarily for the smoking or ingestion of tobacco products.
- B. Penalty: The violation of this section shall be punishable by a fine of up to one hundred dollars (\$100.00) plus costs. (Ord. 2013-59, 12-17-2013)

<u>Section VII:</u> Repealer. All ordinances or parts thereof, which are inconsistent with this ordinance, are hereby repealed.

<u>Section VIII</u>: Savings Clause. Nothing in this ordinance hereby adopted shall be construed to affect any suit or proceedings now pending in any court, or any rights acquired or liability incurred, nor any cause or causes of action accrued or existing, under any act or ordinance repealed hereby. Nor shall any right or remedy of any character be lost, impaired or affected by this ordinance.

<u>Section IX</u>: Severability. If any one or more of the sections, sentences, clauses or parts of this ordinance, chapter or section shall, for any reason, be held invalid, the invalidity of such section, clause or part shall not affect or prejudice in any way the applicability and validity of any other provision of this ordinance. It is hereby declared to be the intention of the City Commission of the City of Enid that this section of the Enid Municipal Code would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part not been included.

<u>Section X:</u> Codification. This ordinance shall be codified as Title 5, Chapter 6, Sections 5-6A-1 through 5-6A-3 of the Enid Municipal Code, 2014.

<u>Section XI</u>. EMERGENCY. WHEREAS, it being necessary to give immediate effect to this ordinance to repeal certain sections that the state has claimed exclusive authority over and in order to cover the use of vapor products so to better protect the health, safety and welfare of the citizens of Enid, an emergency is hereby declared to exist. By reason whereof, this Ordinance shall take effect and be in full force and effect after its passage, as provided by law.

<u>Section 1</u>: That Title 5, Chapter 8, Section 5-8-1 of the Enid Municipal Code, 2014 is hereby amended as follows:

5-8-1: SOUND AMPLIFICATION:

- A. Advertising By Loudspeaker, Amplifying Device: No person shall make, cause to be made, or persist in making, in or upon any street, sidewalk or alley, or upon any private property, any loud, unnecessary, unusual or objectionable noise which disturbs the public peace or annoys the inhabitants of the city by maintaining or operating any music box, phonograph, piano, or any other music device, or any radio, phonograph amplifier, radio amplifier, or loudspeaker or other amplifying device, for the purpose of attracting the attention of persons upon the public streets to any business or trade, or for the purpose of advertising goods, wares or merchandise to the public, except as otherwise provided in this section. Such loud, unnecessary, unusual or objectionable noise which disturbs the public peace or annoys the inhabitants, and the maintenance or operation thereof, is hereby declared to be a nuisance.
- B. Exemption: The provisions of this section shall not apply to music furnished by any person to the exclusive enjoyment of persons actually on the premises or within the place of business of such person, provided the music so furnished shall not be sufficiently loud or offensive to annoy the public generally or to disturb the peace; provided further, that no loudspeaker located upon any premises outside the walls of any building located thereon shall be operated between the hours of ten o'clock (10:00) P.M. and six o'clock (6:00) A.M.
- C. Violation: Violation of this section shall have a maximum fine of two hundred dollars (\$200.00) seven hundred fifty dollars (\$750.00) plus costs.
- <u>Section 2</u>: Repealer. All ordinances or parts thereof, which are inconsistent with this ordinance, are hereby repealed.

- A. Operating without License: It shall be unlawful for any person to install, operate or maintain a cable system within the city without first obtaining the license required by this chapter.
- B. Unauthorized Connections to System: It shall be unlawful for any person to make any unauthorized connection, whether physically, electrically, acoustically, inductively, or otherwise, with any part of the licensee's cable system for the purpose of enabling himself or others to receive any signals, pictures, programs, sounds or any other information or intelligence transmitted over the licensee's system without the consent of the licensee.
- C. Injuring Cable Wires, Equipment: It shall be unlawful for any person, without the consent of the owners, willfully to tamper with, remove, or injure any cable, wires, or other equipment used for the distribution of signals, pictures, programs, sounds or any other information or intelligence transmitted over the licensee's cable system.
- D. Penalty: A violation of this section shall be punishable by a maximum fine of five hundred dollars (\$500.00) plus costs. It shall be a class A offense for any person to violate any of the provisions of this section.
- <u>Section 2</u>: Repealer. All ordinances or parts thereof, which are inconsistent with this ordinance, are hereby repealed.
- <u>Section 3</u>: Savings Clause. It is Lessee's intent to make Lease Payment for the full Lease Term if funds are legally available therefore and in that regard Lessee represents that the Equipment will be used for one or more authorized governmental or proprietary functions essential to its proper, efficient and economic operation.
- **3. DELIVERY AND ACCEPTANCE.** Lessor will cause the Equipment to be delivered to Lessee at the location specified in Schedule A ("Equipment Location"). Lessee will accept the Equipment as soon as it has been delivered and is operational. Lessee will evidence its acceptance of the Equipment by executing and delivering to Lessor a Delivery and Acceptance Certificate in the form provided by Lessor.

Even if Lessee has not executed and delivered to Lessor a Delivery and Acceptance Certificate, if Lessor believes the Equipment has been delivered and is operational, Lessor may require Lessee to notify Lessor in writing (within five (5) days of Lessee's receipt of Lessor's request) whether or not Lessee deems the Equipment (i) to have been delivered and (ii) to be operational, and hence be accepted by Lessee. If Lessee fails to so respond in such five (5) day period, Lessee will be deemed to have accepted the Equipment and be deemed to have acknowledged that the Equipment was delivered and is operational as if Lessee had in fact executed and delivered to Lessor a Delivery and Acceptance Certificate.

4. REPRESENTATIONS AND WARRANTIES. Lessor acknowledges that the Equipment leased hereunder is being manufactured and installed by Lessor pursuant to contract (the "Contract") covering the Equipment. Lessee acknowledges that on or prior to the date of acceptance of the Equipment, Lessor intends to sell and assign Lessor's right, title and interest in and to this Agreement and the Equipment to an assignee ("Assignee"). LESSEE FURTHER ACKNOWLEDGES THAT EXCEPT AS EXPRESSLY SET FORTH IN THE CONTRACT, LESSOR MAKES NO EXPRESS OR IMPLIED WARRANTIES OF ANY NATURE OR KIND WHATSOEVER, AND AS BETWEEN LESSEE AND THE ASSIGNEE, THE PROPERTY SHALL BE ACCEPTED BY LESSEE "AS IS" AND "WITH ALL FAULTS". LESSEE AGREES TO SETTLE ALL CLAIMS DIRECTLY WITH

LESSOR AND WILL NOT ASSERT OR SEEK TO ENFORCE ANY SUCH CLAIMS AGAINST THE ASSIGNEE. NEITHER LESSOR NOR THE ASSIGNEE SHALL BE LIABLE FOR ANY DIRECT, INDIRECT, SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES OF ANY CHARACTER AS A RESULT OF THE LEASE OF THE EQUIPMENT, INCLUDING WITHOUT LIMITATION, LOSS OF PROFITS, PROPERTY DAMAGE OR LOST PRODUCTION WHETHER SUFFERED BY LESSEE OR ANY THIRD PARTY.

Lessor is not responsible for, and shall not be liable to Lessee for damages relating to loss of value of the Equipment for any cause or situation (including, without limitation, governmental actions or regulations or actions of other third parties).

- 5. NON-APPROPRIATION OF FUNDS. Notwithstanding anything contained in this Lease to the contrary, Lessee has the right to not appropriate funds to make Lease Payments required hereunder in any fiscal period and in the event no funds are appropriated or in the event funds appropriated by Lessee's governing body or otherwise available by any lawful means whatsoever in any fiscal period of Lessee for Lease Payments or other amounts due under this Lease are insufficient therefor, this Lease shall terminate on the last day of the fiscal period for which appropriations were received without penalty or expense to Lessee of any kind whatsoever, except as to the portions of Lease Payments or other amounts herein agreed upon for which funds shall have been appropriated and budgeted or are otherwise available. The Lessee will immediately notify the Lessor or its Assignee of such occurrence. In the event of such termination, Lessee agrees to peaceably surrender possession of the Equipment to Lessor or its Assignee on the date of such termination, packed for shipment in accordance with manufacturer specifications and freight prepaid and insured to any location in the continental United States designated by Lessor. Lessor will have all legal and equitable rights and remedies to take possession of the Equipment. Non-appropriation of funds shall not constitute a default hereunder for purposes of Section 16.
- 6. LESSEE CERTIFICATION. Lessee represents, covenants and warrants that: (i) Lessee is a state or a duly constituted political subdivision or agency of the state of the Equipment Location; (ii) the interest portion of the Lease Payments shall be excludable from Lessor's gross income pursuant to Section 103 of the Internal Revenue Code of 1986, as it may be amended from time to time (the "Code"); (iii) the execution, delivery and performance by the Lessee of this Lease have been duly authorized by all necessary action on the part of the Lessee; (iv) this Lease constitutes a legal, valid and binding obligation of the Lessee enforceable in accordance with its terms; (v) Lessee will comply with the information reporting requirements of Section 149(e) of the Internal Revenue Code of 1986 (the "Code"), and such compliance shall include but not be limited to the execution of information statements requested by Lessor; (vi) Lessee will not do or cause to be done any act which will cause, or by omission of any act allow, the Lease to be an arbitrage bond within the meaning of Section 148(a) of the Code; (vii) Lessee will not do or cause to be done any act which will cause, or by omission of any act allow, this Lease to be a private activity bond within the meaning of Section 141(a) of the Code; (viii) Lessee will not do or cause to be done any act which will cause, or by omission of any act allow, the interest portion of the Lease Payment to be or become includible in gross income for Federal income taxation purposes under the Code; and (ix) Lessee will be the only entity to own, use and operate the Equipment during the Lease Term.

Lessee represents, covenants and warrants that: (i) it will do or cause to be done all things necessary to preserve and keep the Lease in full force and effect, (ii) it has complied with all laws relative to public bidding where necessary, and (iii) it has sufficient appropriations or other funds available to pay all amounts due hereunder for the current fiscal period.

If Lessee breaches the covenant contained in this Section, the interest component of Lease Payments may become includible in gross income of the owner or owners thereof for federal income tax purposes. In such event, notwithstanding anything to the contrary contained in Section 11 of this Agreement, Lessee agrees to pay promptly after any such determination of taxability and on each Lease Payment date thereafter to Lessor an additional amount determined by Lessor to compensate such owner or owners for the loss of such excludibility (including, without limitation, compensation relating to interest expense, penalties or additions to tax), which determination shall be conclusive (absent manifest error). Notwithstanding anything herein to the contrary, any additional amount payable by Lessee pursuant to this Section 6 shall be payable solely from Legally Available Funds.

It is Lessor's and Lessee's intention that this Agreement not constitute a "true" lease for federal income tax purposes and, therefore, it is Lessor's and Lessee's intention that Lessee be considered the owner of the Equipment for federal income tax purposes.

- 7. TITLE TO EQUIPMENT; SECURITY INTEREST. Upon shipment of the Equipment to Lessee hereunder, title to the Equipment will vest in Lessee subject to any applicable license; provided, however, that (i) in the event of termination of this Lease by Lessee pursuant to Section 5 hereof; (ii) upon the occurrence of an Event of Default hereunder, and as long as such Event of Default is continuing; or (iii) in the event that the purchase option has not been exercised prior to the Expiration Date, title will immediately vest in Lessor or its Assignee, and Lessee shall immediately discontinue use of the Equipment, remove the Equipment from Lessee's computers and other electronic devices and deliver the Equipment to Lessor or its Assignee. In order to secure all of its obligations hereunder, Lessee hereby (i) grants to Lessor a first and prior security interest in any and all right, title and interest of Lessee in the Equipment and in all additions, attachments, accessions, and substitutions thereto, and on any proceeds therefrom; (ii) agrees that this Lease may be filed as a financing statement evidencing such security interest; and (iii) agrees to execute and deliver all financing statements, certificates of title and other instruments necessary or appropriate to evidence such security interest.
- **8.** USE; REPAIRS. Lessee will use the Equipment in a careful manner for the use contemplated by the manufacturer of the Equipment and shall comply with all laws, ordinances, insurance policies, the Contract, any licensing or other agreement, and regulations relating to, and will pay all costs, claims, damages, fees and charges arising out of the possession, use or maintenance of the Equipment. Lessee, at its expense will keep the Equipment in good repair and furnish and/or install all parts, mechanisms, updates, upgrades and devices required therefor.
- **9. ALTERATIONS.** Lessee will not make any alterations, additions or improvements to the Equipment without Lessor's prior written consent unless such alterations, additions or improvements may be readily removed without damage to the Equipment.
- 10. LOCATION; INSPECTION. The Equipment will not be removed from, [or if the Equipment consists of rolling stock, its permanent base will not be changed from] the Equipment Location without Lessor's prior written consent which will not be unreasonably withheld. Lessor will be entitled to enter upon the Equipment Location or elsewhere during reasonable business hours to inspect the Equipment or observe its use and operation.
- 11. LIENS AND TAXES. Lessee shall keep the Equipment free and clear of all levies, liens and encumbrances except those created under this Lease. Lessee shall pay, when due, all charges and taxes (local, state and federal) which may now or hereafter be imposed upon the ownership, licensing, leasing, rental, sale, purchase, possession or use of the Equipment, excluding however, all taxes on or measured by Lessor's income. If Lessee fails to pay said charges and taxes when due, Lessor shall have the right, but shall not be obligated, to pay said charges and taxes. If Lessor pays any charges or taxes, Lessee shall reimburse Lessor therefor within thirty days of written demand.
- 12. RISK OF LOSS: DAMAGE; DESTRUCTION. Lessee assumes all risk of loss or damage to the Equipment from any cause whatsoever, and no such loss of or damage to the Equipment nor defect therein nor unfitness or obsolescence thereof shall relieve Lessee of the obligation to make Lease Payments or to perform any other obligation under this Lease. In the event of damage to any item of Equipment, Lessee will immediately place the same in good repair with the proceeds of any insurance recovery applied to the cost of such repair. If Lessor determines that any item of Equipment is lost, stolen, destroyed or damaged beyond repair (an "Event of Loss"), Lessee at the option of Lessor will: either (a) replace the same with like equipment in good repair; or (b) on the next Lease Payment date, pay Lessor the sum of: (i) all amounts then owed by Lessee to Lessor under this Lease, including the Lease payment due on such date; and (ii) an amount equal to all remaining Lease Payments to be paid during the Lease Term as set forth in Schedule B.

In the event that Lessee is obligated to make such payment with respect to less than all of the Equipment, Lessor will provide Lessee with the pro rata amount of the Lease Payment and the Balance Payment (as set forth in Schedule B) to be made by Lessee with respect to that part of the Equipment which has suffered the Event of Loss.

13. INSURANCE. Lessee will, at its expense, maintain at all times during the Lease Term, fire and extended coverage, public liability and property damage insurance with respect to the Equipment in such amounts,

covering such risks, and with such insurers as shall be satisfactory to Lessor, or, with Lessor's prior written consent, Lessee may self-insure against any or all such risks. All insurance covering loss of or damage to the Equipment shall be carried in an amount no less than the amount of the then applicable Balance Payment with respect to such Equipment. The initial amount of insurance required is set forth in Schedule B. Each insurance policy will name Lessee as an insured, and will contain a clause requiring the insurer to give Lessor at least thirty (30) days prior written notice of any alteration in the terms of such policy or the cancellation thereof. The proceeds of any such policies will be payable to Lessee. Upon acceptance of the Equipment and upon each insurance renewal date, Lessee will deliver to Lessor a certificate evidencing such insurance. In the event that Lessee has been permitted to self-insure, Lessee will furnish Lessor with a letter or certificate to such effect. In the event of any loss, damage, injury or accident involving the Equipment, Lessee will promptly provide Lessor with written notice thereof and make available to Lessor all information and documentation relating thereto.

14. Intentionally Ommitted.

15. ASSIGNMENT. Without Lessor's prior written consent, Lessee will not either (i) assign, transfer, pledge, hypothecate, grant any security interest in or otherwise dispose of this Lease or the Equipment or any interest in this Lease or the Equipment or; (ii) sublet or lend the Equipment or permit it to be used by anyone other than Lessee or Lessee's employees. Lessor may assign its rights, title and interest in and to this Lease, the Equipment and any documents executed with respect to this Lease and/or grant or assign a security interest in this Lease and the Equipment, in whole or in part. Any such assignees shall have all of the rights of Lessor under this Lease. Subject to the foregoing, this Lease inures to the benefit of and is binding upon the heirs, executors, administrators, successors and assigns of the parties hereto.

Lessee covenants and agrees not to assert against the Assignee any claims or defenses by way of abatement, setoff, counterclaim, recoupment or the like which Lessee may have against Lessor. No assignment or reassignment of any Lessor's right, title or interest in this Lease or the Equipment shall be effective unless and until Lessee shall have received a notice of assignment, disclosing the name and address of each such assignee; provided, however, that if such assignment is made to a bank or trust company as paying or escrow agent for holders of certificates of participation in the Lease, it shall thereafter be sufficient that a copy of the agency agreement shall have been deposited with Lessee until Lessee shall have been advised that such agency agreement is no longer in effect. During the Lease Term Lessee shall keep a complete and accurate record of all such assignments in form necessary to comply with Section 149(a) of the Code, and the regulations, proposed or existing, from time to time promulgated thereunder. No further action will be required by Lessor or by Lessee to evidence the assignment, but Lessee will acknowledge such assignments in writing if so requested.

Any Assignee of Lessor may reassign this Lease and its interest in the Equipment and the Lease Payments to any other person who, thereupon, shall be deemed to be Lessor's Assignee hereunder.

- 16. EVENT OF DEFAULT. The term "Event of Default", as used herein, means the occurrence of any one or more of the following events: (i) Lessee fails to make any Lease Payment (or any other payment) as it becomes due in accordance with the terms of the Lease when funds have been appropriated sufficient for such purpose, and any such failure continues for ten (10) days after the due date thereof; (ii) Lessee fails to perform or observe any other covenant, condition, or agreement to be performed or observed by it hereunder and such failure is not cured within twenty (20) days after written notice thereof by Lessor; (iii) the discovery by Lessor that any statement, representation, or warranty made by Lessee in this Lease or in writing delivered by Lessee pursuant hereto or in connection herewith is false, misleading or erroneous in any material respect; (iv) proceedings under any bankruptcy, insolvency, reorganization or similar legislation shall be instituted against or by Lessee, or a receiver or similar officer shall be appointed for Lessee or any of its property, and such proceedings or appointments shall not be vacated, or fully stayed, within twenty (20) days after the institution or occurrence thereof; or (v) an attachment, levy or execution is threatened or levied upon or against the Equipment.
- 17. REMEDIES. Upon the occurrence of an Event of Default, and as long as such Event of Default is continuing, Lessor may, at its option, exercise any one or more of the following remedies: (i) by written notice to Lessee, declare all amounts then due under the Lease, and all remaining Lease Payments due during the fiscal period in effect when the default occurs to be immediately due and payable, whereupon the same shall become immediately due and payable; (ii) by written notice to Lessee, request Lessee to (and Lessee agrees that it will), at Lessee's expense, promptly discontinue use of the Equipment, remove the Equipment from all of Lessee's computers and electronic devices, return the Equipment to Lessor in the manner set forth in Section 5 hereof, or Lessor, at its option, may enter upon the premises where the Equipment is located and take immediate possession of and remove

the same; (iii) sell or lease the Equipment or sublease it for the account of Lessee, holding Lessee liable for all Lease Payments and other amounts due prior to the effective date of such selling, leasing or subleasing and for the difference between the purchase price, rental and other amounts paid by the purchaser, Lessee or sublessee pursuant to such sale, lease or sublease and the amounts payable by Lessee hereunder; (iv) promptly return the Equipment to Lessor in the manner set forth in Section 5 hereof; and (v) exercise any other right, remedy or privilege which may be available to it under applicable laws of the state of the Equipment Location or any other applicable law or proceed by appropriate court action to enforce the terms of the Lease or to recover damages for the breach of this Lease or to rescind this Lease as to any or all of the Equipment. Upon satisfaction by Lessee of such purchase conditions, Lessor will transfer any and all of its right, title and interest in the Equipment to Lessee as is, without warranty, express or implied, except that the Equipment is free and clear of any liens created by Lessor.

- **21. GOVERNING LAW.** This Lease shall be construed in accordance with, and governed by the laws of, the state of the Equipment Location.
- **22. DELIVERY OF RELATED DOCUMENTS.** Lessee will execute or provide, as requested by Lessor, such other documents and information as are reasonably necessary with respect to the transaction contemplated by this Lease.
- 23. ENTIRE AGREEMENT; WAIVER. This Lease, together with Schedule A Equipment Lease-Purchase Agreement, Schedule B, Evidence of Insurance, Statement of Essential Use/Source of Funds, Certificate of Incumbency, Certified Lessee Resolution (if any), Bank Qualified Statement, Information Return for Tax-Exempt Governmental Obligations and the Delivery and Acceptance Certificate and other attachments hereto, and other documents or instruments executed by Lessee and Lessor in connection herewith, constitutes the entire agreement between the parties with respect to the Lease of the Equipment, and this Lease shall not be modified, amended, altered, or changed except with the written consent of Lessee and Lessor. Any provision of the Lease found to be prohibited by law shall be ineffective to the extent of such prohibition without invalidating the remainder of the Lease.

The waiver by Lessor of any breach by Lessee of any term, covenant or condition hereof shall not operate as a waiver of any subsequent breach thereof.

Communications System Agreement

(Lease)

Motorola Solutions, Inc. ("Motorola") and <u>City of Enid, OK</u> ("Customer") enter into this "Agreement," pursuant to which Customer will purchase and Motorola will sell the System, as described below. Motorola and Customer may be referred to individually as a "Party" and collectively as the "Parties."

WHEREAS, Houston-Galveston Area Council ("H-GAC"), acting as the agent for various local governmental entities who are "End Users" under interlocal agreements (including the Customer) has solicited proposals for radio communications equipment and conducted discussions with Motorola concerning its proposal and, where applicable, in accordance with the competitive procurement procedures of Texas law; and

WHEREAS, H-GAC and Motorola entered into that certain Contract dated as of May 1, 2015 (the "Contract"), which provided that End Users may purchase radio communications equipment from Motorola pursuant to certain terms contained therein; and

WHEREAS, pursuant to Article 6 of the Contract, Motorola and Customer now wish to enter into this Communications System Agreement to delineate the specific terms of the purchase of radio communications equipment and services from Motorola by the Customer.

For good and valuable consideration, the Parties agree as follows:

Section 1 EXHIBITS

The exhibits listed below are incorporated into and made a part of this Agreement. In interpreting this Agreement and resolving any ambiguities, the main body of this Agreement takes precedence over the exhibits and any inconsistency between Exhibits A through F will be resolved in their listed order.

Section 2 DEFINITIONS

Capitalized terms used in this Agreement have the following meanings:

[&]quot;Acceptance Tests" means those tests described in the Acceptance Test Plan.

[&]quot;Administrative User Credentials" means an account that has total access over the operating system, files, end user accounts and passwords at either the System level or box level. Customer's personnel with access to the Administrative User Credentials may be referred to as the Administrative User.

- "Beneficial Use" means when Customer first uses the System or a Subsystem for operational purposes (excluding training or testing).
- "Confidential Information" means all information consistent with the fulfillment of this Agreement that is (i) disclosed under this Agreement in oral, written, graphic, machine recognizable, and/or sample form, being clearly designated, labeled or marked as confidential or its equivalent or (ii) obtained by examination, testing or analysis of any hardware, software or any component part thereof provided by discloser to recipient. The nature and existence of this Agreement are considered Confidential Information. Confidential Information that is disclosed orally must be identified as confidential at the time of disclosure and confirmed by the discloser by submitting a written document to the recipient within thirty (30) days after such disclosure. The written document must contain a summary of the Confidential Information disclosed with enough specificity for identification purpose and must be labeled or marked as confidential or its equivalent.
- "Contract Price" means the price for the System and Services, excluding applicable sales or similar taxes and freight charges.
- "Deliverables" means all written information (such as reports, specifications, designs, plans, drawings, or other technical or business information) that Motorola prepares for Customer in the performance of the Services and is obligated to provide to Customer under this Agreement. The Deliverables, if any, are more fully described in the Statement of Work.
- "Derivative Proprietary Materials" means derivatives of the Proprietary Materials that Motorola may from time to time, including during the course of providing the Services, develop and/or use and/or to which Motorola provides Customer access.
- "Effective Date" means that date upon which the last Party executes this Agreement.
- **"Equipment"** means the hardware components of the Solution that Customer purchases from Motorola under this Agreement. Equipment that is part of the System is described in the Equipment List.
- "Equipment Lease-Purchase Agreement" means the agreement by which Customer finances all or a portion of the Contract Price.
- "Force Majeure" means an event, circumstance, or act of a third party that is beyond a Party's reasonable control (e.g., an act of God, an act of the public enemy, an act of a government entity, strikes or other labor disturbances, hurricanes, earthquakes, fires, floods, epidemics, embargoes, war, and riots).
- "Infringement Claim" means a third party claim alleging that the Equipment manufactured by Motorola or the Motorola Software directly infringes a United States patent or copyright.
- "Motorola Software" means software that Motorola or its affiliated companies owns.
- "Non-Motorola Software" means software that a party other than Motorola or its affiliated companies owns.
- "Open Source Software" (also called "freeware" or "shareware") means software with either freely obtainable source code, license for modification, or permission for free distribution.
- "Proprietary Materials" means certain software tools and/or other technical materials, including, but not limited to, data, modules, components, designs, utilities, subsets, objects, program listings, models, methodologies, programs, systems, analysis frameworks, leading practices and specifications which Motorola has developed prior to, or independently from, the provision of the Services and/or which Motorola licenses from third parties.

- "Proprietary Rights" means the patents, patent applications, inventions, copyrights, trade secrets, trademarks, trade names, mask works, know-how, and other intellectual property rights in and to the Equipment and Software, including those created or produced by Motorola under this Agreement and any corrections, bug fixes, enhancements, updates or modifications to or derivative works from the Software whether made by Motorola or another party.
- "Services" means maintenance, support, subscription, or other professional services provided under this Agreement, which may be further described in the applicable SOW.
- "Software" means the Motorola Software and Non-Motorola Software, including all modifications, enhancements, new versions or new releases, in object code format that is furnished with the System or Equipment or provided to enable Services.
- "Solution" means the combination of the System(s) and Services provided by Motorola under this Agreement.
- "Specifications" means the functionality and performance requirements that are described in the Technical and Implementation Documents.
- **"Subsystem"** means a major part of the System that performs specific functions or operations. Subsystems are described in the Technical and Implementation Documents.
- "System" means the Equipment, including incidental hardware and materials, Software, and design, installation and implementation services that are combined together into an integrated system; the System(s) is (are) described in the Technical and Implementation Documents.
- "System Acceptance" means the Acceptance Tests have been successfully completed.
- "Warranty Period" for System Hardware, Software, or services related to system implementation means one (1) year from the date of System Acceptance or Beneficial Use, whichever occurs first. Warranty Period for professional Services means ninety (90) days from performance of the Service.

Section 3 SCOPE OF AGREEMENT AND TERM

- 3.1. SCOPE OF WORK. Motorola will provide, install and test the System(s), and perform its other contractual responsibilities to provide the Solution, all in accordance with this Agreement. Customer will perform its contractual responsibilities in accordance with this Agreement.
- 3.2. CHANGE ORDERS. Either Party may request changes within the general scope of this Agreement. If a requested change causes an increase or decrease in the cost or time required to perform this Agreement, the Parties will agree to an equitable adjustment of the Contract Price, Performance Schedule, or both, and will reflect the adjustment in a change order. Neither Party is obligated to perform requested changes unless both Parties execute a written change order.
- 3.3. TERM. Unless terminated in accordance with other provisions of this Agreement or extended by mutual agreement of the Parties, the term of this Agreement begins on the Effective Date and continues until expiration of the ten (10) years of maintenance and support.
- 3.4. ADDITIONAL EQUIPMENT OR SOFTWARE. For three (3) years after the expiration date of the Agreement, Customer may order additional Equipment or Software, if it is then available. Each purchase order must refer to this Agreement, the expiration date of the Agreement, and must specify the pricing and delivery terms. The Parties agree that, notwithstanding expiration of the Agreement, the applicable provisions of this Agreement (except for pricing, delivery, passage of title and risk of loss to Equipment, warranty commencement, and payment terms) will govern the purchase and sale of the additional Equipment or Software. Additional or contrary terms in the purchase order will be inapplicable, unless

signed by both parties. Title and risk of loss to additional Equipment will pass at shipment, warranty will commence upon delivery, and payment is due within twenty (20) days after the invoice date. Motorola will send Customer an invoice as the additional Equipment is shipped or Software is licensed. Alternatively, Customer may register with and place orders through Motorola Online ("MOL"), and this Agreement will be the "Underlying Agreement" for those MOL transactions rather than the MOL On-Line Terms and Conditions of Sale. MOL registration and other information may be found at https://businessonline.Motorola.com and the MOL telephone number is (800) 814-0601. Unless lease financing arrangements are mutually agreed in writing concerning the additional Equipment or Software orders, they are not covered by the Equipment Lease-Purchase Agreement. To the extent additional Equipment orders may be covered by the Equipment Lease Purchase Agreement, unless otherwise stated in the Equipment Lease Purchase Agreement, title to the Equipment will pass to Customer upon shipment.

- 3.6. Motorola SOFTWARE. Any Motorola Software, including subsequent releases, is licensed to Customer solely in accordance with the Motorola Software License Agreement in Exhibit A ("Software License Agreement"). Customer hereby accepts and agrees to abide by all of the terms and restrictions of the Software License Agreement.
- 3.7. NON-Motorola SOFTWARE. Any Non-Motorola Software is licensed to Customer in accordance with the standard license, terms, and restrictions of the copyright owner on the Effective Date unless the copyright owner has granted to Motorola the right to sublicense the Non-Motorola Software pursuant to the Software License Agreement, in which case it applies and the copyright owner will have all of Licensor's rights and protections under the Software License Agreement. Motorola makes no representations or warranties of any kind regarding Non-Motorola Software. Non-Motorola Software may include Open Source Software.
- 3.8. SUBSTITUTIONS. At no additional cost to Customer, Motorola may substitute any Equipment, Software, or services to be provided by Motorola, if the substitute meets or exceeds the Specifications and is of equivalent or better quality to the Customer. Any substitution will be reflected in a change order.
- 3.9. OPTIONAL EQUIPMENT OR SOFTWARE. This paragraph applies only if a "Priced Options" exhibit is shown in Section 1, or if the parties amend this Agreement to add a Priced Options exhibit. During the term of the option as stated in the Priced Options exhibit (or if no term is stated, then for one (1) year after the Effective Date), Customer has the right and option to purchase the equipment, software, and related services that are described in the Priced Options exhibit. Customer may exercise this option by giving written notice to Seller which must designate what equipment, software, and related services Customer is selecting (including quantities, if applicable). To the extent they apply, the terms and conditions of this Agreement will govern the transaction; however, the parties acknowledge that certain provisions must be agreed upon, and they agree to negotiate those in good faith promptly after Customer delivers the option exercise notice. Examples of provisions that may need to be negotiated are: specific lists of deliverables, statements of work, acceptance test plans, delivery and implementation schedules, payment terms, maintenance and support provisions, additions to or modifications of the Software License Agreement, hosting terms, and modifications to the acceptance and warranty provisions.

Section 4 SERVICES

If Customer desires and Motorola agrees to continue Services beyond the Term, Customer's issuance and Motorola's acceptance of a purchase order for Services will serve as an automatic extension of the Agreement for purposes of the continuing Services. Only the terms and conditions applicable to the performance of Services will apply to the extended Agreement.

4.1 MAINTENANCE AND SUPPORT SERVICES. During the Warranty Period, in addition to warranty services, Motorola will provide maintenance Services for the Equipment and support for the Motorola Software pursuant to the Statement of Work set forth in Exhibit E -1. Maintenance Services and support during the Warranty Period are included in the Contract Price. If Customer wishes to purchase 1) additional maintenance or software support services during the Warranty Period; or 2) continue or expand

maintenance, software support, and installation services after the Warranty Period, Motorola will provide the description of and pricing for such services in a separate proposal document. Unless otherwise agreed by the parties in writing, the terms and conditions in this Agreement applicable to those maintenance, support, and installation Services and the applicable Statements of Work will govern the provision of such services.

To obtain additional maintenance and software support services, Customer will issue a purchase order referring to this Agreement and the separate proposal document. Omission of reference to this Agreement in Customer's purchase order will not affect the applicability of this Agreement. Motorola's proposal may include a cover page entitled "Service Agreement" or "Installation Agreement", as applicable, and other attachments. These cover pages and other attachments are incorporated into this Agreement by this reference.

4.2 PROFESSIONAL SERVICES. If Customer purchases professional Services as part of the Solution, the Additional Professional Services Terms in Exhibit D-2 will apply to those services. Customer may also purchase additional professional services by issuing a purchase order referencing this Agreement and Motorola's proposal for such additional services.

4.3 INTENTIONALLY OMITTED.

- 4.4 Any information in the form of specifications, drawings, reprints, technical information or otherwise furnished to Customer in providing Services under this Agreement or data viewed, accessed, will remain Motorola's property, will be deemed proprietary, Confidential Information. This Confidential Information will be promptly returned at Motorola's request.
- 4.5 TOOLS. All tools, equipment, dies, gauges, models, drawings or other materials paid for or furnished by Motorola for the purpose of providing Services under this Agreement will be and remain the sole property of Motorola. Customer will safeguard all such property while it is in Customer's custody or control, be liable for any loss or damage to this property, and return it to Motorola upon request. This property will be held by Customer for Motorola's use without charge and may be removed from Customer's premises by Motorola at any time without restriction. Upon termination of the contract for any reason, Customer shall return to Motorola all equipment delivered to Customer.
- 4.6 COVENANT NOT TO EMPLOY. During the term of this Agreement and continuing for a period of two (2) years thereafter, Customer will not hire, engage on contract, solicit the employment of, or recommend employment to any third party of any employee of Motorola or its subcontractors without the prior written authorization of Motorola. This provision applies only to those employees of Motorola or its subcontractors who are responsible for rendering Services under this Agreement. If this provision is found to be overly broad under applicable law, it will be modified as necessary to conform to applicable law.
- 4.7 CUSTOMER OBLIGATIONS. If the Statement of Work contains assumptions that affect the Services or Deliverables, Customer will verify that they are accurate and complete. Any information that Customer provides to Motorola concerning the Services or Deliverables will be accurate and complete in all material respects. Customer will make timely decisions and obtain any required management approvals that are reasonably necessary for Motorola to perform the Services and its other duties under this Agreement. Unless the Statement of Work states the contrary, Motorola may rely upon and is not required to evaluate, confirm, reject, modify, or provide advice concerning any assumptions and Customer-provided information, decisions and approvals described in this paragraph.
- 4.8 NON-PRECLUSION. If, as a result of the Services performed under this Agreement, Motorola recommends that Customer purchase products or other services, nothing in this Agreement precludes Motorola from participating in a future competitive bidding process or otherwise offering or selling the

recommended products or other services to Customer. Customer represents that this paragraph does not violate its procurement or other laws, regulations, or policies.

- 4.9 ASSUMPTIONS. If any assumptions or conditions contained in this Agreement or applicable Statement of Work prove to be incorrect or if Customer's obligations are not performed, Motorola's ability to perform under this Agreement may be impacted and changes to the Contract Price, project schedule, Deliverables, or other changes may be necessary.
- 4.10 PROPRIETARY MATERIALS. Customer acknowledges that Motorola may use and/or provide Customer with access to Proprietary Materials and Derivative Proprietary Materials. The Proprietary Materials and the Derivative Proprietary Materials are the sole and exclusive property of Motorola and Motorola retains all right, title and interest in and to the Proprietary Materials and Derivative Proprietary Materials.
- 4.11 ADDITIONAL SERVICES. Any services performed by Motorola outside the scope of this Agreement at the direction of Customer will be considered to be additional Services which are subject to additional charges. Any agreement to perform additional Services will be reflected in a written and executed change order or amendment to this Agreement.

Section 5 PERFORMANCE SCHEDULE

The Parties will perform their respective responsibilities in accordance with the Performance Schedule. By executing this Agreement, Customer authorizes Motorola to proceed with contract performance.

Section 6 CONTRACT PRICE, PAYMENT AND INVOICING

- 6.1. CONTRACT PRICE. The Contract Price in U.S. dollars is \$469,850.73, which includes the H-GAC administration fee, and the project as stated in Motorola's proposal dated September 5, 2017, including ten (10) years of Maintenance and Support (including the Warranty Period). Upon Agreement execution, Customer will make a down payment of \$50,000.00 in the form of a wire transfer, warrant, check, or cashier's check from a U.S. financial institution. The balance of the purchase price will be paid via the disbursement of the financing proceeds pursuant to the Equipment Lease-Purchase Agreement No. 24234 executed between the parties. For Customer's reference, the Federal Tax Identification Number for Motorola Solutions, Inc. is 36-1115800. Motorola has priced the Services, Software, and Equipment as an integrated System. A reduction in Software or Equipment quantities, or Services, may affect the overall Contract Price, including discounts if applicable.
- 6.2. FREIGHT, TITLE, AND RISK OF LOSS. Motorola will pre-pay and add all freight charges to the invoices. Unless otherwise stated in the Equipment Lease-Purchase Agreement, title to the Equipment will pass to Customer upon shipment. Title to Software will not pass to Customer at any time. Risk of loss will pass to Customer upon delivery of the Equipment to the Customer. Motorola will pack and ship all Equipment in accordance with good commercial practices.
- 6.3. INVOICING AND SHIPPING ADDRESSES. Invoices will be sent to the Customer at the following address: 401 West Garriott, Enid, OK 73701

The address which is the ultimate destination where the Equipment will be delivered to Customer is: 401 West Garriott, Enid, OK 73701

The Equipment will be shipped to the Customer at the following address (insert if this information is known): 401 West Garriott, Enid, OK 73701

Customer may change this information by giving written notice to Motorola.

Section 7 SITES AND SITE CONDITIONS

- 7.1. ACCESS TO SITES. In addition to its responsibilities described elsewhere in this Agreement, Customer will provide a designated project manager; all necessary construction and building permits, zoning variances, licenses, and any other approvals that are necessary to develop or use the sites and mounting locations; and access to the work sites or vehicles identified in the Technical and Implementation Documents as reasonably requested by Motorola so that it may perform its duties in accordance with the Performance Schedule and Statement of Work. If the Statement of Work so indicates, Motorola may assist Customer in the local building permit process.
- 7.2. SITE CONDITIONS. Customer will ensure that all work sites it provides will be safe, secure, and in compliance with all applicable industry and OSHA standards. To the extent applicable and unless the Statement of Work states to the contrary, Customer will ensure that these work sites have adequate: physical space; air conditioning and other environmental conditions; adequate and appropriate electrical power outlets, distribution, equipment and connections; and adequate telephone or other communication lines (including modem access and adequate interfacing networking capabilities), all for the installation, use and maintenance of the System. Before installing the Equipment or Software at a work site, Motorola may inspect the work site and advise Customer of any apparent deficiencies or non-conformities with the requirements of this Section. This Agreement is predicated upon normal soil conditions as defined by the version of E.I.A. standard RS-222 in effect on the Effective Date.
- 7.3. SITE ISSUES. If a Party determines that the sites identified in the Technical and Implementation Documents are no longer available or desired, or if subsurface, structural, adverse environmental or latent conditions at any site differ from those indicated in the Technical and Implementation Documents, the Parties will promptly investigate the conditions and will select replacement sites or adjust the installation plans and specifications as necessary. If change in sites or adjustment to the installation plans and specifications causes a change in the cost or time to perform, the Parties will equitably amend the Contract Price, Performance Schedule, or both, by a change order.

Section 8 TRAINING

Any training to be provided by Motorola to Customer will be described in the Statement of Work. Customer will notify Motorola immediately if a date change for a scheduled training program is required. If Motorola incurs additional costs because Customer reschedules a training program less than thirty (30) days before its scheduled start date, Motorola may recover these additional costs.

Section 9 SYSTEM ACCEPTANCE

- 9.1 COMMENCEMENT OF ACCEPTANCE TESTING. Motorola will provide to Customer at least ten (10) days notice before the Acceptance Tests commence. System testing will occur only in accordance with the Acceptance Test Plan.
- 9.2 SYSTEM ACCEPTANCE. System Acceptance will occur upon successful completion of the Acceptance Tests. Upon System Acceptance, the Parties will memorialize this event by promptly executing a System Acceptance Certificate. If the Acceptance Test Plan includes separate tests for individual Subsystems or phases of the System, acceptance of the individual Subsystem or phase will occur upon the successful completion of the Acceptance Tests for the Subsystem or phase, and the Parties will promptly execute an acceptance certificate for the Subsystem or phase. If Customer believes the System has failed the completed Acceptance Tests, Customer will provide to Motorola a written notice that includes the specific details of the failure. If Customer does not provide to Motorola a failure notice within thirty (30) days after completion of the Acceptance Tests, System Acceptance will be deemed to have occurred as of the completion of the Acceptance Tests. Minor omissions or variances in the System that do not materially impair the operation of the System as a whole will not postpone System Acceptance or Subsystem acceptance, but will be corrected according to a mutually agreed schedule.

- 9.3 BENEFICIAL USE. Customer acknowledges that Motorola's ability to perform its implementation and testing responsibilities may be impeded if Customer begins using the System before System Acceptance. Therefore, Customer will not commence Beneficial Use before System Acceptance without Motorola's prior written authorization, which will not be unreasonably withheld. Motorola is not responsible for System performance deficiencies that occur during unauthorized Beneficial Use. Upon commencement of Beneficial Use, Customer assumes responsibility for the use and operation of the System.
- 9.4 FINAL PROJECT ACCEPTANCE. Final Project Acceptance will occur after System Acceptance when all deliverables and other work have been completed. When Final Project Acceptance occurs, the parties will promptly memorialize this final event by so indicating on the System Acceptance Certificate.

Section 10 REPRESENTATIONS AND WARRANTIES

- 10.1. SYSTEM FUNCTIONALITY. Motorola represents that the System will perform in accordance with the Specifications in all material respects. Upon System Acceptance or Beneficial Use, whichever occurs first, this System functionality representation is fulfilled. Motorola is not responsible for System performance deficiencies that are caused by ancillary equipment not furnished by Motorola which is attached to or used in connection with the System or for reasons or parties beyond Motorola's control, such as natural causes; the construction of a building that adversely affects the microwave path reliability or radio frequency (RF) coverage; the addition of frequencies at System sites that cause RF interference or intermodulation; or Customer changes to load usage or configuration outside the Specifications.
- 10.2 EQUIPMENT WARRANTY. During the Warranty Period, Motorola warrants that the Equipment under normal use and service will be free from material defects in materials and workmanship. If System Acceptance is delayed beyond six (6) months after shipment of the Equipment by events or causes beyond Motorola's control, this warranty expires eighteen (18) months after the shipment of the Equipment.
- 10.3 Software Warranty. Unless otherwise stated in the Software License Agreement, during the Warranty Period, Motorola warrants the Software in accordance with the warranty terms set forth in the Software License Agreement and the provisions of this Section 9 that are applicable to the Software. If System Acceptance is delayed beyond six (6) months after shipment of the Motorola Software by events or causes beyond Motorola's control, this warranty expires eighteen (18) months after the shipment of the Motorola Software. TO THE EXTENT, IF ANY, THAT THERE IS A SEPARATE LICENSE AGREEMENT PACKAGED WITH, OR PROVIDED ELECTRONICALLY WITH, A PARTICULAR PRODUCT THAT BECOMES EFFECTIVE ON AN ACT OF ACCEPTANCE BY THE END USER, THEN THAT AGREEMENT SUPERCEDES THE SOFTWARE LICENSE AGREEMENT AS TO THE END USER OF EACH SUCH PRODUCT.
- 10.4. EXCLUSIONS TO EQUIPMENT AND SOFTWARE WARRANTIES. These warranties do not apply to: (i) defects or damage resulting from: use of the Equipment or Software in other than its normal, customary, and authorized manner; accident, liquids, neglect, or acts of God; testing, maintenance, disassembly, repair, installation, alteration, modification, or adjustment not provided or authorized in writing by Motorola; Customer's failure to comply with all applicable industry and OSHA standards; (ii) breakage of or damage to antennas unless caused directly by defects in material or workmanship; (iii) Equipment that has had the serial number removed or made illegible; (iv) batteries (because they carry their own separate limited warranty) or consumables; (v) freight costs to ship Equipment to the repair depot; (vi) scratches or other cosmetic damage to Equipment surfaces that does not affect the operation of the Equipment; and (vii) normal or customary wear and tear.
- 10.5 SERVICE WARRANTY. During the Warranty Period, Motorola warrants that the Services will be provided in a good and workman like manner and will conform in all material respects to the applicable Statement of Work. Services will be free of defects in materials and workmanship for a period of ninety (90) days from the date the performance of the Services are completed. Customer acknowledges that

the Deliverables may contain recommendations, suggestions or advice from Motorola to Customer (collectively, "recommendations"). Motorola makes no warranties concerning those recommendations, and Customer alone accepts responsibility for choosing whether and how to implement the recommendations and the results to be realized from implementing them.

- 10.6 WARRANTY CLAIMS. To assert a warranty claim, Customer must notify Motorola in writing of the claim before the expiration of the Warranty Period. Upon receipt of this notice, Motorola will investigate the warranty claim. If this investigation confirms a valid Equipment or Software warranty claim, Motorola will (at its option and at no additional charge to Customer) repair the defective Equipment or Motorola Software, replace it with the same or equivalent product, or refund the price of the defective Equipment or Motorola Software. These actions will be the full extent of Motorola's liability for the warranty claim. In the event of a valid Services warranty claim, Customer's sole remedy is to require Motorola to re-perform the non-conforming Service or to refund, on a pro-rata basis, the fees paid for the non-conforming Service. If this investigation indicates the warranty claim is not valid, then Motorola may invoice Customer for responding to the claim on a time and materials basis using Motorola's then current labor rates. Repaired or replaced product is warranted for the balance of the original applicable warranty period. All replaced products or parts will become the property of Motorola.
- 10.7 ORIGINAL END USER IS COVERED. These express limited warranties are extended by Motorola to the original user purchasing the System or Services for commercial, industrial, or governmental use only, and are not assignable or transferable.
- 10.8 DISCLAIMER OF OTHER WARRANTIES. THESE WARRANTIES ARE THE COMPLETE WARRANTIES FOR THE EQUIPMENT AND Motorola SOFTWARE PROVIDED UNDER THIS AGREEMENT AND ARE GIVEN IN LIEU OF ALL OTHER WARRANTIES. Motorola DISCLAIMS ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY, NON-INFRINGEMENT, AND FITNESS FOR A PARTICULAR PURPOSE.

Section 11 DELAYS

- 11.1 FORCE MAJEURE. Neither Party will be liable for its non-performance or delayed performance if caused by a Force Majeure. A Party that becomes aware of a Force Majeure that will significantly delay performance will notify the other Party promptly (but in no event later than fifteen days) after it discovers the Force Majeure. If a Force Majeure occurs, the Parties will execute a change order to extend the Performance Schedule for a time period that is reasonable under the circumstances.
- 11.2 PERFORMANCE SCHEDULE DELAYS CAUSED BY CUSTOMER. If Customer (including its other contractors) delays the Performance Schedule, it will make the promised payments according to the Payment Schedule as if no delay occurred; and the Parties will execute a change order to extend the Performance Schedule and, if requested, compensate Motorola for all reasonable charges incurred because of the delay. Delay charges may include costs incurred by Motorola or its subcontractors for additional freight, warehousing and handling of Equipment; extension of the warranties; travel; suspending and re-mobilizing the work; additional engineering, project management, and standby time calculated at then current rates; and preparing and implementing an alternative implementation plan.

Section 12 DISPUTES

The Parties will use the following procedure to address any dispute arising under this Agreement (a "Dispute").

12.1 GOVERNING LAW. This Agreement will be governed by and construed in accordance with the laws of the State in which the System is installed.

- 12.2 NEGOTIATION. Either Party may initiate the Dispute resolution procedures by sending a notice of Dispute ("Notice of Dispute"). The Parties will attempt to resolve the Dispute promptly through good faith negotiations including 1) timely escalation of the Dispute to executives who have authority to settle the Dispute and who are at a higher level of management than the persons with direct responsibility for the matter and 2) direct communication between the executives. If the Dispute has not been resolved within ten (10) days from the Notice of Dispute, the Parties will proceed to mediation.
- 12.3 MEDIATION. The Parties will choose an independent mediator within thirty (30) days of a notice to mediate from either Party ("Notice of Mediation"). Neither Party may unreasonably withhold consent to the selection of a mediator. If the Parties are unable to agree upon a mediator, either Party may request that American Arbitration Association nominate a mediator. Each Party will bear its own costs of mediation, but the Parties will share the cost of the mediator equally. Each Party will participate in the mediation in good faith and will be represented at the mediation by a business executive with authority to settle the Dispute.
- 12.4. LITIGATION, VENUE and JURISDICTION. If a Dispute remains unresolved for sixty (60) days after receipt of the Notice of Mediation, either Party may then submit the Dispute to a court of competent jurisdiction in the state in which the System is installed. Each Party irrevocably agrees to submit to the exclusive jurisdiction of the courts in such state over any claim or matter arising under or in connection with this Agreement.
- 12.5 CONFIDENTIALITY. All communications pursuant to subsections 12.2 and 12.3 will be treated as compromise and settlement negotiations for purposes of applicable rules of evidence and any additional confidentiality protections provided by applicable law. The use of these Dispute resolution procedures will not be construed under the doctrines of laches, waiver or estoppel to affect adversely the rights of either Party.

Section 13 DEFAULT AND TERMINATION

- 13.1 DEFAULT BY A PARTY. If either Party fails to perform a material obligation under this Agreement, the other Party may consider the non-performing Party to be in default (unless a Force Majeure causes the failure) and may assert a default claim by giving the non-performing Party a written and detailed notice of default. Except for a default by Customer for failing to pay any amount when due under this Agreement which must be cured immediately, the defaulting Party will have thirty (30) days after receipt of the notice of default to either cure the default or, if the default is not curable within thirty (30) days, provide a written cure plan. The defaulting Party will begin implementing the cure plan immediately after receipt of notice by the other Party that it approves the plan. If Customer is the defaulting Party, Motorola may stop work on the project until it approves the Customer's cure plan.
- 13.2. FAILURE TO CURE. If a defaulting Party fails to cure the default as provided above in Section 13.1, unless otherwise agreed in writing, the non-defaulting Party may terminate any unfulfilled portion of this Agreement. In the event of termination for default, the defaulting Party will promptly return to the non-defaulting Party any of its Confidential Information. If Customer is the non-defaulting Party, terminates this Agreement as permitted by this Section, and completes the System through a third Party, Customer may as its exclusive remedy recover from Motorola reasonable costs incurred to complete the System to a capability not exceeding that specified in this Agreement less the unpaid portion of the Contract Price. Customer will mitigate damages and provide Motorola with detailed invoices substantiating the charges.
- 13.3. CONVENIENCE: Customer must provide to Motorola formal written notice at least thirty (30) days in advance of the effective date of the termination. The notice must explicitly state the effective date of the termination and whether the contract termination is in whole or in part, and if in part, which part is being terminated. If Customer exercises this right to terminate for convenience, it will be liable to pay Motorola for the portion of the Contract Price attributable to the Equipment and/or Software delivered, and all services performed, on or before the effective date of the termination. Notwithstanding the above,

Customer shall have no right to terminate this Agreement if Motorola has given Customer a notice of default and such default has not been cured.

Section 14 INDEMNIFICATION

- 14.1 GENERAL INDEMNITY BY Motorola. Motorola will indemnify and hold Customer harmless from any and all liability, expense, judgment, suit, cause of action, or demand for personal injury, death, or direct damage to tangible property which may accrue against Customer to the extent it is caused by the negligence of Motorola, its subcontractors, or their employees or agents, while performing their duties under this Agreement, if Customer gives Motorola prompt, written notice of any claim or suit. Customer will cooperate with Motorola in its defense or settlement of the claim or suit. This section sets forth the full extent of Motorola's general indemnification of Customer from liabilities that are in any way related to Motorola's performance under this Agreement. Notwithstanding, this obligation does not apply if Motorola is entitled to immunity under the NG911 Act of 2012.
- 14.2 INTENTIONALLY OMITTED.
- 14.3 PATENT AND COPYRIGHT INFRINGEMENT.
- 14.3.1 Motorola will defend at its expense any suit brought against Customer to the extent it is based on a third-party claim alleging that the Equipment manufactured by Motorola or the Motorola Software ("Motorola Product") directly infringes a United States patent or copyright ("Infringement Claim"). Motorola's duties to defend and indemnify are conditioned upon: Customer promptly notifying Motorola in writing of the Infringement Claim; Motorola having sole control of the defense of the suit and all negotiations for its settlement or compromise; and Customer providing to Motorola cooperation and, if requested by Motorola, reasonable assistance in the defense of the Infringement Claim. In addition to Motorola's obligation to defend, and subject to the same conditions, Motorola will pay all damages finally awarded against Customer by a court of competent jurisdiction for an Infringement Claim or agreed to, in writing, by Motorola in settlement of an Infringement Claim.
- 14.3.2 If an Infringement Claim occurs, or in Motorola's opinion is likely to occur, Motorola may at its option and expense: (a) procure for Customer the right to continue using the Motorola Product; (b) replace or modify the Motorola Product so that it becomes non-infringing while providing functionally equivalent performance; or (c) accept the return of the Motorola Product and grant Customer a credit for the Motorola Product, less a reasonable charge for depreciation. The depreciation amount will be calculated based upon generally accepted accounting standards.
- 14.3.3 Motorola will have no duty to defend or indemnify for any Infringement Claim that is based upon: (a) the combination of the Motorola Product with any software, apparatus or device not furnished by Motorola; (b) the use of ancillary equipment or software not furnished by Motorola and that is attached to or used in connection with the Motorola Product; (c) Motorola Product designed or manufactured in accordance with Customer's designs, specifications, guidelines or instructions, if the alleged infringement would not have occurred without such designs, specifications, guidelines or instructions; (d) a modification of the Motorola Product by a party other than Motorola; (e) use of the Motorola Product in a manner for which the Motorola Product was not designed or that is inconsistent with the terms of this Agreement; or (f) the failure by Customer to install an enhancement release to the Motorola Software that is intended to correct the claimed infringement. In no event will Motorola's liability resulting from its indemnity obligation to Customer extend in any way to royalties payable on a per use basis or the Customer's revenues, or any royalty basis other than a reasonable royalty based upon revenue derived by Motorola from Customer from sales or license of the infringing Motorola Product.
- 14.3.4 This Section 14 provides Customer's sole and exclusive remedies and Motorola's entire liability in the event of an Infringement Claim. Customer has no right to recover and Motorola has no obligation to provide any other or further remedies, whether under another provision of this Agreement or any other

legal theory or principle, in connection with an Infringement Claim. In addition, the rights and remedies provided in this Section 14 are subject to and limited by the restrictions set forth in Section 15.

Section 15 LIMITATION OF LIABILITY

Except for personal injury or death, Motorola's total liability, whether for breach of contract, warranty, negligence, strict liability in tort, indemnification, or otherwise, will be limited to the direct damages recoverable under law, but not to exceed the price of the Equipment, Software, or Services with respect to which losses or damages are claimed. With respect to annual Services such as maintenance and subscription Services, Motorola's total liability will be limited to the direct damages recoverable under law, but not to exceed the price of twelve (12) months of Services preceding the incident giving rise to the claim. ALTHOUGH THE PARTIES ACKNOWLEDGE THE POSSIBILITY OF SUCH LOSSES OR DAMAGES. THEY AGREE THAT Motorola WILL NOT BE LIABLE FOR ANY COMMERCIAL LOSS. INCONVENIENCE, LOSS OF USE, LOSS TIME, DATA, GOODWILL, REVENUES, PROFITS OR SAVINGS; OR OTHER SPECIAL, INCIDENTAL, INDIRECT, OR CONSEQUENTIAL DAMAGES IN ANY WAY RELATED TO OR ARISING FROM THIS AGREEMENT, THE SALE OR USE OF THE EQUIPMENT OR SOFTWARE, OR THE PERFORMANCE OF SERVICES BY Motorola PURSUANT TO THIS AGREEMENT. This limitation of liability provision survives the expiration or termination of the Agreement and applies notwithstanding any contrary provision. No action for contract breach or otherwise relating to the transactions contemplated by this Agreement may be brought more than one (1) year after the accrual of the cause of action, except for money due upon an open account.

Notwithstanding the above, the Parties acknowledge that Motorola shall be classified as a service provider as defined by the Next Generation 9-1-1 Advancement Act of 2012 ("NG911 Act") and therefore is entitled to the immunity protections granted under the NG911 Act.

Section 16 CONFIDENTIALITY AND PROPRIETARY RIGHTS

16.1 CONFIDENTIAL INFORMATION.

- 16.1.1 Each party is a disclosing party ("Discloser") and a receiving party ("Recipient") under this Agreement. All Deliverables will be deemed to be Motorola's Confidential Information. During the term of this Agreement and for a period of three (3) years from the expiration or termination of this Agreement, Recipient will (i) not disclose Confidential Information to any third party; (ii) restrict disclosure of Confidential Information to only those employees (including, but not limited to, employees of any wholly owned subsidiary, a parent company, any other wholly owned subsidiaries of the same parent company), agents or consultants who must be directly involved with the Confidential Information for the purpose and who are bound by confidentiality terms substantially similar to those in this Agreement; (iii) not copy, reproduce, reverse engineer, de-compile or disassemble any Confidential Information; (iv) use the same degree of care as for its own information of like importance, but at least use reasonable care, in safeguarding against disclosure of Confidential Information; (v) promptly notify Discloser upon discovery of any unauthorized use or disclosure of the Confidential Information and take reasonable steps to regain possession of the Confidential Information and prevent further unauthorized actions or other breach of this agreement; and (vi) only use the Confidential Information as needed to fulfill this Agreement.
- 16.1.2 Recipient is not obligated to maintain as confidential, Confidential Information that Recipient can demonstrate by documentation (i) is now available or becomes available to the public without breach of this agreement; (ii) is explicitly approved for release by written authorization of Discloser; (iii) is lawfully obtained from a third party or parties without a duty of confidentiality; (iv) is known to the Recipient prior to such disclosure; or (v) is independently developed by Recipient without the use of any of Discloser's Confidential Information or any breach of this Agreement.
- 16.1.3 All Confidential Information remains the property of the Discloser and will not be copied or reproduced without the express written permission of the Discloser, except for copies that are absolutely necessary in order to fulfill this Agreement. Within ten (10) days of receipt of Discloser's written request,

Recipient will return all Confidential Information to Discloser along with all copies and portions thereof, or certify in writing that all such Confidential Information has been destroyed. However, Recipient may retain one (1) archival copy of the Confidential Information that it may use only in case of a dispute concerning this Agreement. No license, express or implied, in the Confidential Information is granted other than to use the Confidential Information in the manner and to the extent authorized by this Agreement. The Discloser warrants that it is authorized to disclose any Confidential Information it discloses pursuant to this Agreement.

- 16.2 PRESERVATION OF Motorola'S PROPRIETARY RIGHTS. Motorola, the third party manufacturer of any Equipment, and the copyright owner of any Non-Motorola Software own and retain all of their respective Proprietary Rights in the Equipment and Software, and nothing in this Agreement is intended to restrict their Proprietary Rights. All intellectual property developed, originated, or prepared by Motorola in connection with providing to Customer the Equipment, Software, or related services remain vested exclusively in Motorola, and this Agreement does not grant to Customer any shared development rights of intellectual property. Except as explicitly provided in the Software License Agreement, Motorola does not grant to Customer, either directly or by implication, estoppel, or otherwise, any right, title or interest in Motorola's Proprietary Rights. Customer will not modify, disassemble, peel components, decompile, otherwise reverse engineer or attempt to reverse engineer, derive source code or create derivative works from, adapt, translate, merge with other software, reproduce, distribute, sublicense, sell or export the Software, or permit or encourage any third party to do so. The preceding sentence does not apply to Open Source Software which is governed by the standard license of the copyright owner.
- 16.3 VOLUNTARY DISCLOSURE. Except as required to fulfill its obligations under this Agreement, Motorola will have no obligation to provide Customer with access to its Confidential Information and/or proprietary information. Under no circumstances will Motorola be required to provide any data related to cost and pricing.
- 16.4 OKLAHOMA PUBLIC RECORDS ACT Motorola understands Customer is a governmental entity that must comply with the Oklahoma Open Records Act Title 51 Section 24A.1 et seq., but said law does provide an exception to disclosure for information technology (Title 51 Section 24A.28.5).

Section 17 GENERAL

- 17.1 TAXES. The Contract Price does not include any excise, sales, lease, use, property, or other taxes, assessments or duties, all of which will be paid by Customer except as exempt by law. If Motorola is required to pay any of these taxes, Motorola will send an invoice to Customer and Customer will pay to Motorola the amount of the taxes (including any interest and penalties) within sixty (60) days after the date of the invoice. Customer will be solely responsible for reporting the Equipment for personal property tax purposes, and Motorola will be solely responsible for reporting taxes on its income or net worth.
- 17.2 ASSIGNABILITY AND SUBCONTRACTING. Except as provided herein, neither Party may assign this Agreement or any of its rights or obligations hereunder without the prior written consent of the other Party, which consent will not be unreasonably withheld. Any attempted assignment, delegation, or transfer without the necessary consent will be void. Notwithstanding the foregoing, Motorola may assign this Agreement to any of its affiliates or its right to receive payment without the prior consent of Customer. In addition, in the event Motorola separates one or more of its businesses (each a "Separated Business"), whether by way of a sale, establishment of a joint venture, spin-off or otherwise (each a "Separation Event"), Motorola may, without the prior written consent of the other Party and at no additional cost to Motorola, assign this Agreement such that it will continue to benefit the Separated Business and its affiliates (and Motorola and its affiliates, to the extent applicable) following the Separation Event. Motorola may subcontract any of the work, but subcontracting will not relieve Motorola of its duties under this Agreement.
- 17.3 WAIVER. Failure or delay by either Party to exercise a right or power under this Agreement will not be a waiver of the right or power. For a waiver of a right or power to be effective, it must be in a

writing signed by the waiving Party. An effective waiver of a right or power will not be construed as either a future or continuing waiver of that same right or power, or the waiver of any other right or power.

- 17.4 SEVERABILITY. If a court of competent jurisdiction renders any part of this Agreement invalid or unenforceable, that part will be severed and the remainder of this Agreement will continue in full force and effect.
- 17.5 INDEPENDENT CONTRACTORS. Each Party will perform its duties under this Agreement as an independent contractor. The Parties and their personnel will not be considered to be employees or agents of the other Party. Nothing in this Agreement will be interpreted as granting either Party the right or authority to make commitments of any kind for the other. This Agreement will not constitute, create, or be interpreted as a joint venture, partnership or formal business organization of any kind.
- 17.6 HEADINGS AND SECTION REFERENCES. The section headings in this Agreement are inserted only for convenience and are not to be construed as part of this Agreement or as a limitation of the scope of the particular section to which the heading refers. This Agreement will be fairly interpreted in accordance with its terms and conditions and not for or against either Party.
- 17.7 NOTICES. Notices required under this Agreement to be given by one Party to the other must be in writing and either personally delivered or sent to the address shown below by certified mail, return receipt requested and postage prepaid (or by a recognized courier service, such as Federal Express, UPS, or DHL), or by facsimile with correct answerback received, and will be effective upon receipt:

- 17.8 COMPLIANCE WITH APPLICABLE LAWS. Each Party will comply with all applicable federal, state, and local laws, regulations and rules concerning the performance of this Agreement or use of the System. Customer will obtain and comply with all Federal Communications Commission ("FCC") licenses and authorizations required for the installation, operation and use of the System before the scheduled installation of the Equipment. Although Motorola might assist Customer in the preparation of its FCC license applications, neither Motorola nor any of its employees is an agent or representative of Customer in FCC or other matters.
- 17.9 AUTHORITY TO EXECUTE AGREEMENT. Each Party represents that it has obtained all necessary approvals, consents and authorizations to enter into this Agreement and to perform its duties under this Agreement; the person executing this Agreement on its behalf has the authority to do so; upon execution and delivery of this Agreement by the Parties, it is a valid and binding contract, enforceable in accordance with its terms; and the execution, delivery, and performance of this Agreement does not violate any bylaw, charter, regulation, law or any other governing authority of the Party.
- 17.10 ADMINISTRATOR LEVEL ACCOUNT ACCESS. If applicable to the type of System purchased by Customer, Motorola will provide Customer with Administrative User Credentials. Customer agrees to only grant access to the Administrative User Credentials to those personnel with the training and experience to correctly use them. Customer is responsible for protecting Administrative User Credentials from disclosure and maintaining Credential validity by, among other things, updating passwords when required. Customer may be asked to provide valid Administrative User Credentials when in contact with Motorola System support personnel. Customer understands that changes made as the Administrative

User can significantly impact the performance of the System. Customer agrees that it will be solely responsible for any negative impact on the System or its users by any such changes. System issues occurring as a result of changes made using the Administrative User Credentials may impact Motorola's ability to perform Services or other obligations under the Agreement. In such cases, a revision to the appropriate provisions of the Agreement, including the Statement of Work, may be necessary. To the extent Motorola provides assistance to correct any issues caused by or arising out of the use of or failure to maintain Administrative User Credentials, Motorola will be entitled to bill Customer and Customer will pay Motorola on a time and materials basis for resolving the issue.

- SURVIVAL OF TERMS. The following provisions will survive the expiration or termination of this Agreement for any reason: Section 3.6 (Motorola Software); Section 3.7 (Non-Motorola Software); if any payment obligations exist, Sections 6.1 and 6.2 (Contract Price and Invoicing and Payment); Subsection 10.8 (Disclaimer of Implied Warranties); Section 12 (Disputes); Section 15 (Limitation of Liability); and Section 16 (Confidentiality and Proprietary Rights); and all of the General provisions in Section 17.
- 17.12 ENTIRE AGREEMENT. This Agreement, including all Exhibits, constitutes the entire agreement of the Parties regarding the subject matter of the Agreement and supersedes all previous agreements, proposals, and understandings, whether written or oral, relating to this subject matter. This Agreement may be executed in multiple counterparts, and shall have the same legal force and effect as if the Parties had executed it as a single document. The Parties may sign in writing, or by electronic signature, including by email. An electronic signature, or a facsimile copy or computer image, such as a PDF or tiff image, of a signature, shall be treated as and shall have the same effect as an original signature. In addition, an electronic signature, a true and correct facsimile copy or computer image of this Agreement shall be treated as and shall have the same effect as an original signed copy of this document. This Agreement may be amended or modified only by a written instrument signed by authorized representatives of both Parties. The preprinted terms and conditions found on any Customer purchase or purchase order, acknowledgment or other form will not be considered an amendment or modification of this Agreement, even if a representative of each Party signs that document.

Exhibit A

Motorola SOFTWARE LICENSE AGREEMENT

This Exhibit A Software License Agreement ("Agreement") is between Motorola Solutions, Inc., ("Motorola"), and <u>City of Enid, OK</u> ("Licensee").

For good and valuable consideration, the parties agree as follows:

Section 1 DEFINITIONS

- 1.1 "Designated Products" means products provided by Motorola to Licensee with which or for which the Software and Documentation is licensed for use.
- 1.2 "Documentation" means product and software documentation that specifies technical and performance features and capabilities, and the user, operation and training manuals for the Software (including all physical or electronic media upon which such information is provided).
- 1.3 "Open Source Software" means software with either freely obtainable source code, license for modification, or permission for free distribution.
- 1.4 "Open Source Software License" means the terms or conditions under which the Open Source Software is licensed.
- 1.5 "Primary Agreement" means the agreement to which this exhibit is attached.
- 1.6 "Security Vulnerability" means a flaw or weakness in system security procedures, design, implementation, or internal controls that could be exercised (accidentally triggered or intentionally exploited) and result in a security breach such that data is compromised, manipulated or stolen or the system damaged.
- 1.7 "Software" (i) means proprietary software in object code format, and adaptations, translations, decompilations, disassemblies, emulations, or derivative works of such software; (ii) means any modifications, enhancements, new versions and new releases of the software provided by Motorola; and (iii) may contain one or more items of software owned by a third party supplier. The term "Software" does not include any third party software provided under separate license or third party software not licensable under the terms of this Agreement.

Section 2 SCOPE

Motorola and Licensee enter into this Agreement in connection with Motorola's delivery of certain proprietary software or products containing embedded or pre-loaded proprietary software, or both. This Agreement contains the terms and conditions of the license Motorola is providing to Licensee, and Licensee's use of the proprietary software and related documentation.

Section 3 GRANT OF LICENSE

3.1. Subject to the provisions of this Agreement and the payment of applicable license fees, Motorola grants to Licensee a personal, limited, non-transferable (except as permitted in Section 7) and non-exclusive license under Motorola's copyrights and Confidential Information (as defined in the Primary Agreement) embodied in the Software to use the Software, in object code form, and the Documentation solely in connection with Licensee's use of the Designated Products. This Agreement does not grant any rights to source code.

3.2. If the Software licensed under this Agreement contains or is derived from Open Source Software, the terms and conditions governing the use of such Open Source Software are in the Open Source Software Licenses of the copyright owner and not this Agreement. If there is a conflict between the terms and conditions of this Agreement and the terms and conditions of the Open Source Software Licenses governing Licensee's use of the Open Source Software, the terms and conditions of the license grant of the applicable Open Source Software Licenses will take precedence over the license grants in this Agreement. If requested by Licensee, Motorola will use commercially reasonable efforts to: (i) determine whether any Open Source Software is provided under this Agreement; and (ii) identify the Open Source Software and provide Licensee a copy of the applicable Open Source Software License (or specify where that license may be found).

Section 4 LIMITATIONS ON USE

- 4.1. Licensee may use the Software only for Licensee's internal business purposes and only in accordance with the Documentation. Any other use of the Software is strictly prohibited. Without limiting the general nature of these restrictions, Licensee will not make the Software available for use by third parties on a "time sharing," "application service provider," or "service bureau" basis or for any other similar commercial rental or sharing arrangement.
- Licensee will not, and will not allow or enable any third party to: (i) reverse engineer, 4.2. disassemble, peel components, decompile, reprogram or otherwise reduce the Software or any portion to a human perceptible form or otherwise attempt to recreate the source code; (ii) modify, adapt, create derivative works of, or merge the Software; (iii) copy, reproduce, distribute, lend, or lease the Software or Documentation to any third party, grant any sublicense or other rights in the Software or Documentation to any third party, or take any action that would cause the Software or Documentation to be placed in the public domain; (iv) remove, or in any way alter or obscure, any copyright notice or other notice of Motorola's proprietary rights; (v) provide, copy, transmit, disclose, divulge or make the Software or Documentation available to, or permit the use of the Software by any third party or on any machine except as expressly authorized by this Agreement; or (vi) use, or permit the use of, the Software in a manner that would result in the production of a copy of the Software solely by activating a machine containing the Software. Licensee may make one copy of Software to be used solely for archival, backup, or disaster recovery purposes; provided that Licensee may not operate that copy of the Software at the same time as the original Software is being operated. Licensee may make as many copies of the Documentation as it may reasonably require for the internal use of the Software.
- 4.3. Unless otherwise authorized by Motorola in writing, Licensee will not, and will not enable or allow any third party to: (i) install a licensed copy of the Software on more than one unit of a Designated Product; or (ii) copy onto or transfer Software installed in one unit of a Designated Product onto one other device. Licensee may temporarily transfer Software installed on a Designated Product to another device if the Designated Product is inoperable or malfunctioning, if Licensee provides written notice to Motorola of the temporary transfer and identifies the device on which the Software is transferred. Temporary transfer of the Software to another device must be discontinued when the original Designated Product is returned to operation and the Software must be removed from the other device. Licensee must provide prompt written notice to Motorola at the time temporary transfer is discontinued.
- 4.4. Licensee will maintain, during the term of this Agreement and for a period of two years thereafter, accurate records relating to this license grant to verify compliance with this Agreement. Motorola or an independent third party ("Auditor") may inspect Licensee's premises, books and records, upon reasonable prior notice to Licensee, during Licensee's normal business hours and subject to Licensee's facility and security regulations. Motorola is responsible for the payment of all expenses and costs of the Auditor. Any information obtained by Motorola and the Auditor will be kept in strict confidence by Motorola and the Auditor and used solely for the purpose of verifying Licensee's compliance with the terms of this Agreement.

Section 5 OWNERSHIP AND TITLE

Motorola, its licensors, and its suppliers retain all of their proprietary rights in any form in and to the Software and Documentation, including, but not limited to, all rights in patents, patent applications, inventions, copyrights, trademarks, trade secrets, trade names, and other proprietary rights in or relating to the Software and Documentation (including any corrections, bug fixes, enhancements, updates, modifications, adaptations, translations, de-compilations, disassemblies, emulations to or derivative works from the Software or Documentation, whether made by Motorola or another party, or any improvements that result from Motorola's processes or, provision of information services). No rights are granted to Licensee under this Agreement by implication, estoppel or otherwise, except for those rights which are expressly granted to Licensee in this Agreement. All intellectual property developed, originated, or prepared by Motorola in connection with providing the Software, Designated Products, Documentation or related services, remains vested exclusively in Motorola, and Licensee will not have any shared development or other intellectual property rights.

Section 6 LIMITED WARRANTY; DISCLAIMER OF WARRANTY

- 6.1. Unless otherwise stated in the Primary Agreement, the commencement date and the term of the Software warranty will be a period of ninety (90) days from Motorola's shipment of the Software (the "Warranty Period"). If Licensee is not in breach of any of its obligations under this Agreement, Motorola warrants that the unmodified Software, when used properly and in accordance with the Documentation and this Agreement, will be free from a reproducible defect that eliminates the functionality or successful operation of a feature critical to the primary functionality or successful operation of the Software. Whether a defect occurs will be determined by Motorola solely with reference to the Documentation. Motorola does not warrant that Licensee's use of the Software or the Designated Products will be uninterrupted, error-free, completely free of Security Vulnerabilities, or that the Software or the Designated Products will meet Licensee's particular requirements. Motorola makes no representations or warranties with respect to any third party software included in the Software. Notwithstanding, any warranty provided by a copyright owner in its standard license terms will flow through to Licensee for third party software provided by Motorola.
- 6.2 Motorola's sole obligation to Licensee and Licensee's exclusive remedy under this warranty is to use reasonable efforts to remedy any material Software defect covered by this warranty. These efforts will involve either replacing the media or attempting to correct significant, demonstrable program or documentation errors or Security Vulnerabilities. If Motorola cannot correct the defect within a reasonable time, then at Motorola's option, Motorola will replace the defective Software with functionally-equivalent Software, license to Licensee substitute Software which will accomplish the same objective, or terminate the license and refund the Licensee's paid license fee.
- 6.3. Warranty claims are described in the Primary Agreement.
- 6.4. The express warranties set forth in this Section 6 are in lieu of, and Motorola disclaims, any and all other warranties (express or implied, oral or written) with respect to the Software or Documentation, including, without limitation, any and all implied warranties of condition, title, non-infringement, merchantability, or fitness for a particular purpose or use by Licensee (whether or not Motorola knows, has reason to know, has been advised, or is otherwise aware of any such purpose or use), whether arising by law, by reason of custom or usage of trade, or by course of dealing. In addition, Motorola disclaims any warranty to any person other than Licensee with respect to the Software or Documentation.

Section 7 TRANSFERS

Licensee will not transfer the Software or Documentation to any third party without Motorola's prior written consent. Motorola's consent may be withheld at its discretion and may be conditioned upon transferee

paying all applicable license fees and agreeing to be bound by this Agreement. If the Designated Products are Motorola's radio products and Licensee transfers ownership of the Motorola radio products to a third party, Licensee may assign its right to use the Software (other than CPS and Motorola's FLASHport® software) which is embedded in or furnished for use with the radio products and the related Documentation; provided that Licensee transfers all copies of the Software and Documentation to the transferee, and Licensee and the transferee sign a transfer form to be provided by Motorola upon request, obligating the transferee to be bound by this Agreement.

Section 8 TERM AND TERMINATION

- 8.1 Licensee's right to use the Software and Documentation will begin when the Primary Agreement is signed by both parties and will continue for the life of the Designated Products with which or for which the Software and Documentation have been provided by Motorola, unless Licensee breaches this Agreement, in which case this Agreement and Licensee's right to use the Software and Documentation may be terminated immediately upon notice by Motorola.
- 8.2 Within thirty (30) days after termination of this Agreement, Licensee must certify in writing to Motorola that all copies of the Software have been removed or deleted from the Designated Products and that all copies of the Software and Documentation have been returned to Motorola or destroyed by Licensee and are no longer in use by Licensee.
- 8.3 Licensee acknowledges that Motorola made a considerable investment of resources in the development, marketing, and distribution of the Software and Documentation and that Licensee's breach of this Agreement will result in irreparable harm to Motorola for which monetary damages would be inadequate. If Licensee breaches this Agreement, Motorola may terminate this Agreement and be entitled to all available remedies at law or in equity (including immediate injunctive relief and repossession of all non-embedded Software and associated Documentation unless Licensee is a Federal agency of the United States Government).

Section 9 Commercial Computer Software

- 9.1 U.S. GOVERNMENT END USERS. The Software, Documentation and updates are commercial items as that term is defined at 48 C.F.R. Part 2.101, consisting of "commercial computer software" and "computer software documentation" as such terms are defined in 48 C.F.R. Part 252.227-7014(a)(1) and 48 C.F.R. Part 252.227-7014(a)(5), and used in 48 C.F.R. Part 12.212 and 48 C.F.R. Part 227.7202, as applicable. Consistent with 48 C.F.R. Part 12.212, 48 C.F.R. Part 252.227-7015, 48 C.F.R. Part 227.7202-1 through 227.7202-4, 48 C.F.R. Part 52.227-19, and other relevant sections of the Code of Federal Regulations, as applicable, the Software, Documentation and Updates are distributed and licensed to U.S. Government end users: (i) only as commercial items, and (ii) with only those rights as are granted to all other end users pursuant to the terms and conditions contained herein.
- 9.2 If Licensee is licensing Software for end use by the United States Government or a United States Government agency, Licensee may transfer such Software license, but only if: (i) Licensee transfers all copies of such Software and Documentation to such United States Government entity or interim transferee, and (ii) Licensee has first obtained from the transferee (if applicable) and ultimate end user an enforceable end user license agreement containing restrictions substantially identical to the ones contained in this Agreement. Except as stated in the foregoing, Licensee and any transferee(s) authorized by this subsection 9.2 may not otherwise use or transfer or make available any Motorola software to any third party nor permit any party to do so.

Section 10 CONFIDENTIALITY

Licensee acknowledges that the Software and Documentation contain Motorola's valuable proprietary and Confidential Information and are Motorola's trade secrets, and that the provisions in the Primary

Agreement concerning Confidential Information apply. Motorola acknowledges Licensee is required to follow the Oklahoma Open Records Act (Title 51 Section 24.A.1, et seq.).

Section 11 LIMITATION OF LIABILITY

The Limitation of Liability provision is described in the Primary Agreement.

Section 12 NOTICES

Notices are described in the Primary Agreement.

Section 13 GENERAL

- 13.1. COPYRIGHT NOTICES. The existence of a copyright notice on the Software will not be construed as an admission or presumption of publication of the Software or public disclosure of any trade secrets associated with the Software.
- 13.2. COMPLIANCE WITH LAWS. Licensee acknowledges that the Software is subject to the laws and regulations of the United States and Licensee will comply with all applicable laws and regulations, including export laws and regulations of the United States. Licensee will not, without the prior authorization of Motorola and the appropriate governmental authority of the United States, in any form export or re-export, sell or resell, ship or reship, or divert, through direct or indirect means, any item or technical data or direct or indirect products sold or otherwise furnished to any person within any territory for which the United States Government or any of its agencies at the time of the action, requires an export license or other governmental approval. Violation of this provision is a material breach of this Agreement.
- 13.3. ASSIGNMENTS AND SUBCONTRACTING. Motorola may assign its rights or subcontract its obligations under this Agreement, or encumber or sell its rights in any Software, without prior notice to or consent of Licensee.
- 13.4. GOVERNING LAW. This Agreement is governed by the laws of the United States to the extent that they apply and otherwise by the internal substantive laws of the State to which the Software is shipped if Licensee is a sovereign government entity, or the internal substantive laws of the State of Illinois if Licensee is not a sovereign government entity. The terms of the U.N. Convention on Contracts for the International Sale of Goods do not apply. In the event that the Uniform Computer Information Transaction Act, any version of this Act, or a substantially similar law (collectively "UCITA") becomes applicable to a party's performance under this Agreement, UCITA does not govern any aspect of this Agreement or any license granted under this Agreement, or any of the parties' rights or obligations under this Agreement. The governing law will be that in effect prior to the applicability of UCITA.
- 13.5. THIRD PARTY BENEFICIARIES. This Agreement is entered into solely for the benefit of Motorola and Licensee. No third party has the right to make any claim or assert any right under this Agreement, and no third party is deemed a beneficiary of this Agreement. Notwithstanding the foregoing, any licensor or supplier of third party software included in the Software will be a direct and intended third party beneficiary of this Agreement.
- 13.6. SURVIVAL. Sections 4, 5, 6.3, 7, 8, 9, 10, 11 and 13 survive the termination of this Agreement.
- 13.7. ORDER OF PRECEDENCE. In the event of inconsistencies between this Exhibit and the Primary Agreement, the parties agree that this Exhibit prevails, only with respect to the specific subject matter of this Exhibit, and not the Primary Agreement or any other exhibit as it applies to any other subject matter.

13.8 SECURITY. Motorola uses reasonable means in the design and writing of its own Software and the acquisition of third party Software to limit Security Vulnerabilities. While no software can be guaranteed to be free from Security Vulnerabilities, if a Security Vulnerability is discovered, Motorola will take the steps set forth in Section 6 of this Agreement.

Additional Maintenance, Support, and Installation Terms

- 1. SERVICES. Maintenance, Support, and Installation Services to be provided by Motorola are further described in Exhibit E-1 (see Motorola's proposal dated September 5, 2017). Motorola will provide Maintenance and Support Services as further described in Section 4.2.2 of Motorola's proposal dated September 5, 2017 and is included in the Contract Price stated in Section 6 of the Primary Agreement.
- 2. PURCHASE ORDER ACCEPTANCE. Purchase orders for additional, continued, or expanded maintenance, software support, or installation services during the Warranty Period or after the Warranty Period, agreement become binding only when accepted in writing by Motorola.
- 3. START DATE. The "Start Date" for Maintenance, Support, and Installation Services will be upon Final Project Acceptance as stated in the Primary Agreement and continue for ten (10) years thereafter.
- 4. INTENTIONALLY OMITTED.
- 5. TERMINATION. Written notice of intent to terminate must be provided thirty (30) days or more prior to the anniversary date. If Motorola provides Services after the termination or expiration of this Agreement, the terms and conditions in effect at the time of the termination or expiration will apply to those Services and Customer agrees to pay for those services on a time and materials basis at Motorola's then effective hourly rates.
- 6. EQUIPMENT DEFINITION. For maintenance, support, and installation services, Equipment will be defined to mean the hardware specified in the applicable SOW or attachments to the maintenance, support, or installation proposal.
- 7. ADDITIONAL HARDWARE. If Customer purchases additional hardware from Motorola that becomes part of the System, the additional hardware may be added to this Agreement and will be billed at the applicable rates after the warranty period for that additional equipment expires. Such hardware will be included in the definition of Equipment.
- 8. MAINTENANCE. Equipment will be maintained at levels set forth in the manufacturer's product manuals and routine procedures that are prescribed by Motorola will be followed. Motorola parts or parts of equal quality will be used for Equipment maintenance.
- 9. EQUIPMENT CONDITION. All Equipment must be in good working order on the Start Date or when additional equipment is added to the Agreement. Upon reasonable request by Motorola, Customer will provide a complete serial and model number list of the Equipment. Customer must promptly notify Motorola in writing when any Equipment is lost, damaged, stolen or taken out of service. Customer's obligation to pay maintenance and support fees for this Equipment will terminate at the end of the month in which Motorola receives the written notice. If Equipment cannot, in Motorola's reasonable opinion, be properly or economically maintained for any reason, Motorola may modify the scope of Services related to that Equipment; remove that Equipment from the Agreement; or increase the price to maintain that Equipment.
- 10. EQUIPMENT FAILURE. Customer must promptly notify Motorola of any Equipment failure. Motorola will respond to Customer's notification in a manner consistent with the level of Service purchased as indicated in this Agreement and applicable SOW.
- 11. INTRINSICALLY SAFE. Customer must specifically identify any Equipment that is labeled intrinsically safe for use in hazardous environments.
- 12. EXCLUDED SERVICES.

- a) Service excludes the repair or replacement of Equipment that has become defective or damaged from use in other than the normal, customary, intended, and authorized manner; use not in compliance with applicable industry standards; excessive wear and tear; or accident, liquids, power surges, neglect, acts of God or other force majeure events.
- b) Unless specifically included in this Agreement, Service excludes items that are consumed in the normal operation of the Equipment, such as batteries or magnetic tapes.; upgrading or reprogramming Equipment; accessories, belt clips, battery chargers, custom or special products, modified units, or software; and repair or maintenance of any transmission line, antenna, microwave equipment, tower or tower lighting, duplexer, combiner, or multicoupler. Motorola has no obligations for any transmission medium, such as telephone lines, computer networks, the internet or the worldwide web, or for Equipment malfunction caused by the transmission medium.
- 13. TIME AND PLACE. Service will be provided at the location specified in this Agreement or the SOW. When Motorola performs maintenance, support, or installation at Customer's location, Customer will provide Motorola, at no charge, a non-hazardous work environment with adequate shelter, heat, light, and power and with full and free access to the Equipment. Waivers of liability from Motorola or its subcontractors will not be imposed as a site access requirement. Customer will provide all information pertaining to the hardware and software elements of any system with which the Equipment is interfacing so that Motorola may perform its Services. Unless otherwise stated in this Agreement or applicable SOW, the hours of Service will be 8:30 a.m. to 4:30 p.m., local time, excluding weekends and holidays. Unless otherwise stated in this Agreement or applicable SOW, the price for the Services exclude any charges or expenses associated with helicopter or other unusual access requirements; if these charges or expenses are reasonably incurred by Motorola in rendering the Services, Customer agrees to reimburse Motorola for those charges and expenses.
- 14. CUSTOMER CONTACT. Customer will provide Motorola with designated points of contact (list of names and phone numbers) that will be available twenty-four (24) hours per day, seven (7) days per week, and an escalation procedure to enable Customer's personnel to maintain contact, as needed, with Motorola.

A CONTRACT BETWEEN HOUSTON-GALVESTON AREA COUNCIL

Houston, Texas AND

MOTOROLA SOLUTIONS, INC.

Farmers Branch, Texas

This Contract is made and entered into by the Houston-Galveston Area Council of Governments, hereinafter referred to as H-GAC, having its principal place of business at 3555 Timmons Lane, Suite 120, Houston, Texas 77027, AND, Motorola Solutions, Inc. hereinafter referred to as the CONTRACTOR, having its principal place of business at Park West C-2, 1507 LBJ Freeway, Farmers Branch, Texas 75234.

ARTICLE 1: SCOPE OF SERVICES

The parties have entered into a Radio Communication/Emergency Response & Mobile Interoperability Equipment Contract to become effective as of May 1, 2015, and to continue through April 30, 2018 (the "Contract"), subject to extension upon mutual agreement of the CONTRACTOR and H-GAC. H-GAC enters into the Contract as Agent for participating governmental agencies, each hereinafter referred to as END USER, for the purchase of Radio Communication/Emergency Response & Mobile Interoperability Equipment offered by the CONTRACTOR. The CONTRACTOR agrees to sell Radio Communication/Emergency Response & Mobile Interoperability Equipment through the H-GAC Contract to END USERS.

ARTICLE 2:

THE COMPLETE AGREEMENT

The Contract shall consist of the documents identified below in order of precedence:

- 1. The text of this Contract form, including but not limited to, Attachment A
- 2 General Terms and Conditions
- 3. Proposal Specifications No: RA05-15, including any relevant suffixes
- 4. CONTRACTOR's Response to Proposal No: RA05-15, including but not limited to, prices and options offered

All of which are either attached hereto or incorporated by reference and hereby made a part of this Contract, and shall constitute the complete agreement between the parties hereto. This Contract supersedes any and all oral or written agreements between the parties relating to matters herein. Except as otherwise provided herein, this Contract cannot be modified without the written consent of both parties,

ARTICLE 3:

LEGAL AUTHORITY

CONTRACTOR and H-GAC warrant and represent to each other that they have adequate legal counsel and authority to enter into this Contract. The governing bodies, where applicable, have authorized the signatory officials to enter into this Contract and bind the parties to the terms of this Contract and any subsequent amendments thereto.

ARTICLE 4:

APPLICABLE LAWS

The parties agree to conduct all activities under this Contract in accordance with all applicable rules, regulations, directives, issuances, ordinances, and laws in effect or promulgated during the term of this Contract.

ARTICLE 5:

INDEPENDENT CONTRACTOR

The execution of this Contract and the rendering of services prescribed by this Contract do not change the independent status of H-GAC or CONTRACTOR. No provision of this Contract or act of H-GAC in performance of this Contract shall be construed as making CONTRACTOR the agent, servant or employee of H-GAC, the State of Texas or the United States Government. Employees of CONTRACTOR are subject to the exclusive control and supervision of CONTRACTOR. CONTRACTOR is solely responsible for employee payrolls and claims arising therefrom.

ARTICLE 6:

END USER AGREEMENTS

H-GAC acknowledges that the END USER may choose to enter into an End User Agreement with the CONTRACTOR through this Contract and that the term of said Agreement may exceed the term of the H-GAC Contract. However this acknowledgement is not to be construed as H-GAC's endorsement or approval of the End User Agreement terms and conditions. CONTRACTOR agrees not to offer to, agree to or accept from END USER any terms or conditions that conflict with or contravene those in CONTRACTOR's H-GAC contract. Further, termination of this Contract for any reason shall not result in the termination of the underlying End User Agreements entered into between CONTRACTOR and any END USER which shall, in each instance, continue pursuant to their stated terms and duration. The only effect of termination of this Contract is that CONTRACTOR will no longer be able to enter into any new End User Agreements with END USERS pursuant to this Contract. Applicable H-GAC order processing charges will be due and payable to H-GAC on any End User

Agreements surviving termination of this Contract between H-GAC and CONTRACTOR.

ARTICLE 7: SUBCONTRACTS & ASSIGNMENTS

CONTRACTOR agrees not to subcontract, assign, transfer, convey, sublet or otherwise dispose of this Contract or any right, title, obligation or interest it may have therein to any third party without prior written notice to H-GAC. H-GAC reserves the right to accept or reject any such change. CONTRACTOR shall continue to remain responsible for all performance under this Contract regardless of any subcontract or assignment. H-GAC shall be liable solely to CONTRACTOR and not to any of its Subcontractors or Assignees.

ARTICLE 8: EXAMINATION AND RETENTION OF CONTRACTOR'S RECORDS

CONTRACTOR shall maintain during the course of its work, complete and accurate records of items that are chargeable to END USER under this Contract. H-GAC, through its staff or its designated public accounting firm, the State of Texas, or the United States Government shall have the right at any reasonable time to inspect copy and audit those records on or off the premises of CONTRACTOR. Failure to provide access to records may be cause for termination of this Contract. CONTRACTOR shall maintain all records pertinent to this Contract for a period of not less than five (5) calendar years from the date of acceptance of the final contract closeout and until any outstanding litigation, audit or claim has been resolved. The right of access to records is not limited to the required retention period, but shall last as long as the records are retained. CONTRACTOR further agrees to include in all subcontracts under this Contract, a provision to the effect that the subcontractor agrees that H-GAC'S duly authorized representatives, shall, until the expiration of five (5) calendar years after final payment under the subcontract or until all audit findings have been resolved, have access to, and the right to examine and copy any directly pertinent books, documents, papers, invoices and records of such subcontractor involving any transaction relating to the subcontract. To the extent allowed by law, nothing contained herein shall authorize H-GAC and/or END USER to audit confidential information regarding product cost.

ARTICLE 9: REPORTING REQUIREMENTS

CONTRACTOR agrees to submit reports or other documentation in accordance with the General Terms and Conditions of the Proposal Specifications. If CONTRACTOR fails to submit to H-GAC in a timely and satisfactory manner any such report or documentation, or otherwise fails to satisfactorily render performance hereunder, such failure may be considered cause for termination of this Contract.

ARTICLE 10: MOST FAVORED CUSTOMER CLAUSE

If CONTRACTOR at any time during a contract period, routinely enters into agreements with other governmental customers within the State of Texas, and offers the same or substantially the same products offered to H-GAC on a basis that provides prices more favorable than those provided to H-GAC, CONTRACTOR shall within ten (10) business days thereafter notify H-GAC of that offering. The contract with H-GAC shall be deemed to be automatically amended and effective retroactively to the effective date of the most favorable contract, wherein CONTRACTOR shall provide the same quantity discount to II-GAC and its End Users for equal or larger orders purchased the same quantity and under the same circumstances. H-GAC shall have the right and option at any time to decline to accept any such change, in which case the amendment shall be deemed null and void. If CONTRACTOR believes any apparently more favorable price charged and/or offered a customer during the term of this agreement is not in fact most favored treatment, CONTRACTOR shall within ten (10) business days notify H-GAC in writing, setting forth the detailed reasons CONTRACTOR believes aforesaid offer which has been deemed to be a most favored treatment, is not in fact most favored treatment. H-GAC, after due consideration of such written explanation, may decline to accept such explanation and thereupon the contract between H-GAC and CONTRACTOR shall be automatically amended, effective retroactively, to the effective date of the most favored agreement, to provide the same prices to H-GAC.

The most favored price structure set forth in this paragraph shall not apply to any pre-existing contracts Contractor has in the State of Texas. The term "pre-existing contracts" shall refer to contracts in existence as of the original effective date of the HGAC contract, i.e. 5/1/15.

The Parties agree that the above MFC provision shall not apply to the sale of large communications systems (one million dollars (\$1,000,000.00) and above). The term "Communications System" shall refer to a project that includes the sale of infrastructure hardware and/or software, user devices, and Motorola engineering and installation service. The contract for a "Communication System" will always have a Statement of Work and an Acceptance Test Plan.

The Parties accept the following definition of routine. A prescribed, detailed course of action to be followed regularly; a standard procedure.

ARTICLE 11: SEVERABILITY

All parties agree that should any provision of this Contract be determined to be invalid or unenforceable, such determination shall not affect any other term of this Contract, which shall continue in full force and effect

ARTICLE 12:

DISPUTES

Any and all disputes concerning questions of fact or of law arising under this Contract, which are not disposed of by agreement, shall be decided by the Executive Director of H-GAC or his designee, who shall reduce his decision to writing and provide notice thereof to CONTRACTOR. The decision of the Executive Director or his designee shall be final and conclusive unless, within thirty (30) days from the date of receipt of such notice, CONTRACTOR requests a rehearing from the Executive Director of H-GAC. In connection with any rehearing under this Article, CONTRACTOR shall be afforded an opportunity to be heard and offer evidence in support of its position. The decision of the Executive Director after any such rehearing shall be final and conclusive. CONTRACTOR may, if it elects to do so, appeal the final and conclusive decision of the Executive Director to a court of competent jurisdiction. Pending final decision of a dispute hereunder, CONTRACTOR shall proceed diligently with the performance of this Contract and in accordance with H-GAC'S final decision.

ARTICLE 13: LIMITATION OF CONTRACTOR'S LIABILITY

Except as specified in any separate writing between the CONTRACTOR and an END USER, CONTRACTOR's total liability under this Contract, whether for breach of contract, warranty, negligence, strict liability, in tort or otherwise, but excluding its obligation to indemnify H-GAC described in Article 14, is limited to the price of the particular products/services sold hereunder, and CONTRACTOR agrees either to refund the purchase price or to repair or replace product(s) that are not as warranted. In no event will CONTRACTOR be liable for any loss of use, loss of time, inconvenience, commercial loss, lost profits or savings or other incidental, special or consequential damages to the full extent such use may be disclaimed by law. CONTRACTOR understands and agrees that it shall be liable to repay and shall repay upon demand to END USER any amounts determined by H-GAC, its independent auditors, or any agency of State or Federal government to have been paid in violation of the terms of this Contract.

ARTICLE 14: LIMIT OF H-GAC'S LIABILITY AND INDEMNIFICATION OF H-GAC

H-GAC's liability under this Contract, whether for breach of contract, warranty, negligence, strict liability, in tort or otherwise, is limited to its order processing charge. In no event will H-GAC be liable for any loss of use, loss of time, inconvenience, commercial loss, lost profits or savings or other incidental, special or consequential damages to the full extent such use may be disclaimed by law. Contractor agrees, to the extent permitted by law, to defend and hold harmless H-GAC, its board members, officers, agents, officials, employees, and indemnities from any and all claims, costs, expenses (including reasonable attorney fees), actions, causes of action, judgments, and liens arising as a result of CONTRACTOR's negligent act or omission under this Contract. CONTRACTOR shall notify H-GAC of the threat of lawsuit or of any actual suit filed against CONTRACTOR relating to this Contract.

ARTICLE 15: TERMINATION FOR CAUSE

H-GAC may terminate this Contract for cause based upon the failure of CONTRACTOR to comply with the terms and/or conditions of the Contract; provided that H-GAC shall give CONTRACTOR written notice specifying CONTRACTOR'S failure. If within thirty (30) days after receipt of such notice, CONTRACTOR shall not have either corrected such failure, or thereafter proceeded diligently to complete such correction, then H-GAC may, at its option, place CONTRACTOR in default and the Contract shall terminate on the date specified in such notice. CONTRACTOR shall pay to H-GAC any order processing charges due from CONTRACTOR on that portion of the Contract actually performed by CONTRACTOR and for which compensation was received by CONTRACTOR.

ARTICLE 16: TERMINATION FOR CONVENIENCE

Either H-GAC or CONTRACTOR may cancel or terminate this Contract at any time by giving thirty (30) days written notice to the other. CONTRACTOR may be entitled to payment from END USER for services actually performed; to the extent said services are satisfactory to END USER. CONTRACTOR shall pay to H-GAC any order processing charges due from CONTRACTOR on that portion of the Contract actually performed by CONTRACTOR and for which compensation is received by CONTRACTOR.

ARTICLE 17: CIVIL AND CRIMINAL PROVISIONS AND SANCTIONS

CONTRACTOR agrees that it will perform under this Contract in conformance with safeguards against fraud and abuse as set forth by H-GAC, the State of Texas, and the acts and regulations of any funding entity. CONTRACTOR agrees to notify H-GAC of any suspected fraud, abuse or other criminal activity related to this Contract through filing of a written report promptly after it becomes aware of such activity.

ARTICLE 18: GOVERNING LAW & VENUE

This Contract shall be governed by the laws of the State of Texas. Venue and jurisdiction of any suit or cause of action arising under or in connection with this Contract shall lie exclusively in Harris County, Texas. Disputes between END USER and CONTRACTOR are to be resolved in accord with the law and venue rules of the state of purchase. CONTRACTOR shall immediately notify H-GAC of such disputes.

ARTICLE 19: PROCEDURAL STEPS ENUMERATED FOR SALES TO END USERS

- All Cooperative Purchasing business will be processed in accordance with H-GAC's policies and procedures, at contracted prices, and shall include approved order processing charges.
- 2. END USER will access the Cooperative Purchasing Program through the H-GAC website and /or by submission of any duly

executed purchase order to a contractor having a valid contract with H-GAC and in a format acceptable to H-GAC.

- 3. **END USER** will submit order(s) electronically through **CONTRACTOR'S** on-line ordering process or issue Purchase Order(s) directly to **CONTRACTOR** at contract prices, and also submit a copy to **H-GAC**.
- 4. The H-GAC CONTRACTOR will deliver products/services as specified by the contract between CONTRACTOR and H-GAC, and invoice each END USER for (1) products/services purchased and (2) H-GAC'S applicable order processing charge.
- 5. Upon delivery, acceptance, and receipt of an H-GAC CONTRACTOR's, documented invoice, END USER shall pay the H-GAC CONTRACTOR the full amount of the invoice.
- 6. For orders of less than \$100,000, CONTRACTOR will promptly pay to H-GAC any order processing charges due, and in Any case, not later than sixty (60) calendar days after End User order is processed. Payments will be processed to H-GAC on a monthly basis. For orders of \$100,000 or more, CONTRACTOR will promptly pay to H-GAC any order processing charges due, and in any case not later than forty-five (45) calendar days after receipt of End User payment by Motorola.
- Failure to promptly remit H-GAC's order processing charges may result in sanctions including, but not limited to, contract termination
- CONTRACTOR shall be responsible for delivery and acceptance of each unit by END USER, according to the requirements of
 the specifications, this Contract, and purchase order issued to CONTRACTOR by an END USER. All required equipment tests
 shall be borne by CONTRACTOR.
- CONTRACTOR shall promptly provide H-GAC and END USER with all information pertaining to delivery schedules.
 CONTRACTOR shall also use its best efforts to expedite unit deliveries on shorter notice than set forth in its verification for any specific purchase order when requested.
- 10. All prices are F.O.B. END USER'S location with all transportation charges prepaid and included in any invoice,
- 11. All pricing shall be based on the current contract unless the **H-GAC CONTRACTOR** prior to receipt of **END USER**'s purchase order for delivery of any products/services has received **H-GAC's** prior written approval for any price increases.
- 12. The H-GAC CONTRACTOR agrees to accept the terms of this agreement and to conduct all transactions based on pricing and other terms of the contract including, but not limited to, the applicable H-GAC order processing charge. The CONTRACTOR agrees to encourage END USERS to execute authorizing Interlocal contracts with H-GAC.

ARTICLE 20: LIQUIDATED DAMAGES

Any liquidated damages terms will be determined between CONTRACTOR and END USER at the time END USER's purchase order is placed.

ARTICLE 21: PERFORMANCE BONDS FOR INDIVIDUAL ORDERS

Except as described below for fire apparatus, CONTRACTOR agrees to provide a Performance Bond at the request of END USER within ten (10) days of receipt of END USER's purchase order.

It shall be standard procedure for every order received for fire apparatus that a Performance Bond in the amount of the order be provided to the END USER. Failure of CONTRACTOR to provide such performance bond within ten (10) days of receipt of END USER's order may constitute a total breach of contract and shall be cause for cancellation of the order at END USER's sole discretion. END USER may choose to delete the requirement for a Performance Bond at END USER's sole discretion. If the bond requirement is waived, END USER shall be entitled to a price reduction commensurate with the cost that would have been incurred by CONTRACTOR for the bond.

ARTICLE 22: CHANGE OF CONTRACTOR STATUS

CONTRACTOR shall immediately notify H-GAC, in writing, of ANY change in ownership, control, dealership/franchisee status, Motor Vehicle license status, or name, and shall also advise whether or not this Contract shall be affected in any way by such change. H-GAC shall have the right to determine whether or not such change is acceptable, and to determine what action shall be warranted, up to and including cancellation of Contract.

ARTICLE 23: LICENSING REQUIRED BY TEXAS MOTOR VEHICLE BOARD [IF APPLICABLE]

CONTRACTOR will for the duration of this Contract maintain current licenses that are required by the Texas Motor Vehicle Commission Code. If at any time during this Contract period, any CONTRACTOR'S license is not renewed, or is denied or revoked, CONTRACTOR shall be deemed to be in default of this Contract unless the Motor Vehicle Board issues a stay or waiver. Contractor shall promptly provide copies of all current applicable Texas Motor Vehicle Board documentation to H-GAC upon request.

MASTER SERVICES AGREEMENT

THIS MASTER SERVICES AGREEMENT (the "Agreement") is made and entered into by and between the City of Enid, Oklahoma, Oklahoma Municipal Corporation ("Customer"), and Southwestern Bell Telephone Company d/b/a AT&T OKLAHOMA ("AT&T OKLAHOMA") ("the parties").

INTRODUCTION

The parties hereby agree to amend the original Service Agreement for Universal Emergency Number Service (E9-1-1) agreement entered into by the parties on or about November 3, 2010

The parties further agree that the following terms and conditions will govern AT&T OKLAHOMA's offering and Customer's purchase of certain E9-1-1 service, database management and network transport Services (collectively, the "Services") for use by Customer to provide Enhanced 9-1-1 service to telecommunications users in Garfield County, Oklahoma.

I. DESCRIPTION OF SERVICES, PRICING AND ADDENDA

AT&T OKLAHOMA agrees to provide Services as described herein and in executed Addenda attached hereto beginning at the time of execution of this Agreement unless otherwise agreed to by the parties. Whenever Customer desires AT&T OKLAHOMA to perform Services, Customer will request AT&T OKLAHOMA to prepare an Addendum describing the Services to be performed and the price for the Services. Each Addendum will reference and incorporate the terms of this Agreement. The Services specified in a particular Addendum together with the terms, conditions and prices at which said Services are to be performed are collectively referred to as the "Addendum".

If the terms set forth in an Addendum are acceptable, Customer will execute and return the Addendum to AT&T OKLAHOMA. Each Addendum will be completed pursuant to the terms of the applicable Addendum executed by the parties and the terms and conditions of this Agreement. If AT&T OKLAHOMA does not receive Customer's written acceptance of an Addendum within ten (10) days of Customer's receipt, the Addendum will be deemed rejected.

II. COMPENSATION

AT&T OKLAHOMA will bill Customer for Services performed in accordance with the price(s) stated on the applicable Addendum on a monthly basis, in advance, or as stated in the applicable Addendum, if different. AT&T OKLAHOMA reserves the right to invoice incrementally, as predefined phases of the Addendum are completed. Payment terms are net thirty (30) days from date of invoice following installation.

III. INTERRUPTED OPERATION

Customer understands and agrees that AT&T OKLAHOMA does not guarantee uninterrupted operation of the Services sold hereunder. Suspension of operation of either E911 system may become necessary during maintenance of the Services.

IV. ERRANT SERVICE REQUEST

If within a 30 day period AT&T OKLAHOMA responds to a second request for Customer for service related to a problem(s) that does not involve the Services covered by this Agreement, AT&T OKLAHOMA will invoice Customer for a service call at AT&T OKLAHOMA's then prevailing standard rate and Customer agrees to pay such invoice within thirty (30) days of receipt. AT&T OKLAHOMA will not attempt to correct any problem that does not involve the Services provided pursuant to this Agreement.

V. TERMINATION OF AN ADDENDUM; SUSPENSION OF SERVICES

- A. No Addendum may be terminated, suspended or canceled except as expressly permitted by this Agreement. Notwithstanding any other term or provision in this Agreement or in any Addendum to the contrary, either party may, at its election and upon written notice, terminate, suspend or cancel any Addendum or this Agreement without any further liability or obligation to the other party in the event that:

 By way of clarification, the Early Termination Charge described in Paragraph V.B. of the Agreement does not apply and will not be assessed if Customer terminates the Agreement under Paragraph V.A. or V.C of the Agreement; rather, the Early Termination Charge applies only if Customer terminates outside of V.A. or V.C."
 - 1. The other party is in material breach of or default under such Addendum, and such breach or default continues for a period of

- thirty (30) days after the giving of written notice by the party not in breach or default; or
- 2. Any federal, state or local governmental agency or regulatory body or a court or tribunal of competent jurisdiction renders or enters an Addendum, ruling, regulation, directive, decree or judgment which restricts or prohibits either party from continuing, impairs either party's ability to continue, or makes impractical or unduly expensive either party's continuance under such Addendum or this Agreement.
- B. Upon termination, Customer agrees to pay AT&T OKLAHOMA all amounts due for Services provided by AT&T OKLAHOMA up to and including the effective date of termination. Termination shall constitute a full and complete discharge of AT&T OKLAHOMA's obligations. Any Addendum in progress or requested prior to the termination of this Agreement will be completed and Customer agrees to reimburse AT&T OKLAHOMA for the Services performed and/or any material ordered by it. Customer acknowledges, however, that determining the precise damages that AT&T OKLAHOMA will incur due to Customer's early termination will be difficult and uncertain. Accordingly, Customer also agrees to pay AT&T OKLAHOMA an Early Termination Charge to compensate AT&T OKLAHOMA for the damages caused by Customer's Said termination charge shall be paid prior to the early termination. expiration of this Agreement. Unless the Addendum applicable to the terminated Service states otherwise, the Early Termination Charge that Customer shall pay shall be equal to Fifty Percent (50%) of the amount derived by multiplying the billed monthly price for the disconnected service by the months remaining in the Term of the Addendum hereto under which the terminated Service(s) have been provided. The Parties agree that the resulting amount reasonably approximates the value of the damages AT&T OKLAHOMA would incur in the event of Customer's early termination. By way of clarification, the Early Termination Charge described in Paragraph V.B. of the Agreement does not apply and will not be assessed if Customer terminates the Agreement under Paragraph V.A. or V.C of the Agreement; rather, the Early Termination Charge applies only if Customer terminates outside of V.A. or V.C."
- C. Either party may terminate a Service, an entire Addendum and, if all Addenda are affected, this Agreement, upon thirty (30) day written notice setting forth the reason(s) for termination, if: (1) A regulatory agency requires any material modification of this Agreement or any Addendum which has a material negative effect on Customer; or (2) the other party fails to perform or observe any material term or condition of this Agreement and such failure is not remedied within thirty (30) business days following the breaching

party's receipt of notice or ten (10) days in the event of Customer's non-payment for the Services. Provided, however, if the alleged breach is of a type that cannot reasonably be remedied within thirty (30) business days, and AT&T OKLAHOMA starts work on a remedy within thirty (30) days, Customer cannot terminate for breach until and unless AT&T OKLAHOMA is unable to remedy the breach, and then shall give first a new thirty days' notice of its intent to terminate.

D. Notwithstanding the foregoing, AT&T OKLAHOMA reserves the right to terminate this Agreement or any Addendum hereto for convenience upon one hundred & twenty days notice of its intent to do so, provided, however, that such termination for convenience may be made effective only on any annual anniversary date of the execution of this Agreement.

VI. DISCLAIMER OF WARRANTIES AND LIMITATION OF LIABILITIES

- A. AT&T OKLAHOMA DOES NOT WARRANT THAT THE SERVICES WILL OPERATE UNINTERRUPTED OR ERROR FREE OR PREVENT THIRD PARTY ACCESS TO CUSTOMER'S NETWORKS. EXCEPT FOR ANY EXPRESS WARRANTIES SET FORTH IN ANY ADDENDUM, THE SERVICES ARE PROVIDED "AS IS" AND WITHOUT WARRANTY OF ANY KIND.
- B. AT&T OKLAHOMA HEREBY DISCLAIMS ALL IMPLIED WARRANTIES, OBLIGATIONS OR LIABILITIES, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, WITH RESPECT TO THE SERVICES PROVIDED HEREUNDER. IN NO EVENT SHALL AT&T OKLAHOMA BE LIABLE FOR ANY LOST PROFITS, SPECIAL, INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES, WHETHER FOR BREACH OF ANY EXPRESS OR IMPLIED WARRANTIES OR OTHERWISE, INCLUDING DAMAGE TO PROPERTY AND, TO THE EXTENT PERMITTED BY LAW, DAMAGES FOR PERSONAL INJURY.
- C. AT&T OKLAHOMA SHALL NOT BE LIABLE FOR ANY INDIRECT OR CONSEQUENTIAL DAMAGES, INCLUDING ANY LOST PROFITS, LOSS OF BUSINESS INCOME OR REVENUES OR DAMAGES FOR PERSONAL INJURY OR PROPERTY DAMAGE RELATED TO OR ALLEGED TO HAVE BEEN CAUSED BY THE ACTS OR OMISSIONS OF AT&T OKLAHOMA IN PROVIDING THE SERVICES HEREUNDER. IN NO EVENT WILL AT&T OKLAHOMA'S LIABILITY FOR DAMAGES CAUSED BY OR ARISING OUT OF ITS FAILURE TO PERFORM SERVICES IN A PROPER AND TIMELY MANNER EXCEED THE AMOUNT PAID BY

CUSTOMER TO AT&T OKLAHOMA FOR SUCH MATERIAL AND SERVICES.

- D. IN NO EVENT SHALL AT&T OKLAHOMA BE LIABLE FOR LOST PROFITS, TOLL FRAUD, LOSS OF USE, SPECIAL, INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES, FOR BREACH OF ANY EXPRESS OR IMPLIED WARRANTIES, OR OTHERWISE, IN CONNECTION WITH SUCH EQUIPMENT OR SERVICES, EVEN WHEN AT&T OKLAHOMA HAS BEEN GROSSLY NEGLIGENT OR ENGAGED IN WILLFUL MISCONDUCT.
- E. CUSTOMER'S SOLE AND EXCLUSIVE REMEDIES AGAINST AT&T OKLAHOMA, ITS AFFILIATES, AND THEIR DIRECTORS, OFFICERS AND EMPLOYEES FOR ANY LOSSES OR DAMAGES ARISING FROM ANY EQUIPMENT, SOFTWARE OR SERVICES PROVIDED BY AT&T OKLAHOMA, WHETHER IN CONTRACT OR IN TORT, SHALL BE LIMITED TO REPAIR OR REPLACEMENT OF THE SERVICES. IN ANY EVENT, AT&T OKLAHOMA'S LIABILITY SHALL BE LIMITED TO THE AMOUNT SPECIFIED IN THE TARIFF OR THE AMOUNT PAID TO AT&T OKLAHOMA BY CUSTOMER UNDER THE APPLICABLE ADDENDUM AND SHALL NOT ENCOMPASS ANY DAMAGES DUE TO CAUSES BEYOND THE REASONABLE CONTROL OF AT&T OKLAHOMA OR ATTRIBUTABLE TO ANY SERVICE, PRODUCTS, OR ACTIONS OF ANY PERSON OTHER THAN AT&T OKLAHOMA, REGARDLESS OF THE FORM OF ACTION.
 - Customer understands and agrees that AT&T OKLAHOMA's price reflects this limitation of liability and that this disclaimer is reasonable in all respects.

 - b) Repair of damages caused by misuse or neglect.

 - d) Repair of damage caused by accident and/or disaster, including but not limited to fire, flood, wind, lightning or water.
 - e) Repair of damage caused by the attachment of mechanical, electrical or electronic material or devices to the system that is not supplied by AT&T OKLAHOMA.

- f) Repairs which are impractical for AT&T OKLAHOMA to render because of alterations in or attachments to the system.
- **F.** Upon Customer's request and at AT&T OKLAHOMA's option, AT&T OKLAHOMA will provide any of the foregoing Services at its then prevailing standard service rate therefore.

VII. NOTICES

Any notice or demand which under the terms of this Agreement or otherwise must or may be given or made by AT&T OKLAHOMA or Customer will be in writing and given or made by facsimile or similar communication or by certified or registered mail, return receipt requested, addressed to the respective parties as shown:

Such notice or demand will be deemed to be given or made when sent, if sent by facsimile or similar communication, or when deposited, postage prepaid, in the U.S. mail. The above addresses may be changed at any time by giving thirty (30) days' prior written notice as above provided.

VIII. TERM OF AGREEMENT

This Agreement will become effective after execution by both parties and remain in full force and effect for a sixty (60) month period or until terminated by either

party upon thirty (30) days' prior written notice. If federal or state law prohibits Customer from executing any agreement for more than a one (1) year term, then the term of this agreement shall be deemed to be one (1) year and shall be renewable each year for the term of this contract, after the expiration of the initial twelve (12) month term.

IX. ADDENDUM TAKES PRECEDENCE OVER AGREEMENT

Any term in an Addendum that directly conflicts with this Agreement will be deemed to control with respect to Services provided pursuant to that Addendum.

X. ASSIGNMENT

Neither party may assign or transfer its rights or obligations under this Agreement except with the prior written consent of the other party, which consent will not be unreasonably withheld. Notwithstanding the foregoing, both parties will have the right to assign this Agreement to any present or future affiliate, subsidiary or parent corporation without securing consent, and may grant to any such assignee the same rights and privileges party enjoys under this Agreement. In addition, AT&T OKLAHOMA may subcontract any portion of the Services to be performed without the prior written approval of Customer.

XI. CHOICE OF LAW

This Agreement will be governed by and construed in accordance with the laws of Oklahoma and venue shall be established for all disputes as District Court of Garfield County,. This Agreement is subject to the laws of Oklahoma pertaining to public indebtedness. In the event that it is determined by an administrative agency or court of law that this Agreement violates any laws, ordinances or regulations, SWBT shall have the option of terminating this Agreement with no further obligation to Customer.

XII. CONFLICT OF INTEREST

Each party represents and warrants that no officer, director, employee or agent of the other party has been or will be employed, retained, paid a fee or otherwise has received or will receive, directly or indirectly, any personal compensation, "kickback" or any other consideration outside the specific terms of this Agreement in connection with or in contemplation of this Agreement or any future Addendum.

XIII. CURE

AT&T OKLAHOMA will not be deemed to be in default under any term of this Agreement or any Addendum executed pursuant to this Agreement, and Customer will not seek or be entitled to enforce any remedy for any claimed default, unless AT&T OKLAHOMA fails to cure or correct same within thirty (30) days following receipt of written notice from Customer.

XIV. FORCE MAJEURE

AT&T OKLAHOMA will not be liable for any delay or failure to perform Services due to circumstances beyond its reasonable control including, by way of illustration only and not limitation, labor strikes, natural catastrophes, civil disturbances, weather, material shortages, government regulations, fire, explosion, lightning, earthquake, power surges or failures, labor disputes, floods, storms, tornadoes, acts of God, war, civil disturbances, acts of civil or military authorities or the public enemy, delays caused by the other party equipment vendors or other similar causes. AT&T OKLAHOMA will be excused from performance during the period of such interference, provided that it uses reasonable efforts to avoid or remove such causes of nonperformance.

XV. INDEPENDENT CONTRACTOR

Neither AT&T OKLAHOMA nor its employees, agents or representatives are employees, servants, partners or joint ventures of or with Customer. AT&T OKLAHOMA is an independent contractor and will at all times direct, control and supervise all of its employees, agents and representatives and their respective activities.

XVI. LABOR AND MATERIAL

AT&T OKLAHOMA will furnish all supervision, labor, tools, transportation, material and supplies specified in an Addendum except any items specifically listed in the Addendum and/or this Agreement as being furnished by Customer or others.

XVII. MODIFICATION TO CONFORM TO LAWS

A. This Agreement and all obligations under will be subject to all applicable laws, rules and regulations (collectively, "Laws") including, by way of illustration and not limitation, the 1996 Federal Telecommunications Act. In the event this Agreement, or any of its provisions, Addenda or the operations contemplated hereunder, are

found to be inconsistent with or contrary to any Laws, the latter will be deemed to control and, if commercially practicable, this Agreement will be regarded as modified accordingly and will continue in full force and effect as so modified.

B. If such modified Agreement is not commercially practicable, in the opinion of either party, then the parties agree to meet promptly and discuss any necessary amendments or modifications to this Agreement. If the parties are unable to agree on necessary amendments or modifications in Addendum to comply with any Laws, then this Agreement may be terminated immediately by either party. In the event of such termination, Customer will pay AT&T OKLAHOMA all amounts due for Services provided by AT&T OKLAHOMA under this Agreement up to and including the effective date of termination.

XVIII. NON-WAIVER

No course of dealing or failure of either party to enforce strictly any term, right or condition of this Agreement will be construed as a waiver of such term, right or condition.

XIX. RELEASES VOID

Customer will not require any waivers or releases of any personal rights from employees or representatives of AT&T OKLAHOMA in connection with the presence of such employees or representatives on Customer's PREMISES, and no such releases or waivers will be pleaded by Customer or third persons in any action or proceeding.

XX. RISK OF LOSS OR DAMAGE

Customer agrees to protect any items furnished by AT&T OKLAHOMA to Customer in connection with this Agreement, including all Addenda, and bear the risk of loss, theft or damage thereto while such items and/or other items are on Customer's premises until the Services are completed.

XXI. SEVERABILITY

A. If any of the provisions of this Agreement are determined, or AT&T OKLAHOMA in good faith at its sole discretion believes them, to be invalid or unenforceable, Such invalidity or unenforceability will not invalidate or render unenforceable the entire Agreement. The Agreement then will be construed as if it did not contain the particular

invalid or unenforceable provision(s), and the rights and obligations of AT&T OKLAHOMA and Customer will be construed and enforced accordingly, unless, in the sole discretion of AT&T OKLAHOMA, the undertaking becomes commercially unreasonable.

- B. If such modified Agreement is not commercially practicable, in the opinion of AT&T OKLAHOMA, then the parties agree to meet promptly to discuss any necessary amendments or modifications to this Agreement. If the parties are unable to agree on necessary amendments or modifications, then either party may immediately terminate this Agreement, in which event Customer must pay AT&T OKLAHOMA all amounts due for Services provided by AT&T OKLAHOMA up to and including the effective date of termination.
- C. If approval of this Agreement by any regulatory agency is required and not obtained, then this Agreement to the extent not approved will immediately terminate.

XXII. SURVIVAL

Any obligation arising under this Agreement or any Addendum which by its nature will continue beyond the termination, cancellation or expiration hereof, including by way of illustration only and not limitation, those clauses entitled "LIMITATION OF LIABILITY", "SEVERABILITY", and "CONFIDENTIALITY" will survive the termination, cancellation or expiration of this Agreement.

XXIII. CONFIDENTIALITY

- A. **Confidential Information**. Confidential Information means: (a) information the parties share with each other in connection with this Agreement or in anticipation of providing Services under this Agreement, but only to the extent identified as Confidential Information in writing; and (b) except as may be required by applicable law or regulation, the terms of this Agreement and any pricing or other proposals.
- B. **Obligations**. Each party's Confidential Information will, for a period of 3 years following its disclosure to the other party (except in the case of software, which is indefinite): (a) be held in confidence; (b) be used and transmitted only for purposes of using the Services or performing this Agreement (including in the case of AT&T, the ability to utilize Customer's Confidential Information in order to detect fraud, check quality, and to operate, maintain and repair the Services); and (c) not be disclosed, except to the receiving party's employees, agents and contractors having a need-to-know (but only if such agents and contractors are not direct competitors of the other party and agree in writing to use and disclosure restrictions as

restrictive as this Section 5), or to the extent authorized to be revealed by law, governmental authority or legal process (but only if such disclosure is limited to that which is so authorized and prompt notice is provided to the disclosing party to the extent practicable and not prohibited by law, governmental authority or legal process).

C. **Exceptions**. The restrictions in this Section will not apply to any information that: (a) is independently developed by the receiving party; (b) is lawfully received by the receiving party free of any obligation to keep it confidential; or (c) becomes generally available to the public other than by breach of this Agreement.

XXIV.TAXES

In the event that Customer is liable under federal law for excise taxes or under state or local law for sales, use or similar taxes collected by AT&T OKLAHOMA on the Services (including any subcontractor's fees) provided under this Agreement and/or any Addendum, then AT&T OKLAHOMA will bill such taxes separately and Customer agrees to pay them.

XXIV. REPAIRS

AT&T OKLAHOMA will: (a) be available to the customer 24x7x365 for the term of this agreement (b) dispatch service; and (c) perform diagnostic service and network monitoring from the central office. Dispatch for service will be made available consistent with the following schedule. (1) Response Time - 2 hours, remote access and testing, (2) 4 hours, dispatch for critical/major, (3) Next business day dispatch for non critical/minor repairs. If AT&T OKLAHOMA dispatches its service technician to Customer's premises to respond to a trouble report regarding network Services and the service problem is found to be in Customer's equipment, standard time and material charges will apply. Customer agrees to pay such charges.

XXV. GENERAL TERMS AND CONDITIONS

- A. The terms and conditions of this Agreement are equally binding upon the Parties named herein, their heirs, assigns and successors in interest.
- B. Addenda may be added to this Agreement, and each will (1) reference this Agreement, (2) be sequentially numbered and initialed by the

parties, and (3) include the Term of the Addendum, a description of the features, type, quantity and rates for the Services, the location(s) where the Services will be provided, and any special terms and conditions. Customer may also request changes to the Services. Changes may include upgrades, downgrades and/or rearrangements of Services. Change charges may apply, and Customer will be advised of such charges at the time the change is requested. AT&T OKLAHOMA SHALL NOT BE OBLIGATED TO PROVIDE SUCH CHANGED SERVICES UNLESS IT CONSENTS AND CUSTOMER HAS AGREED TO THE CHARGES THEREFOR.

- C. AT&T OKLAHOMA will bill and Customer will pay to AT&T OKLAHOMA, on a monthly basis or as otherwise specified in an Addendum, the charges set forth for the first Term, and the then-current price in subsequent Terms. Charges will commence on the effective date of the Addendum. The prices do not include any independent company or interexchange carrier charges, intra-building network cable, simple inside wire, repair Services for such cable and wire, or wiring associated with Customer equipment.
- D. Payment of charges is due on the date specified on the bill. Customer will reimburse AT&T for all costs associated with collecting delinquent or dishonored payments, including reasonable attorney's fees. AT&T may charge late payment fees if payment is more than thirty (30) days past due (a) for Services contained in a Tariff or Guidebook, at the rate specified therein, or (b) for all other services, at the lower of 1.5% per month (18% per annum) or the maximum rate allowed by law for overdue payments.
- E. In the event of a billing dispute, Customer shall pay the undisputed portion on the payment due date. If a dispute is subsequently resolved in AT&T OKLAHOMA's favor, Customer will be liable for the disputed portion plus the late fee specified above. If the dispute in resolved in Customer's favor, Customer will not be liable for the late fee on the withheld payment.
- F. AT&T OKLAHOMA will rely on information provided by Customer and will not be responsible for any damages or costs that result from errors or omissions in such information. Customer will also obtain at its expense any necessary licenses, easements, permits and consents (including landlord's or mortgagee's consents) in connection with Services.

- G. AT&T OKLAHOMA will have the right to suspend performance or to pursue any other remedies provided under this Agreement where Customer delays or fails to comply with this Agreement. If any of the measures described above are unreasonably expensive, Customer may request that AT&T OKLAHOMA suspend its performance under an Addendum until such time as an alternative remedy or course of performance is secured or agreed upon. If any such suspension lasts longer than thirty (30) days, AT&T OKLAHOMA may terminate that Addendum.
- H. Provision of the Services is subject to the availability and operational limitations of the equipment and associated facilities. If the Services require use of Customer Equipment, such Customer Equipment must be compatible with AT&T OKLAHOMA's equipment and facilities and must conform to industry standards and specifications as outlined in the Addendum. Customer shall ensure the continuing compatibility of Customer Equipment.
- I. Customer is responsible for the installation, operation and maintenance of Customer Equipment. No combination of Customer Equipment shall: require change in or alteration of AT&T OKLAHOMA's equipment or the Services; cause electrical hazards to AT&T OKLAHOMA's personnel or damage to AT&T OKLAHOMA's equipment; cause the malfunction of AT&T OKLAHOMA's billing equipment; or cause degradation of service to other persons. Upon notice from AT&T OKLAHOMA that Customer Equipment is causing such hazard, damage, malfunction or degradation of the service, Customer shall promptly make such changes as shall be necessary to remove or prevent such hazard, damage, malfunction or degradation of the Service. Customer shall be solely responsible for the overall design of its Services and for any redesigning or rearrangement of its Services which may be required because of changes in facilities, operations or procedures of AT&T OKLAHOMA, minimum network protection criteria, or operating or maintenance characteristics of the facilities.
- J. Customer shall provide AT&T OKLAHOMA with reasonable access to Customer's premises to enable AT&T OKLAHOMA to install, inspect, test, rearrange, maintain, repair or remove the Services. If AT&T OKLAHOMA responds to a request from Customer and access is denied or unavailable, standard time and material charges may apply.
- K. It is a condition precedent to AT&T OKLAHOMA's obligations hereunder that: (a) Customer is not in default of Customer's obligations under this Agreement; and (b) the AT&T OKLAHOMA

Network has not been damaged as a result of misuse, abuse, neglect, accident, improper environmental conditions, electrical voltages or currents, repair, alteration or maintenance by any person or party other than an authorized service facility, attachment of mechanical, electrical or electronic material or devices not supplied by AT&T OKLAHOMA, or any use that violates the instructions furnished by AT&T OKLAHOMA or the manufacturer.

- L. Customer shall indemnify, defend and hold harmless AT&T OKLAHOMA, its parents, affiliates and subsidiaries, and their respective officers, directors, employees, agents, successors and assigns from and against any claim, loss or damage involving: (1) Claims for libel, slander, invasion of privacy, or infringement of copyright arising from Customer's own communications; or (2) Claims for patent or intellectual property infringement arising from Customer's acts of combining or using the Services in connection with Customer Equipment.
- M. AT&T OKLAHOMA shall indemnify, defend and hold harmless Customer from and against any claim, or suit brought by a third party alleging the Services infringe such party's U.S. patents, trademarks or copyright ("Intellectual Property"), provided that Customer: (a) followed AT&T OKLAHOMA's reasonable instructions for use of any Intellectual Property associated with the Services; (b) did not modify the Services; (c) notifies AT&T OKLAHOMA promptly and in writing of any such claims; and (d) cooperates with and permits AT&T OKLAHOMA to control the defense, settlement or other handling of such claim or threatened claim. AT&T OKLAHOMA shall not be responsible for any claims resulting from Customer's combination of the Services with other products or Services or Customer Equipment.
- N. The failure of either party to insist upon strict performance of any provision of this Agreement in any one or more instances shall not be construed as a waiver for the future of any such provision, but the same shall be and remain in full force and effect.
- O. Customer will schedule and coordinate the performance of work by suppliers, contractors or other entities working or present at a Customer location in a manner which will not interfere with AT&T OKLAHOMA's performance of its Services within the time period specified in the applicable Addendum.
- P. Neither AT&T OKLAHOMA nor its employees, agents or representatives are employees, servants, partners or joint venturers of or with

Customer. AT&T OKLAHOMA is an independent contractor and will at all times direct, control and supervise all of its employees, agents and representatives and their respective activities.

Q. Customer will not require any waivers or releases of any personal rights from employees or representatives of AT&T OKLAHOMA in connection with their presence on Customer's premises, and no such releases or waivers will be pleaded by Customer or third persons in any action or proceeding.

XXVI. ENTIRE AGREEMENT

This Agreement, including Addenda and applicable tariff, sets forth the entire understanding of the parties and supersedes any and all prior agreements, arrangements, representations or understandings relating to the subject matter hereof. No amendments, modifications, or subsequent agreements concerning the subject matter of this Agreement will be effective unless made in writing. Each reference to a tariff provision in this Agreement shall be deemed to mean any and all similar tariff provisions or other regulations changed or established from time to time in lieu of said tariff provision during the term of this Agreement. In the case of a discrepancy between the tariffs, this Agreement and any Addendum the governing Addendum shall be 1) the tariff, 2) the Addendum, and 3) this Agreement.

Customer agrees to purchase, and AT&T OKLAHOMA agrees to sell, meetpoint billed Network Trunking Service (hereinafter, "Network Service") as that term is defined in Company's tariffs on file with the Public Utility Commission, for a Term of (3 years) 36 months. All terms, conditions, rules and regulations set forth in said tariffs under which the Service is offered hereby are incorporated by reference herein. All charges to Customer for Network Service shall subject to change after the Service has been established and shall reflect exactly the price set forth in the AT&T OKLAHOMA "Enhanced 9-1-1 Universal Emergency Number Service" tariff.
- 2. Customer agrees that the price for the Network Service described above shall be One Thousand One Hundred Ninety Dollars (\$1,190.00) per month for the Term, and one time set up fee Four Thousand Forty Dollars \$4,040.00. Customer further agrees the price for subsequent Terms shall be the price in Company's tariffs for such services on file with the Public Utility Commission in effect on the renewal date of this Agreement, if any. The Parties agree that the network requirements for the Enid, OK will be audited annually to determine if additional trunking capacity is needed, based on that year's usage. If AT&T OKLAHOMA, in its sound business judgment, determines that additional capacity is needed, Customer agrees to purchase such additional capacity at the price in Company's tariffs for such services on file with the Public Utility Commission in effect on the date ordered.
- 3. Customer agrees that minimum participation in the Enhanced 9-1-1 Universal Emergency Number Service shall include all police and fire units which are located within the geographical boundaries of the Customer or which provide police and/or fire service to the Customer.
- 4. The prices herein do not include applicable taxes and fees. AT&T OKLAHOMA retains ownership of all network and database Services, and the equipment providing such Services is leased to the Customer pursuant to the terms of this contract and AT&T OKLAHOMA's tariff provisions.
- 5. AT&T OKLAHOMA shall be provided access by the Customer and all public safety agencies to their premises where the equipment and facilities are located. This access, to be provided at any reasonable time, shall be for the purpose of installation, inspection and repairing the facilities used in furnishing the Services.

- 6. Customer shall be responsible for furnishing AT&T OKLAHOMA with a correct and current definition of the specific geographic areas covered by each primary and secondary PSAP from time to time, as they may change. This definition shall be by street names, street types, directions, street addresses and number ranges (where applicable), or in such other manner as to accurately define the area and be in a format acceptable to AT&T OKLAHOMA.
- 7. The definition of each geographic area and the ongoing maintenance of such information shall be the sole responsibility of the Customer. Customer further agrees to furnish to AT&T OKLAHOMA, in a timely manner, any such updated geographical information. Customer understands that the time required by AT&T OKLAHOMA to update the data base with data provided by the Customer will depend on the nature and extent of such changes. AT&T OKLAHOMA will require a reasonable interval of time in which to input into the database major changes such as realignment of PSAP boundaries, street names changes, new street additions and annexations.
- 8. Customer further understands that in Addendum to properly route calls from subscribers in some rural areas of the county, it will be necessary for Customer to provide unique street addresses (including house numbers) for specific real estate parcels in these areas. Street addresses will be required for streets or thoroughfares which cross multiple jurisdictional boundaries and at present use only rural route and box numbers as an address. These street addresses would not affect current mailing addresses.
- 9. The Service is provided solely for the benefit of Customer. The provision of such service shall not be interpreted, construed or regarded as being for the benefit of, or creating any AT&T OKLAHOMA obligation toward or any right of action on behalf of, and third person or other legal entity.
- 10. AT&T OKLAHOMA does not undertake to answer and forward Enhanced 9-1-1 calls, but furnishes that use of its facilities to enable Customer to respond to such calls with Customer's personnel on Customer's premises.
- 11. The rates charged for the enhanced 9-1-1 Service do not contemplate and AT&T OKLAHOMA does not undertake any responsibility for inspection or constant monitoring to discover errors, defects and malfunctions in the service. Customer shall have the responsibility of discovering all errors, defects and malfunctions. Customer assumes the duty of, and will make such tests as, in the judgment of the Customer, are required to determine whether the system is functioning properly for its use. Customer shall promptly notify AT&T OKLAHOMA in the event the system is not functioning properly.

- 12. AT&T OKLAHOMA shall not be liable for any loss or damages arising out of errors, interruptions, defects, failures, or malfunctions of the Service, including any and all network facilities and data processing systems associated therewith. Damages arising out of such interruption, defects, failures, or malfunctions of the system after AT&T OKLAHOMA has been so notified and has had a reasonable time for repair, shall in no event exceed an amount equivalent to the charges made for the service affected for the period following notice from Customer until service is restored.

- 4. The prices herein do not include applicable taxes and fees. AT&T OKLAHOMA retains ownership of all network and database Services, and the equipment providing such Services is leased to the Customer pursuant to the terms of this contract and AT&T OKLAHOMA's tariff provisions.

REAL ESTATE PURCHASE CONTRACT

THIS **CONTRACT**, made and entered into by and between CECIL AND TERRI DURHEIM, husband and wife, of Garfield County, Oklahoma, (hereinafter referred to as "**Seller**") and the CITY OF ENID, a Municipal Corporation, Garfield County, Oklahoma, (hereinafter referred to as "**Buyer**.")

FOR AND IN CONSIDERATION of the conditions, covenants, and agreements hereinafter set forth, it is mutually agreed by and between the parties as follows:

1. **Property**: Seller agrees to sell and convey to Buyer, and Buyer agrees to purchase the following described real property, situated in Garfield County, Oklahoma:

SURFACE RIGHTS ONLY:

Part of Lot One (1), Block Four (4), Waverly Addition to the City of Enid, Garfield County, Oklahoma, according to the replat of Blocks 1, 2, 3 and 4 of said Addition, as follows: Beginning at the Southeast corner of said Lot One (1); thence North 64.90 feet; thence West 52.55 feet; thence South 64.30 feet; thence East 52.25 feet to the point of beginning,

otherwise known as 1302 W. Randolph, Enid, Oklahoma,

hereinafter referred to as the "Real Property."

- 2. **Purchase Price**: The purchase price for the "Real Property" is \$38,000.00 (Thirty-eight thousand dollars and zero cents). The purchase price shall be paid by Buyer to Seller at the closing of the transaction. The Seller will deliver at closing a good and sufficient Warranty Deed with all the covenants of title conveying the "Real Property" as described in paragraph (1) to the Buyer in fee simple.
- 3. <u>Title</u>. Within ten days of the execution of this contract by both parties, the Seller shall, at Seller's sole expense, deliver to the Buyer an abstract of title, by a bonded abstractor, to the "Real Property". The abstract of title shall be certified to the date of the execution of the Contract showing good and marketable title to the "Real Property" to be vested in the Seller, free and clear of all liens and encumbrances, subject, however, to any easements, rights of way, building and use restrictions, and oil and gas leases of record. It is agreed that no matter shall be construed as an encumbrance or defect in title so long as the same is not so construed under the Real Estate Title Examination Standards of the Oklahoma Bar Association, where applicable. Buyer shall have ten days after receipt of the abstract of title in which to have the abstract examined and in the event of any defects in title or title requirements, Seller shall be provided a copy of the title opinion and shall have a reasonable time within which to meet such title requirements. The sale shall be closed within 5 business days after the title requirements have been met, or as soon thereafter as the Escrow Agent can schedule the closing.

4. Expenses.

- A. BUYER shall pay for the recording of the Warranty Deed.
- B. SELLER shall pay for the costs of bringing the abstract of title up to the date of execution of this Contract.
- C. BUYER shall pay for the examination of the abstract of title (title opinion).
