<u>BACKGROUND</u>: The City of Enid solicited bids for Bid Package No. 1-2A for earthwork, site clearing, soil erosion and sediment control for the Enid Renaissance Project and received three bids. Flintco Constructive Services, LLC (Flintco) reviewed the bids and recommend awarding the contract to Summit Civil Contractors, LLC, with the low bid of \$368,500.00.

Funding for Bid Package No. 1-2A is from the Capital Improvement Fund and is a portion of Flintco's Guaranteed Maximum Price.

<u>BACKGROUND</u>: The City of Enid recently solicited bids for Bid Package No. 1-2B for site utilities for the Enid Renaissance Project and received three bids. Flintco Constructive Solutions, LLC (Flintco) reviewed the bids and recommend awarding the contract to Cherokee Builders, Inc. with the low bid of \$280,780.00.

8.4 A RESOLUTION RECOGNIZING MID-CONTINENT PACKAGING, INC. FOR CONTRIBUTIONS TO OUR COMMUNITY AND DECLARING SUPPORT FOR MID-CONTINENT PACKAGING, INC.'S PLANS FOR EXPANSION AND APPLICATION SUBMITTED TO THE OKLAHOMA POOLED FINANCE PROGRAM.

<u>BACKGROUND</u>: Mid-Continent Packaging, Inc. has been a major employer in the City of Enid for over twenty (20) years and is expanding operations at its current facility.

This resolution acknowledges support by the Mayor and Board of Commissioners in Mid-Continent Packaging, Inc's. expansion efforts and its application for funding to the Oklahoma Pooled Finance Program.

9.1 EXECUTE RIGHT OF ENTRY AND INDEMNITY AGREEMENT (FOR BRIDGE PAINTING) BETWEEN UNION PACIFIC RAILROAD COMPANY AND THE CITY OF ENID.

<u>BACKGROUND</u>: Last year, the City of Enid made a request to Union Pacific Railroad for permission to clean and paint Union Pacific's Willow Street Bridge. This Agreement provides the City a right to enter upon Union Pacific's property in exchange for the City indemnifying Union Pacific if any damages occur.

9.2 EXECUTE ADOPTION AGREEMENT BETWEEN UNION PACIFIC RAILROAD AND THE CITY OF ENID.

BACKGROUND: In November, 2010, the City purchased from Earl and Karen Cunningham, a building that sat on Union Pacific Right-of-Way

behind the outfield of David Allen Memorial Ballpark. The building was removed on March 22, 2011. Mr. and Mrs. Cunningham leased the land under the building from Union Pacific through December 31, 2010, and the City is responsible for the rent from January 1, 2011, through March 22, 2011. The rent amount for that period is four hundred sixteen dollars and forty-seven cents (\$416.47).

9.3 EXECUTE INTERLOCAL AGREEMENT BETWEEN THE STATE OF OKLAHOMA OFFICE OF JUVENILE AFFAIRS (OJA) AND THE CITY OF ENID FOR FUNDING OF THE ENID COMMUNITY INTERVENTION CENTER (CIC).

BACKGROUND: Each year, the City of Enid contracts with OJA to run the Enid CIC, which is the reception and 24-hour juvenile holding facility within the Enid Police Department. This contract will be effective for FY 2011-2012.

<u>BACKGROUND</u>: The City of Enid's abatement programs rely on private mowing contractors to provide the labor necessary to eliminate accumulation of high grass and weeds throughout the community. The City awards annual contracts for such work.

9.5 CONSIDERATION AND DENIAL OF TORT CLAIM OF MEGAN ELLIS.

<u>BACKGROUND</u>: On May 6, 2011, Ms. Megan Ellis submitted a tort claim in the amount of \$110.00 for damage to her 2005 Chrysler Sebring. She claimed the damage occurred on April 8, 2011, as a result of City of Enid crews spraying paint onto her vehicle as they were striping the access road to the West of Van Buren Street near Willow Road. The City Attorney investigated the claim and found that it was Ms. Ellis' own actions which caused the damage. Ms. Ellis drove over freshly painted striping and the tires of her own vehicle transferred the wet paint onto her vehicle. City crews had employed proper safeguards, using a safety trailing vehicle and flashing lights. There was no negligence on the part of the City.

9.6 AWARD CONTRACT FOR CONCRETE BOX STRUCTURAL LINER, PROJECT NO. F-1114A AND AUTHORIZE THE MAYOR TO EXECUTE ALL CONTRACT DOCUMENTS AFTER REVIEW BY THE CITY ATTORNEY.

<u>BACKGROUND</u>: A six-foot wide by seven-foot-tall concrete culvert currently exists on Cherokee Street between the Cherokee Strip Conference Center and Convention Hall. Inspection of the storm drainage structure shows it to be in good condition. However, to ensure the life of the storm drain exceeds the life of the area improvements, a structural liner must be placed inside the box.

Bids were solicited for the structural liner and Kenny Construction Company d/b/a Western Slope Utilities, LLC of Breckenridge, CO, was the lowest, responsible bid in the amount of \$399,975.00. Contract time for the project is 90 days, and the work will be limited to access points outside of the new Event Center construction zone, which will allow for both projects to proceed simultaneously.

Funding for this project is from the Storm Water Fund.

<u>BACKGROUND</u>: The Northeast Wing Renovation Project at the Enid Police Department has been completed and a final inspection was performed in March. Final billing has been received from Henson Construction, the project has passed inspection, and is ready for formal acceptance by the Commission. The base contract amount was \$564,742.00 and after total change orders, the final contract price is \$568,717.00 with the final balance of \$5,000.00 due.

This project was funded from the Police Fund.
