<u>BACKGROUND</u>: This item concerns a property located at 300 Lakeview Drive, on the east side of the street. The City is requesting changing the land use from a Public Institution Designation to a Medium Intensity Residential Designation. Currently the lot houses the former Clay Hall dormitory.

The Enid Metropolitan Area Planning Commission voted unanimously to recommend approval at their June 20, 2011 regular meeting.

3. CONDUCT A HEARING REZONING PROPERTY DESCRIBED AS PART OF THE SOUTHWEST QUARTER SECTION 9, TOWNSHIP 22, NORTH RANGE 6 WIM, ENID, OKLAHOMA FROM "SU" SPECIAL USE DISTRICT TO "R-7" RESIDENTIAL MULTI-FAMILY DISTRICT.

BACKGROUND: This item concerns a property located at 300 Lakeview Drive on the east side of the street. The applicant is requesting rezoning the property from "SU" Special Use District to "R-7" Residential Multi-Family District. The former Clay Hall dormitory is located on the property. The applicant is proposing to renovate the building into one and two bedroom apartments for affordable non-subsidized senior citizens 62 years or older.

The zoning pattern surrounding this request includes "SU" to the north, south and east with "R-2" across the street west. The Enid Metropolitan Area Planning Commission voted unanimously to recommend approval at their June 20, 2011 regular meeting.
