Notice is hereby given that the Mayor and Board of Commissioners of the City of Enid, Oklahoma and the Trustees of the Enid Municipal Authority, a Public Trust, will meet in special session at 12:00 p.m. on the 30th day of November 2011, in the Council Chambers of the City Administration Building, located at 401 W. Owen K. Garriott Road in said city, and the agenda for said meeting is as follows:

- 2. RECESS TO CONVENE AS THE ENID MUNICIPAL AUTHORITY.

CONSIDER A RESOLUTION AUTHORIZING THE ENID MUNICIPAL AUTHORITY (THE "AUTHORITY") TO ISSUE ITS SALES TAX REVENUE NOTE, TAXABLE SERIES 2011 (THE "NOTE") IN THE AGGREGATE PRINCIPAL AMOUNT OF NOT-TO-EXCEED \$12,000,000.00; WAIVING COMPETITIVE BIDDING AND AUTHORIZING THE NOTE TO BE SOLD ON A NEGOTIATED BASIS; APPROVING AND AUTHORIZING EXECUTION OF A SALES TAX AGREEMENT BY AND BETWEEN THE CITY OF ENID, OKLAHOMA (THE "CITY") AND THE AUTHORITY PERTAINING TO A YEAR-TO-YEAR PLEDGE OF CERTAIN SALES TAX REVENUE; APPROVING AND AUTHORIZING EXECUTION OF A NOTE INDENTURE AUTHORIZING THE ISSUANCE AND SECURING THE PAYMENT OF THE NOTE; PROVIDING THAT THE ORGANIZATIONAL DOCUMENT CREATING THE AUTHORITY IS SUBJECT TO THE PROVISIONS OF THE NOTE INDENTURE; AUTHORIZING AND DIRECTING THE EXECUTION OF THE NOTE AND OTHER DOCUMENTS RELATING TO THE TRANSACTION; AND CONTAINING OTHER PROVISIONS RELATING THERETO.

BACKGROUND: The City of Enid recently awarded a contract to build an event center for \$17,444,444.00, and to renovate Convention Hall for \$7,082,000.00, for a total of \$24,526,444.00. The City of Enid currently has cash reserves to pay for this project, but it is prudent to have the flexibility to retain some cash on hand for any emergencies or opportunities that may arise. On November 1, 2011, the City Commission approved and authorized the City Manager and Municipal Finance Services, Inc., to further pursue financing options to be presented at the Special Meeting, November 30, 2011.
