# MAYOR AND BOARD OF COMMISSIONERS SPECIAL MEETING

- 1. CALL TO ORDER/ROLL CALL.
- 2. CONSIDER A RESOLUTION AMENDING THE 2012-2013 WATER CAPITAL IMPROVEMENT FUND BUDGET BY APPROPRIATING ADDITIONAL FUNDS IN THE AMOUNT OF \$2,250,000.00 TO INCREASE THE 2012-2013 APPROPRIATED AMOUNTS FOR THE WATER CAPITAL IMPROVEMENT DEPARTMENT.

<u>BACKGROUND</u>: This is a companion to Items 3, 4, 5, and 7. On January 15, 2013, the City of Enid Commission approved a Resolution to allow an emergency bidding and purchase to replace the 20-inch waterline from 54<sup>th</sup> Street and US 412 to 78<sup>th</sup> Street, 1.3 miles south of US 412. The existing waterline has deteriorated to the point that continual repairs are required, and full pressure cannot be applied to the pipe. This has created a health and safety concern for approximately 50% of the City of Enid's customer demand.

Item 5 will consider awarding a contract for emergency placement of a waterline and approval of Change Order No. 1. The City of Enid received five (5) bids on four (4) sections of the waterline replacement project to place a new 24-inch waterline along a new route following US 412 and 78<sup>th</sup> Street. Nowak Construction Company provided the lowest bid for all four (4) sections in the amount of \$3,035,451.00. Section four (4) places a 2,460-foot, eight (8) inch waterline along Kremlin Drive to allow moving service connects off the larger line. This can be accomplished by City forces and should not be included in the award, reducing the bid amount to \$2,879,211.00.

Change Order No. 1 in the deduct amount of \$1,049,183.50 will adjust the pipe alignment to a shorter route, following the railroad right-of-way, and change the pipe size to 20-inches. This reduces the contract amount to \$1,830,027.50. Due to availability of materials, Change Order No. 1 will reduce the contract time from 110 days to 60 days. It is recommended to award a contract for Sections 1, 2, and 3 and approve Change Order No. 1.

This item will increase the Water Capital Improvement Department Fund by \$2,250,000.00 to fund the emergency waterline. The funds will come from reductions in other fund budgets.
