Those firms were Whitney Smith Co., Forth Worth, Texas, Strategic Government Resources (SGR), Keller, Texas, The PACE Group, Tupelo, Mississippi, and Affion Public, Camp Hill, Pennsylvania. All firms responded. Based on discussion at the May 6, 2014 Study Session, The PACE Group and SGR were selected to make presentations to the Commission regarding their recruitment strategies. Final selection will be made no later than the June 3, 2014 regular Commission meeting.
