# Garfield County Drug and Alcohol Coalition Minutes for October 8, 2014 Five 80 Coffee House, 122 E. Randolph, Enid, OK 73701

Matt Lohmann called the meeting to order at 10:05 am.

Introductions were completed and individuals in attendance were Matt Lohmann, Hope Outreach; Sean Byrne, PreventionWorkz, Dena Patterson, PreventionWorkz; Terri Presa, Vance Air Force Base; Tena Dominquez, Vance Air Force Base; Meri Spurlock, PreventionWorkz; Allison Seigars, Rural Health Care/CHIO; Jay Sharp, Rural Health Care/CHIO; Melissa Baldwin, NCBH and Erin Turner, ODMHSAS.

Tena Dominquez made the motion to approve the minutes as written and Jay Sharp second the motion. The coalition approved the minutes as written.

Matt Lohman reported that Kristen Claypole had an emergency court appearance this morning and would present next month's meeting.

#### Dena Patterson shared the Prescription Drug Abuse in Garfield County

The Naloxone training has been coordinated and scheduled for October 9, 2014. It is exciting because the Enid Police Department, Garfield County Sheriff's Department and the Enid Fire Department will all be attending. Gail Box and the Austin Box "12" Foundation will be providing the kits as well as lunch for the first responders training. The next step is to provide Naloxone kits to families of individuals on opioid medications.

Dena Patterson reported the special event had been postponed due to unforeseen circumstances.

There are new DEA guidelines concerning safe disposal of prescription medications. It is exciting because pharmacies will not be able to take back controlled substances. It will be interesting to see which pharmacies are willing and how this affects the long-term care and residential care facilities.

#### Meri Spurlock shared the Underage Drinking in Garfield County

The next Responsible Beverage Service and Sales Training will be held next Monday, October 13 at Blaze's BBQ, 2-5:00.

The 2M2L Training scheduled for Wednesday, October 28, 2014. It will be an all-day training for law enforcement. There will be a mock party so the law enforcement officers will have the opportunity to practice party dispersals.

<u>The PreventionWorkz staff led the coalition in a discussion concerning the sustainability</u> of the current strategies. Sean Byrne shared about the sustainability plan as well as the plan of action of an online survey so that representation of all members can be evaluated and surveyed.

## <u>Underage Drinking in Garfield County – November 12, 2014</u>

- The big news is the 2M2L Law Enforcement Training and Mock Party Dispersal went well. It was hosted by ABLE, Garfield County Sheriff's Office and PreventionWorkz. Senior ABLE Agent Gina Pratt taught the class. There were 32 officers in attendance from Garfield County Sheriff's Office, Enid Police Department, Grant County Sheriff's Office, Noble County Sheriff's Office, Canton Police Department, Fairview Police Department, Oklahoma Department of Wildlife, Kingfisher County Sheriff's Office, Washita County Sheriff's Office, OSU Police Department and Enid Campus Police. Also attending was a representative from the Garfield County District Attorney's Office and two field representatives from ODMHSAS. There were 23 people from three different age groups attending the mock drinking party juveniles, 18-20 year olds and 21 years old and up.
- The 'Thank You Card' program rewards clerks/servers who correctly check IDs. There is a 15 minute training. If you are interested in participating in this program, please contact Meri Spurlock.

## Prescription Drug Abuse and Safe Disposal Garfield County - November 12, 2014

- The Austin Box "12" Foundation presented 26 kits to the First Responders including the Enid Police Department, Enid Fire Department and Garfield County Sheriff's Department. These kits will be utilized throughout Garfield County. Mike Honisberg is visiting with all rural fire departments about utilizing additional kits as well.
- There will be a community meeting held at the Five 80 on Thursday, November 20th from 5:15 pm to
  7:15 pm to discuss future endeavors surrounding Prescription Drug Abuse Awareness in Garfield County.
- As of November 1, 2014, the law no longer requires a prescription for Naloxone.
- The Prescription Monitoring Program will need to be addressed this next legislation.
