SUBJECT:

DISCUSS HB 1875 OTC RETENTION SERVICE FEES.

BACKGROUND:

Special City of Enid Projects Presentation:

June 9, 2015.

- The Oklahoma State Legislature passed HB 1875 on May 16, 2014 in the 2014 session.
- The House vote was 91-3 and the Senate vote was 40-0.
- The Oklahoma Tax Commission has retained 1% of the Oklahoma municipality's net sales tax to fund statewide collection, distribution, and auditing expenses.
- Two years of discussion with the Oklahoma Tax Commission and the Oklahoma Municipal League determined that the OTC could operate effectively by retaining $\frac{1}{2}\%$ of 1% of the municipality's net sales tax. Current financial technology was the primary reason behind the decrease.
- Joan Riley was the chair of the OML Legislative Lobby Committee during this process.
- The new retention rate of $\frac{1}{2}\%$ of 1% will begin on July 1, 2015.

\$324,281.00 City of Enid annual sales tax retention and use tax retention service fee to OTC for FYE 2012-2013.

\$310,098.00 City of Enid annual sales tax retention and use tax retention service fee to OTC for FYE 2013-2014.

\$ 12,920.00 Approximate lower cost to COE of the monthly retention fee to the OTC.

\$7,365.00 General Fund Operating Revenue: 2% of 3.5% of COE Sales Tax Revenue

\$5,555.00 1.5% of 3.5% of COE Sales Tax Revenue: 1% to Enid Municipal Authority for Water Debt, .25% for Fire & Police Public Safety Tax, .25% for School Bond Tax.

RECOMMENDATION

The sales tax revenue increase (2% of the 3.5% or .57%) due to lowering the retention fee to $\frac{1}{2}\%$ from 1% will be a windfall increase to the COE beginning on July 1, 2015.

These funds (approximately \$7,365.00 per month) could be placed in a separate EMA account to allow the COE to save the money to fund Special Projects in the future as recommended by the COE Staff and approved by the City Commission. These funds could be used for smaller Capital Improvements as they become available. The City Commission would then vote on additional Special Projects as each project is completed.

These funds would not be used for General Fund purposes.
