Garfield County Drug and Alcohol Coalition Meeting Minutes 2/10/2016

Matt Lohman called the meeting to order at 10:05 am. Introductions where completed. Those in attendance include Gail Box, Sean Byrne, Tena Dominquez, Merle Isaak, Matt Lohman, Terri Presa, Meri Spurlock, Theresa Sharp, Tiffany Beasley, Jen Mitchell and Dena Patterson.

Margaret Watkins made a motion to approve the minutes as written. Tena Dominquez second the motion. Minutes passed unanimously.

Gail Box reported about the Naloxone Kits: Clinton Foundation will send naloxone kits free to all public schools, but something in the Oklahoma Education Statutes is holding it up. School nurses want them. This should fall under the Good Samaritan law and will get us more information about contacting legislators.

Dena Patterson presented a PowerPoint surrounding Non-medical prescription drug use in Garfield County. She gave everyone a copy of the current Matrix; the coalition discussed and reviewed all data. Key points included: Social media ads, youth going out of country to get meds, over prescribing practices as reported by physicians, enforcement for doctors who over prescribed. Allison Seigars made the motion to address social/community norms in Garfield County. Teresa Sharp second the motion and it passed unanimously. Dena Patterson reported the Rx Workgroup would be meeting on February 18, 2016

Meri Spurlock gave her report surrounding underage drinking. She reported the owner of the Blue Note Lounge hired attorney for his second sell and he received a plea agreement. Meri Spurlock will give the underage drinking data presentation at the March meeting.
