Motion was made by Commissioner Janzen and seconded by Commissioner Ezzell to adopt an ordinance amending Section 6-5-8 in Chapter 1, Title 6 of the Enid Municipal Code, 2014, entitled "Attention To Driving Required," to include Oklahoma state law that prohibits texting and driving.

Following brief discussion, the vote was as follows:

**ORDINANCE NO. 2015-34**

**AN ORDINANCE AMENDING THE ENID MUNICIPAL CODE, 2014, TITLE 6, ENTITLED "MOTOR VEHICLES AND TRAFFIC," CHAPTER 1, ENTITLED "GENERAL TRAFFIC PROVISIONS," SECTION 6-5-8, ENTITLED "ATTENTION TO DRIVING REQUIRED," TO INCLUDE OKLAHOMA STATE LAW THAT PROHIBITS TEXTING AND DRIVING.
