# Garfield County Drug and Alcohol Coalition Meeting Minutes 3/9/2016

Jane Martin called the meeting to order at 10:03am. Introductions were completed. Those is attendance include Judy Helberg, Matt Lohman, Jane Martin, Dena Patterson, Tim Prince, Jay Sharp, Meri Spurlock, Jen Mitchell, and Theresa Sharp.

Matt Lohman made a motion to approve the minutes as written. Theresa Sharp second the motion. Minutes passed unanimously.

Meri Spurlock presented a PowerPoint surrounding underage drinking in Garfield County. She gave everyone a copy of the current Matrix; the coalition reviewed and discussed the data. Key points included: statistics for underage drinking in both Garfield County and the State of Oklahoma, specifically where teens are obtaining alcohol, focus group information, and influence of alcohol on other social issues such as suicide and teen pregnancy. Judy Helberg made a motion to address Social and Retail Availability in Garfield County. Jay Sharp second the motion and it passed unanimously.

Dena Patterson distributed the Logic Model for Non-medical prescription drug use as a part of the strategic plan to address social/community norms in Garfield County.

Judy Helberg provided some education on juvenile testing in drug court.

Sean Byrne provided information regarding advocating for private practice at the legislature level. There was a discussion of the state budget shortfall and its impact on Garfield County. Increasing protective factors for youth, such as a mentoring program or sports teams, was included in that discussion.

The meeting unofficial adjourned at 11:10am.
