Minutes

4/13/2016

Jane Martin called the meeting to order at 10:05 am. Introductions were completed and those in attendance were Sandy Howard, Merle Isaak, Matt Lohman, Jane Martin, Taylor Randolph, Meri Spurlock and Dena Patterson.

Sandy Howard made a motion to approve the minutes as written and Matt Lohman second the motion. Motion passed unanimously.

Meri Spurlock discussed the modernization alcohol laws; announced the next RBSS training will be April **20**, 2016 from 1 – 4pm at the Enid Public library. Meri Spurlock presented the logic model for underage drinking in Garfield County. Dena Patterson handed out the Oklahoma Prevention Policy Alliance modernization and letter to the editor discussing the importance of contacting their senators/representatives. Dena also shared about the Oklahoma Prevention Policy Alliance meetings and invited any of the coalition members to attend.

Dena Patterson shared about the Picnic for Progress encouraging coalition members to share the information with their agencies and others who may be interested. The event is Saturday, May 14, 2016 from 10:00 to 2:00 pm. Volunteers, Booths & Sponsors are needed and encouraged.

Taylor Randolph discussed the upcoming state cuts and the ramifications on the clients served. The bill is SB383. If passed it would include a 10% cut to individuals under supervision as well as placing CAPS on client services, which is going to hurt the client's quality of life.

The coalition discussed possible new meeting places due to the conflict that have been encountered with a group who is previously in this room. Dena Patterson will discuss this with the Five 80 staff to see if what can be done and research new public meeting locations.

Taylor Randolph made a motion to adjourn the meeting and Merle Isaak second the motion. Meeting adjourned at 11:00 am.
