Council Chambers of the Administration Building of the City of Enid, located at 401 West Owen K. Garriott Road in said city, pursuant to notice given by December 15, 2015 to the Clerk of the City of

Enid, and pursuant to notice thereof displayed at the entrance to the Administration Building of said city, in prominent view and which notice was posted prior to 5:00 P.M. on the 18th day of April 2016.

Mayor Shewey called the meeting to order with the following members present and absent:

PRESENT: Commissioners Janzen, Brownlee, Ezzell, Timm, Wilson, Vanhooser and Mayor Shewey.

ABSENT: None.

Staff present were City Manager Jerald Gilbert, Assistant City Manager Joan Riley, City

Attorney Andrea Chism, City Clerk Linda Parks, Director of Engineering Services Christopher Gdanski,

Chief Financial Officer Erin Crawford, Public Services Director Billy McBride, Public Utilities

Director Louis Mintz, Planning Administrator Chris Bauer, Director of Marketing and Public Relations

Steve Kime, Human Resources Director Sonya Key, and Ex-Officio Member Col. Fred Cunningham.

Pastor Terry O'Toole from Chisholm Trail Cowboy Church gave the Invocation, and Captain Bryan

Skaggs led the Flag Salute.

Motion was made by Commissioner Vanhooser and seconded by Commissioner Janzen to approve the

minutes of the regular Commission meeting of April 5, 2016, and the vote was as follows:

AYE: Commissioners Janzen, Brownlee, Ezzell, Timm, Wilson, Vanhooser and Mayor Shewey.

NAY: None.

Officer David Handley presented a six-month old male mixed Lab/Bulldog puppy, available for

adoption at the Enid Animal Shelter.

A proclamation was read and presented proclaiming April 2016 as "Fair Housing Month."

A proclamation was read and presented proclaiming April 19, 2016 as "Arbor Day 2016."

Brandon Fuentes was presented a Certificate of Achievement for his award-winning entry in the Annual Oklahoma Arbor Week Poster Contest.

Mayor Shewey announced that Items 8.5, Approve And Execute A Management Agreement Between The City Of Enid And The Denny Price Family YMCA Of Enid, Oklahoma, For The Management Of The Champlin Pool, and 9.1, Accept Oklahoma Water Resource Board (OWRB) Groundwater Permit For Municipal Use For The Benefit Of The City Of Enid, were being removed from the agenda from consideration.

Mayor Shewey introduced Item 8.1, Accept The Preliminary Design Based Engineering Cost Estimate For The Kaw Lake Program And Take Any Action Necessary.

Opening comments were made by Director of Engineering Service Chris Gdanski who stated that the purpose of this item was to discuss and refine the program cost estimate and schedule for the Kaw Lake Pipeline Project.

Mr. Michael Graves, from the firm of Garver, LLC, provided a Phase I update of the project, and discussed the program's cost estimates for each of the major components of the project, which were noted as follows:

1)	Microtunnel Intake Structure and Pump Station	\$20.2 million
2)	Intermediate Booster Pump Station	\$11.8 million
3)	Raw Water Pipeline	\$121.6 million
4)	Terminal Storage Reservoirs	\$41.7 million
5)	Water Treatment Plant	\$66.2 million
6)	High Service Pump Station	\$13.1 million
7)	East Pressure Plane Integration & Clearwell	\$16.5 million

for a total infrastructure cost of \$291.1 million. He went on to say that there would be additional program execution and design costs for program management, planning, design, land acquisition, construction phase services, and post construction activities. Those costs were yet to be determined, but had been estimated at \$73 million. Additionally, he was recommending that the City plan for approximately thirty percent (30%), or \$87.4 million, in contingencies, bringing the total program cost estimate to \$451.5 million.

Commissioner Ezzell stated that when the process to determine the best long term water strategy for the city of Enid began, the rough cost of a 36-inch pipeline to Kaw was \$148 million. Rough surface water costs for three (3) lake options had also been studied, which ranged in costs from between \$218 million and \$335 million. He asked how confident Garver and staff were that those surface solutions had not become cheaper. The Commission's conservative pipeline choice had tripled. Was this still the best option on the table, and would thirty percent (30%) contingency be sufficient?

Mr. Gdanski stated that he was confident that the Kaw pipeline was the best option on the table.

Mr. Graves stated that he was confident that thirty percent (30%) contingency was the right planning number at this stage of the program. He was not comfortable with anything less.

Mr. Graves stated that realizing the estimate of \$451.5 million was a large number, and much different than had previously been discussed with previous master planning efforts, his firm had looked at phasing opportunities to help reduce program costs. He stated that certain components

within the program could be delayed or deferred, which would not impact the City's ability to deliver water. It wouldn't necessarily be the same volume of water, but it wouldn't box the City in of delivering future water supply when those phased items were added back to the program.

Potential items that could be phased, and the risks associated with phasing those items, were noted. Mr. Graves stated if the phased concepts were implemented across the program, the City could potentially realize or defer approximately \$62 million in capital costs. However, at that point, the program would only be rated for 14 MGD as opposed to 21 MGD, as previously projected.

In closing, Mr. Graves stated that commissioners had options moving forward. At this point, the City was only at the ten percent (10%) part of the program. He asked that commissioners consider two (2) options: 1) Move forward with the optimal solution. Move forward with the optimal solution and plan on funding the contingency amount of \$87.4 million for a full program cost of \$451 million, and watch what happened to the contingency as they moved through the design phases; and 2) Start identifying phased opportunities. Given more time, some phasing components could be evaluated. Track those phased items along with the changes in contingency, and take the program all the way to bid. At that point, they would have defined what the City could afford. When the program was bid, if they were in the money, all of those phased items would be included in the program, and actually be constructed. If they weren't in the money, they would prioritize the phased items, deduct those items, put them on a shelf for future projects, and implement as many of the phased components that they could afford.

Mr. Graves stated that the Phase 2 scope of work and schedule would be unchanged by any decision commissioners made regarding the way they wanted to fund the program, or by how much they wanted to fund. If they continued to design the optimum program to the thirty percent (30%) level to update the cost estimate, which was still a 12-month process. However, to maintain the program schedule, Phase 2 needed to be initiated by July 1, 2016, so that the program could be kept on schedule for a water delivery date. He went on to say that the final design phasing would have minimal impact on the schedule if they decided to phase some components from the construction schedule. Additionally, there would also be minimal impact on the schedule if they decided to implement some of the phasing opportunities.

Motion was made by Commissioner Vanhooser to accept the preliminary design based engineering cost estimate for the Kaw Lake Program as presented.

Motion was seconded by Commissioner Timm, and the vote was as follows:

AYE: Commissioners Janzen, Brownlee, Ezzell, Timm, Wilson, Vanhooser and Mayor Shewey.

NAY: None.

Motion was made by Commissioner Vanhooser and seconded by Commissioner Wilson to approve a resolution adopting the Fiscal Year 2016 Annual Action Plan for the Community Development Block Grant (CDBG) Program and Budget for the July 2016 - June 2017 program year, and authorizing the Mayor to submit the Plan to the Department of Housing and Urban Development.

Ms. Lanita Norwood, 468 East Ohio Avenue, addressed the Commission. She expressed concerns that since the process for allocating the use of CDBG funds had changed, citizens and organizations

had lost their voice in the community and their opportunity to apply for grant monies. She asked commissioners to reconsider the process, and give citizens back their voice and opportunity to apply for funding.

Mr. Clifford Porter, 361 East Cherry Avenue, expressed concerns that decisions regarding the allocation of funds did not take into consideration the needs of the Booker T. Washington Community Center and the citizens it served. He also expressed concerns that the transfer of management of Champlin Pool to the YMCA would negatively impact the summer program for the Booker T. Washington Community Center.

City Manager Jerald Gilbert stated that no agreement had been made with the YMCA regarding the management of Champlin Pool.

There being no further comments, the vote was taken as follows:

WHEREAS, the City of Enid has conducted public hearings and has received public input concerning the development of an Annual Action Plan and otherwise informed residents of the proposed plan of activities and budget levels included in the "Action Plan" for Fiscal Year 2016; and

WHEREAS, the Annual Action Plan contains the form SF-424 for the current funding year and the required certifications of eligibility for federal assistance.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Commissioners of the City of Enid, Oklahoma, as follows

The Board of Commissioners has reviewed the FY 2016 Annual Action Plan which includes the plan for expenditure of Community Development Block Grant and HOME Programs projected use of funds and activities scheduled for July 2016- June 2017 and find it to be consistent with the overall objectives of the Housing and Community Development Act and local neighborhood redevelopment strategies.

The Board of Commissioners, after evaluation of all the pertinent information presented, authorize the Mayor to submit on behalf of the City of Enid, the FY 2016 Annual Action Plan for Community Planning and Development Programs for the July 2016 - June 2017 Program Year.

Discussion was held regarding a resolution declaring the intent to consider approval of a project and creation of a tax increment district for the improvement of 66th Street under the Local Development Act; directing preparation of a project plan; appointing a review committee; directing the review committee to make findings as to eligibility and financial impact, if any, on taxing jurisdictions within the district; directing the review committee to make a recommendation with respect to the proposed project plan; directing the Planning Commission to make a recommendation with respect to the proposed project plan; directing the review committee and the Planning Commission to make a recommendation with respect to termination of certain existing tax increment districts; and containing other provisions relating thereto.

Motion was made by Commissioner Vanhooser that the same be approved, with the modification to add the language "Oakwood Mall TIF" immediately following "Orion Ethanol TIF, Inc." on Line 4, Section 5 of the resolution.

City Manager Jerald Gilbert stated that commissioners had discussed leaving the Oakwood Mall TIF until May 31, 2016, but the timing of that might work with Commissioner Vanhooser's motion.

Commissioner Vanhooser stated that commissioners would have to deal with the Oakwood Mall TIF in a formal way at some point. The arbitrary deadline of May 31st would not be official until a recommendation was made to disband it. This would be the perfect mechanism to simply add language to the resolution so that the committee which was created to discuss the various issues would also have a say of getting rid of the Oakwood Mall TIF, which needed to be done.

Mr. Gilbert stated that he agreed. However, he went on to say that if added, it would involve a different makeup of the committee. It would involve the Superintendent of Enid Public Schools, because that entity would be in that district.

Mr. Nate Ellis, from The Public Finance Law Group, PLLC, stated that if the Commission desired to make that modification, it could be done. He suggested an additional paragraph in the resolution to describe and define what the Oakwood Mall TIF was, as well as additional wording to provide that a representative of the Enid Public Schools shall be a committee member. He went on to say that it appeared there was potentially more involved with the Oakwood Mall TIF. That there really was a subject of discussion. However, the resolution could be opened to allow for consideration of that TIF. He also suggested that it might be cleaner to have a separate resolution at the next Commission meeting to consider opening the Oakwood Mall TIF back up, with a broader vent of "do we need to modify it, do we need to kill it," or whatever the case might be.

Commissioner Janzen stated that if commissioners were making major modifications to the resolution, the item should be tabled.

Commissioner Ezzell stated that he knew the deadline that commissioners had discussed was completely arbitrary, and the likelihood of it mattering one way or another was debatable. However, in good faith, and as a partner in economic development projects, he didn't feel that it would hurt to sit on any movement regarding the Oakwood Mall TIF until that deadline was past. He wasn't sure that anything was likely to change, but it seemed like a good faith sign to say that it wasn't being taken off the table yet. He also didn't want the Commission to be accused of placing any kind of damper on the development, or anyone to put the blame on them if it didn't come through.

Following further discussion, Commissioner Vanhooser withdrew his original motion and moved to approve the resolution as presented.

Motion was seconded by Commissioner Ezzell, and the vote was as follows:

A RESOLUTION DECLARING THE INTENT TO CONSIDER APPROVAL OF A PROJECT AND CREATION OF A TAX INCREMENT DISTRICT UNDER THE LOCAL DEVELOPMENT ACT; DIRECTING PREPARATION OF A PROJECT PLAN; APPOINTING A REVIEW COMMITTEE; DIRECTING THE REVIEW COMMITTEE TO MAKE FINDINGS AS TO ELIGIBILITY AND FINANCIAL IMPACT, IF ANY, ON TAXING JURISDICTIONS WITHIN THE DISTRICT; DIRECTING THE REVIEW COMMITTEE TO MAKE A RECOMMENDATION WITH RESPECT TO THE PROPOSED PROJECT PLAN; DIRECTING THE PLANNING COMMISSION TO MAKE A RECOMMENDATION WITH RESPECT TO THE PROPOSED PROJECT PLAN; DIRECTING THE REVIEW COMMITTEE AND THE PLANNING COMISSION TO MAKE A RECOMMENDATION WITH RESPECT TO TERMINATION OF CERTAIN EXISTING TAX INCREMENT DISTRICTS; AND CONTAINING OTHER PROVISIONS RELATING THERETO.

WHEREAS, The City of Enid (the "City") is working to promote economic development in the area, in order to provide increased opportunity for residents of the area and to improve the overall standard of living; and

WHEREAS, the City aspires to attract business interests with the potential to invest in transload facilities within the City, subject to certain conditions including economic development incentives and financing; and

WHEREAS, the Local Development Act, Title 62, Oklahoma Statutes Section 850 et seq. (the "Local Development Act"), was passed by the Oklahoma Legislature to implement Section 6C of Article X of the Oklahoma Constitution, which empowers the governing bodies of cities, towns, and counties to apportion tax increments to help finance the public costs of economic development; and

WHEREAS, the proposed project depends upon the utilization of tax increment financing to help finance the project costs; and

WHEREAS, it is desirable to direct the City staff to prepare a proposed project plan for consideration; and

WHEREAS, the Board of Commissioners, as the governing body of the City, is empowered to approve the creation of a tax increment district to further the public purpose of economic development within the City; and

WHEREAS, the Local Development Act provides for the appointment of a Review Committee to review and make recommendations concerning the proposed district, plan, or project, to consider and make findings and recommendations with respect to the conditions establishing the eligibility of the proposed district, and to consider and determine whether the proposed plan and project will have a financial impact on any taxing jurisdiction within the proposed district and to report its findings and make its recommendations to the governing body; and

WHEREAS, the Local Development Act provides that the membership of the Review Committee shall consist of the following: a representative of the governing body who shall serve as chairperson; a representative of the planning commission having jurisdiction over the proposed district; a representative designated by each taxing jurisdiction within the proposed district whose ad valorem taxes might be impacted by the plan; and three members representing the public at-large and selected by the other committee members from a list of seven names submitted by the chairperson of the review committee; and

WHEREAS, it is appropriate and desirable to appoint a Review Committee to consider and make recommendations on a proposed project plan; and

WHEREAS, the City heretofore created Increment District No. 2, City of Enid (the "Oklahoma Ethanol TIF") pursuant to Ordinance No. 2006-7 dated March 21, 2006, in connection with the adoption of the Oklahoma Ethanol Economic Development Project Plan dated March 21, 2006; and

WHEREAS, the City heretofore created Increment District No. 3, City of Enid (the "Orion Ethanol TIF") pursuant to Ordinance No. 2006-16 dated September 19, 2006, in connection with the adoption of the Orion Ethanol Economic Development Project Plan dated September 19, 2006; and

WHEREAS, the City heretofore created Increment District No. 6, City of Enid (the "Northstar Canola TIF") pursuant to Ordinance No. 2013-3 dated January 15, 2013, in connection with the adoption of the Northstar Economic Development Project Plan dated December 21, 2012; and

WHEREAS, due to unforeseen economic factors beyond the control of the City, the economic development proposed in connection with the Oklahoma Ethanol TIF, the Orion Ethanol TIF, and the

Northstar Canola TIF has not occurred and will not occur in a manner consistent with the respective Project Plans heretofore adopted by the City; and

WHEREAS, the City desires to direct the Review Committee and the Planning Commission to consider the termination of the Oklahoma Ethanol TIF, the Orion Ethanol TIF, and the Northstar Canola TIF concurrently with the consideration of the proposed transload facility tax increment district.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND BOARD OF COMMISSIONERS OF THE CITY OF ENID, OKLAHOMA:

SECTION 1. INTENT. The Mayor and Board of Commissioners intends to consider approval of a project and creation of a tax increment district to facilitate the financing of eligible project costs of a project and hereby directs preparation of a project plan by City staff, to be submitted for consideration in accordance with the Local Development Act.

SECTION 2. ESTABLISHMENT OF REVIEW COMMITTEE. A Review Committee is hereby appointed whose membership shall consist of the following: one representative of the Mayor and Board of Commissioners, who shall be chairperson; one representative of the Metropolitan Area Planning Commission; one representative designated by Garfield County; one representative designated by Garfield County Health Department; one representative designated by Pioneer Pleasant-Vale Independent School District No. 56; one representative designated by Autry Technology Center Vo-Tech District No. 15; and three representatives of the public at large, who shall be selected from a list of seven names submitted by the representative of the Mayor and Board of Commissioners, as chairperson of the Review Committee, by the other Review Committee members.

SECTION 3. REVIEW COMMITTEE FINDING AND RECOMMENDATION. The Review Committee shall consider and determine whether the proposed plan and project will have a financial impact on any taxing jurisdiction within the proposed district and shall report its findings to the Mayor and Board of Commissioners. Furthermore, the Review Committee shall consider and make its findings and recommendations to the Mayor and Board of Commissioners with respect to the conditions establishing the eligibility of the proposed district and the appropriateness of approval of the proposed plan and project.

SECTION 4. PLANNING COMMISSION RECOMMENDATION. The Enid Planning and Zoning Commission shall review the proposed project plan and shall make a recommendation on the plan to the Mayor and Board of Commissioners.

SECTION 5. TERMINATION OF CERTAIN EXISTING TIFS. The Review Committee and the Enid Planning and Zoning Commission shall each make a recommendation with respect to the proposed termination of the Oklahoma Ethanol TIF, the Orion Ethanol TIF, and the Northstar Canola TIF to the Mayor and Board of Commissioners; provided however, in connection with the recommendation respecting Oklahoma Ethanol TIF, a representative of Chisholm Independent School District No. 42 shall be substituted for the representative of Pioneer Pleasant-Vale Independent School District No. 56 for purposes of the Review Committee.

A presentation depicting the project was made by City Engineer Robert Hitt. He noted that four (4) bids were received, with the low bid, submitted by Vital Signs of Oklahoma (Vital Signs), Edmond, Oklahoma, being non-responsive, as it did not include a bid bond as required by the specifications. He stated that staff had contacted the owner of Vital Signs to obtain the bond, but he had declined to provide the bond as required.

Mr. Gdanski further explained that the owner had also expressed concerns that a performance bond and a three-year maintenance bond would be required if awarded the contract for the project. Because the cost of obtaining those bonds had not been included in his proposal, he had requested that his bid be withdrawn from consideration.

Commissioner Timm expressed concerns that the budgeted amount was too excessive to spend on signs.
